# Antecedentes - Herramienta para reportar en línea

- Se ha reconocido en muchas decisiones de la COP, la necesidad de monitorear la implementación
- En la decisión VIII/14, la COP decidió establecer un mecanismo, como herramienta de planeación, para la entrega de informes;
- En línea con el artículo 18, esta herramienta facilitará la cooperación técnica entre las Partes, facilitando: el intercambio de información del diseño y aplicación de los indicadores, así como el intercambio de herramientas de políticas;
- La herramienta para la entrega de informes en línea es un complemento y no un reemplazo;
- Es parte del CHM.

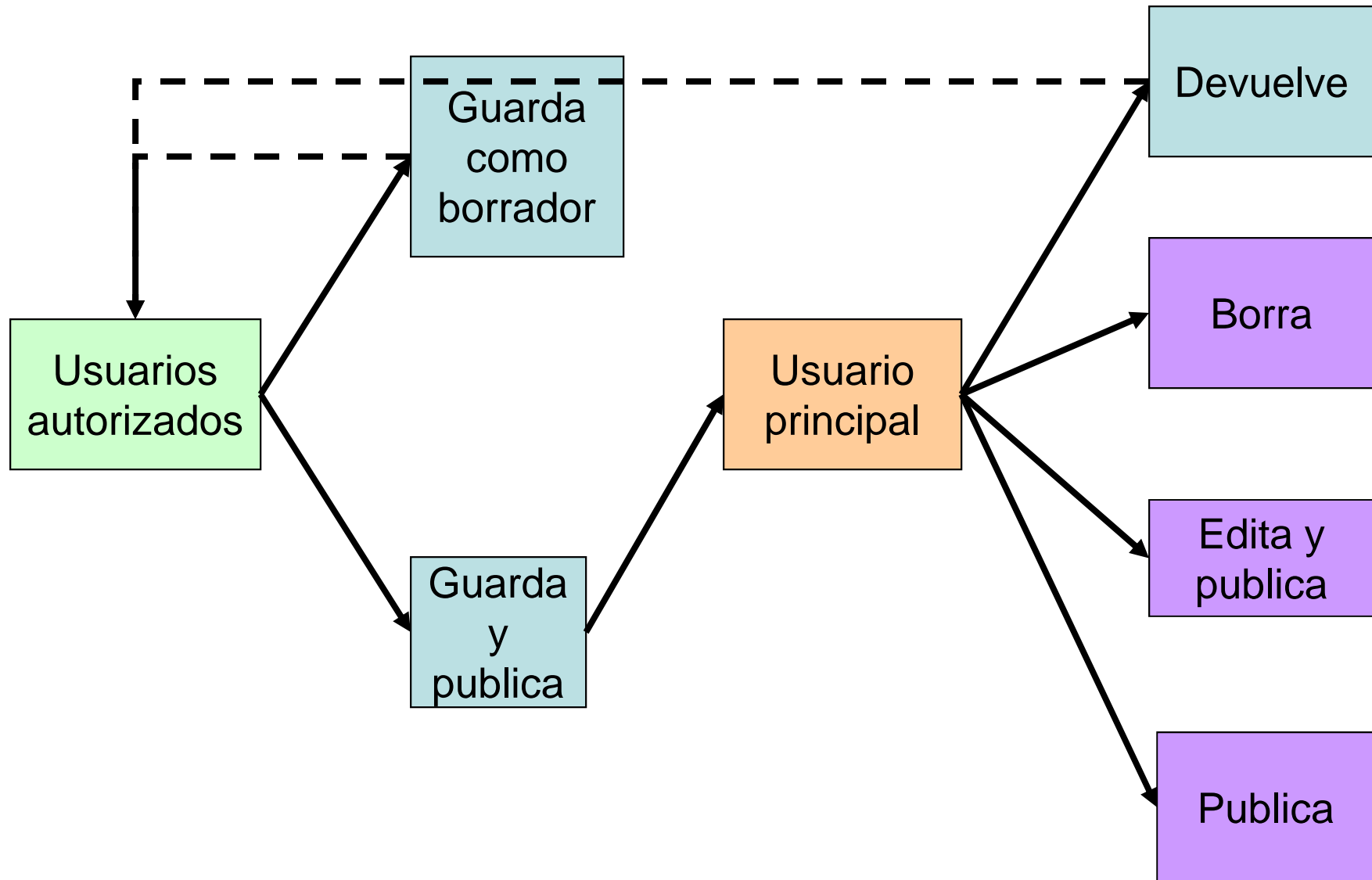


