5. General information on access to Dehradun, India

The closest International Airport from Dehradun is Indira Gandhi International Airport (IGI), New Delhi. Dehradun is located approximately 250 km from New Delhi. The domestic airport at Dehradun is located about 30 km from the Dehradun city centre. Taxi from the airport costs approximately INR 1,000 (approx. US \$21).

5.1 By Train

The Indian Railways offers comfortable train services to and from Dehradun. The Dehradun Shatabdi Express, with daily service to and from New Delhi Railway Station is the most convenient way to go to Dehradun. In addition, there are a number of other trains, which go to Dehradun, thereby offering a wide range of choices. **Advance reservation is required which can be done via internet <http://www.irctc.co.in/>.** For more information on the train schedules, visit <http://www.indianrail.gov.in> and refer to **Annex B** below. Participants wishing to travel by Shatabdi Express from New Delhi to Dehradun may take a pre-paid taxi (Meru Taxi Service) from IGI Airport to New Delhi Railway Station, which would cost approx. INR 800 (US \$ 16). Participants arriving by train may take a taxi from Dehradun Railway Station to their hotel, at an approx. fare of INR 300 (US \$6).

5.2 By Air

Dehradun is connected by air. Kingfisher Red Airlines and Jet Airways Konnect operates two flights each from Delhi to Dehradun and back as per the following schedule:

6. Visa information



Participants from all countries require an entry visa for India and are strongly advised to contact the nearest Indian diplomatic or consular mission **as soon as possible** in order to secure the required entry visa in a timely manner, prior to departure. Visa requests must be made on line. It should be noted that airline companies will not allow boarding in the absence of a valid visa.

To facilitate the issuance of visas, the Secretariat will issue upon request invitation letters to be attached to the visa applications.

7. Health requirements

The International travel, health and vaccination requirements for travel to India can be obtained from the World Health Organization (WHO) web site: <http://apps.who.int/tools/geoserver/www/ith/index.html>.

Travellers to India require a yellow fever vaccination certificate for travellers over 9 months of age, who within the preceding six days, have been in or have passed through any country with risk of yellow fever transmission.

Malaria risk exists throughout the year in the whole country at altitudes below 2000 metres.

For more information, please consult a medical professional with regard to the vaccination requirements for your travel.
