#### 5. General information on access to Brasilia, Brazil



Brasilia is serviced by the Brasilia International Airport – Presidente Juscelino Kubitschek (about 12 km from the city centre). Taxis are available at the airport. Please note that in Brasilia, taxi fares can only be paid in cash, credit cards are not accepted. The rate for the trip to the city centre is approximately R \$50 (Approx. US \$20) and the journey takes approximately 15 minutes.

#### 6. Visa information



Participants from countries listed below <u>do not</u> require an entry visa for Brazil. Participants from all other countries are strongly advised to contact the nearest Brazilian diplomatic or consular mission **as soon as possible** in order to secure the required entry visa in a timely manner, prior to departure. The visa application process can be lengthy, so please allow sufficient time. Some airline companies will not allow boarding without a valid visa.

#### 7. Health Requirements

Travellers to Brazil require a yellow fever vaccination certification if you have been or have passed through any country with risk of yellow fever transmission, or going to Distrito Federal (including the capital city of Brasília).

Malaria is present in most forested areas below 900 m within the nine states and also occurs on the periphery of some large cities.

For more information or your vaccination requirements for Brazil, please consult a medical professional with regard to the vaccination requirements for your travel.

#### 8. Hotel information

The official language in Brazil is Portuguese. English is spoken is some hotels and restaurants.

### 11. Weather and time zone information



In March, temperatures in Brasilia range between a maximum of 31°C in the daytime and a minimum of 21°C at night. Brasilia is 1,158 metres above sea level. The rainy season is during the months from December to March. Please bring appropriate clothing.
