Along with this form applicants should send by fax a copy of the following:

- A letter of assignment on official letterhead of their media organization signed by an authorized person (Editor, Bureau Chief or Publisher). It should specify the name and functional title of the journalist.
- Photocopy of a valid press card.

Participants are encouraged to submit their accreditation request form **no later than 30 August 2005**. It should be noted that double accreditation (e.g. as press and delegate or NGO) is not allowed.

Registration

Upon arrival in Montreal, participants will be required to present their original press card and two forms of photo ID (passport, driver's license or work ID) at the registration desk located at the lower atrium of the ICAO building. Registration will begin Sunday, 4 September from 3 to 6 p.m. and will continue on Monday, 5 September 2005 at 8 a.m. Journalists who are accredited will be issued with press identification badges in order for them to gain access to the conference venue and the public sessions.
