REVIEW OF PROGRESS IN PROVIDING SUPPORT IN IMPLEMENTING THE OBJECTIVES OF THE CONVENTION AND ITS STRATEGIC PLAN FOR BIODIVERSITY 2011-2020

Note by the Executive Secretary**

I. INTRODUCTION

- 1. The Strategic Plan for Biodiversity 2011-2020 is an ambitious plan developed with the purpose of inspiring broad-based action in support of biodiversity over the United Nations Decade on Biodiversity by all countries and stakeholders. As indicated in the annex to decision X/2, the Plan will be implemented primarily through activities at national or subnational levels, with supporting action at the regional and global levels.
- 2. Moreover, the Conference of the Parties (decision X/2, paragraph 6) emphasized the need for capacity-building activities and the effective sharing of knowledge, consistent with decisions VIII/8, IX/8 and other relevant decisions of the Conference of the Parties, in order to support all countries, especially developing countries, in particular the least developed countries, small island developing States, and the most environmentally vulnerable countries, as well as countries with economies in transition, and indigenous and local communities, in the implementation of the Strategic Plan for Biodiversity 2011-2020.
- 3. In accordance with its multi-year programme of work (decision X/9), the Conference of the Parties, at its eleventh meeting addressed, *inter alia*, the following issues in reviewing progress in providing support to assist Parties: resource mobilization; capacity-building; stakeholder engagement; communication, education and public awareness; clearing-house mechanism. The meeting also reviewed progress on activities undertaken to increase global awareness of the United Nations Decade on Biodiversity.

- 4. In paragraph 9 of decision XI/2, the Conference of the Parties reiterated its request to the Executive Secretary, in cooperation with partner organizations, to facilitate the continued exchange of best practices and lessons learned from the preparation, updating and revision of national biodiversity strategies and action plans (NBSAPs). In paragraph 10 of the same decision, the Conference of the Parties also requested the Executive Secretary to continue promoting and facilitating activities, in partnership with relevant organizations, to strengthen implementation of the Strategic Plan for Biodiversity 2011-2020 and progress towards the Aichi Biodiversity Targets at the national, subregional and regional levels, and encouraged other donors and parties to complement the funds provided by the Government of Japan, through the Japan Biodiversity Fund.
- 5. In response to the above requests to the Executive Secretary, this document has been prepared to provide the fifth meeting of the Ad Hoc Open-ended Working Group on Review of Implementation of the Convention with updated information on progress achieved in providing support to Parties for revising and updating their NBSAPs and strengthening their capacity to implement the Convention and its Protocols. Previous documents related to this agenda item include UNEP/CBD/COP/11/13 and UNEP/CBD/COP/11/INF/13. Parties are advised that activities carried out regarding the provision of support for Scientific and Technical Cooperation and Technology Transfer and the clearing-house mechanism, in accordance with requests from the tenth and eleventh meetings of the Conference of the Parties, are contained in the respective addenda to this document (UNEP/CBD/WGRI/5/3/Add.1, UNEP/CBD/WGRI/5/3/Add.2). Capacity-building initiatives for indigenous and local communities are reported in document UNEP/CBD/WG8J/8/2, which was considered by the eighth meeting of the Working Group on Article 8(j) and Related Provisions when met in Montreal from 7 to 11 October 2013.
- 6. A large number of the activities undertaken by the Secretariat to strengthen the capacity of Parties have been supported by the Japan Biodiversity Fund. This Fund, established by the Government of Japan as the Presidency of the tenth meeting of the Conference of the Parties, aims to build the capacity of developing countries with resources of 5 billion yen in total. The Fund's objective is to help developing countries to develop their capacity to implement the Aichi-Nagoya Biodiversity Compact by providing support to the Secretariat to assist Parties to: (i) implement the Strategic Plan for Biodiversity 2011–2020 and the associated Aichi Biodiversity Targets; (ii) revise their NBSAPs to include national targets, in accordance with the Strategic Plan for Biodiversity 2011-2020; and (iii) strengthen their overall capacity to implement the Convention.
- 7. Other donors, including Canada, China, Denmark, European Union, France, Germany, Republic of Korea, Netherlands, Norway, Spain, United Kingdom and Uruguay have also been supporting these Secretariat-led activities.
- 8. The Executive Secretary has also prepared a note on progress on the provision of support for Communication, Education and Public Awareness (CEPA), including the United Nations Decade on Biodiversity (UNDB) (UNEP/CBD/WGRI/5/INF/1).

II. PROGRESS IN PROVIDING CAPACITY-BUILDING SUPPORT FOR REVISING AND UPDATING NATIONAL BIODIVERSITY STRATEGIES AND ACTION PLANS

- 9. During the period 2012-2013, the Secretariat, together with partner organizations and host countries and with the support of the Government of Japan and other donors, has organized a number of capacity-building workshops for updating NBSAPs.
- 10. These regional and subregional capacity-building workshops for implementing the Strategic Plan for Biodiversity 2011-2020 were organized by the Secretariat to assist countries in establishing national targets in the framework of the Aichi Biodiversity Targets, and in revising and updating NBSAPs, supported by the Government of Japan, through the Japan Biodiversity Fund, and other donors.

- 11. In addition to the organization of the 17 workshops¹ reported in UNEP/CBD/COP/11/13, five follow-up regional workshops (Pacific, North Africa and the Middle East, Caribbean, Central and Eastern Europe and Central Asia, plus Latin America) were held between August 2012 and May 2013, for a total of 22 having been conducted in this series. Of these 22 workshops, a total of 7 were follow-up workshops. Further details are provided below. Over 925 individuals and 174 Parties participated in the above series of workshops. Workshop presentations, materials, outputs and summary reports, including summaries of participant evaluations, are available at: www.cbd.int/nbsap/workshops2.shtml.
- 12. To complement the above series of workshops, the Secretariat convened a global workshop in Nairobi, from 11 to 15 November 2013, to review progress and build capacity for the NBSAP revision process, primarily targeting the national GEF-Enabling Activity Project Coordinators. This workshop was convened in response to decision X/2, which urges Parties and Governments to revise and update their NBSAPs, and report thereon to the twelfth meeting of the Conference of the Parties in October 2014. It also follows up on decision XI/2, which requests the Executive Secretary to continue to promote and facilitate, in partnership with relevant organizations, activities to strengthen implementation of the Strategic Plan for Biodiversity 2011-2020 and the Aichi Biodiversity Targets at the national, subregional and regional levels. The programme of the workshop, delivered in five United Nations languages, focused on aspects of NBSAP planning and development that have been identified as the most in need of capacity-building and technical support and consisted of three major themes - resource mobilization and valuation, mainstreaming, and national target-setting. A total of 110 Parties and 160 participants, primarily NBSAP project coordinators, were represented at this workshop. Members of the NBSAP Forum (see paragraphs 12 and 13 below) also provided additional support, in delivering thematic modules, serving as resource persons and contributing to side events. - 13. Launched at the eleventh meeting of the Conference of the Parties in October 2012, the NBSAP Forum is a global partnership, hosted by the Secretariat of the Convention on Biological Diversity (SCBD), the United Nations Development Programme (UNDP) and the United Nations Environment Programme World Conservation Monitoring Centre (UNEP-WCMC), whose mission is to support countries in revising their NBSAPs and setting national targets. The NBSAP Forum's web portal site became operational in late 2013 (http://nbsapforum.net/) and is intended to serve as a "one-stop shop" where members can access resources (e.g. public-access articles, guide books, maps, websites, best practices) to assist with all aspects of the Aichi Biodiversity Targets and other key biodiversity planning themes and also to act as a portal to other useful websites for biodiversity planning.
- The NBSAP web pages on the CBD website have been updated with a view to streamlining information searches, improving the presentation of information and, to a certain extent, complementing the information available on the NBSAP Forum's portal site. In planning and carrying out activities for revising their NBSAPs and setting national targets, Parties may be interested to note the information available on the webpage on "COP Guidance on NBSAPs" at http://www.cbd.int/nbsap/guidance.shtml, which provides quick references to areas that Parties have suggested, through decisions of the ninth, tenth and eleventh meetings of the Conference of the Parties, should be included in NBSAPs with links to the respective CBD web pages of the area in question also provided. NBSAPs submitted after the tenth meeting the Conference of the **Parties** highlighted are http://www.cbd.int/nbsap/about/latest/default.shtml. In addition, the National Targets database at http://www.cbd.int/nbsap/targets/default.shtml has been updated with all national targets (or equivalent) taken from these NBSAPs, to provide examples of national targets established by Parties that contribute to the implementation of the Aichi Biodiversity Targets, with indications as to which targets have been officially mapped to the global Aichi Biodiversity Targets by the Party concerned. III. PROGRESS IN PROVIDING CAPACITY-BUILDING SUPPORT FOR IMPLEMENTING THE STRATEGIC PLAN FOR BIODIVSERITY 2011-2020

- 15. The Secretariat, together with partner organizations and host countries, and with the support of Japan and other donors, has facilitated other activities to build the capacity of developing countries to implement the Strategic Plan for Biodiversity 2011-2020 in addition to the support for NBSAP revision mentioned above. The table annexed to this note summarizes the capacity-building activities the Secretariat has been conducting in 2013-2014 (annex I), from which it can be seen that the Japan Biodiversity Fund, in collaboration with other partners, has facilitated the Secretariat's work in assisting Parties not only to meet Aichi Biodiversity Target 17 on NBSAPs, but also to develop their capacity to implement other Aichi Biodiversity Targets and the Strategic Plan for Biodiversity 2011-2020 as a whole.
- 16. Annex II shows the list of capacity-building workshops covering the majority of the Aichi Biodiversity Targets which the Secretariat organized in 2013-2014 with support from Japan and other donors.
- 17. There remains a capacity gap at national level, especially in developing countries, to implement the Strategic Plan for Biodiversity 2011-2020; specific needs and mechanisms will be discussed under various agenda items as indicated in annex III.
- 18. Annex III shows possible elements to be prioritized in further supporting Parties to implement the Strategic Plan for Biodiversity 2011-2020 and the agenda items of fifth meeting of the Ad Hoc Openended Working Group on Review of Implementation of the Convention and eighteenth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA-18) where Parties may wish to discuss these elements further.
- 19. While an increasing number of donors, including some developing countries, are supporting capacity-building activities under the Secretariat, currently, and since the tenth meeting of the Conference of the Parties, the Japan Biodiversity Fund has been supporting, by far, the largest share of these activities. As the support from the Japan Biodiversity Fund is gradually phased out by 2020, there is therefore a need for increased support from other donors.
- 20. At the same time, the Secretariat is also committed to further enhance its capacity-building activities within its mandate, and to streamline such activities. Accordingly, the Executive Secretary established an internal task force on capacity-building to develop a "Secretariat-Wide Approach to Capacity-Building and Training" in order to respond in a strategic, coherent and coordinated manner to the various requests by the Conference of the Parties and the Conference of the Parties serving as the meeting of the Parties to the Cartagena Protocol on Biosafety to undertake capacity-building activities to assist Parties in the implementation of their obligations under the Convention and its Protocols on biosafety and access and benefit-sharing.
- 21. Based on the work of the task force, the Secretariat is currently developing its capacity development strategy and action plan for supporting the implementation of the Convention and its two Protocols, in line with the Strategic Plan for Biodiversity 2011-2020 and its Aichi Biodiversity Targets and the Strategic Plan for the Cartagena Protocol on Biosafety 2011-2020, taking also into account the Secretariat's work on technical and scientific cooperation. The strategy and action plan is intended to guide the Secretariat in the design, implementation and evaluation of its capacity-building activities for the period 2014-2020. It will enable the Secretariat to adopt a more strategic, coherent and results-oriented approach to capacity-building and also to leverage resources and opportunities through strategic partnerships and collaborative initiatives, which will ultimately help improve the efficiency, effectiveness and impact of its capacity-building activities. Once finalized, the draft strategy and action plan will be made available for the information of Parties.

22. In addition, the Executive Secretary, with financial support from the Japan Biodiversity Fund, has hired a consulting firm to develop a guidebook and train/coach Secretariat staff to enable them to more effectively design, deliver and evaluate training activities and to provide follow-up support and continuous learning opportunities for trained trainers to be nominated by Parties, indigenous and local communities and other stakeholders. This will promote consistent standards and approaches to training activities across the Secretariat programme areas and help to improve the overall quality and impact of the Secretariat's support to Parties. The guide on "Designing and Delivering Effective Trainings for the Implementation of the Convention and its two Protocols on Biosafety and Access and Benefit-Sharing" will also be available through the clearing-house mechanism for use, as appropriate, by Parties and other relevant stakeholders.

IV. SUGGESTED RECCOMENDATION

23. The Ad Hoc Open-ended Working Group on Review of Implementation of the Convention may wish to adopt a decision along the following lines:

The Ad Hoc Open-ended Working Group on Review of Implementation of the Convention,

- 1. *Invites* Parties to consider, as necessary, recommendations for capacity-building support to Parties, including on scientific and technical cooperation, to further enhance implementation of the Strategic Plan for Biodiversity 2011-2020 and its Aichi Biodiversity Targets for inclusion in a "Pyeongchang Roadmap 2020" by the Conference of Parties, at its twelfth meeting;
- 2. *Recommends* that the Conference of Parties, at its twelfth meeting, adopt a decision along the following lines:

The Conference of the Parties

- 1. *Recognizes* that there remains a capacity gap at national level, especially in developing countries, to implement the Strategic Plan for Biodiversity 2011-2020 and the Aichi Biodiversity Targets;
- 2. Welcomes the efforts of the Secretariat to further enhance and streamline capacity-building support to Parties for the effective implementation of the Convention and its Protocols;
- 3. Recalling paragraph 10 of decision XI/2, further requests the Executive Secretary to continue promoting and facilitating, in partnership with relevant organizations, activities to strengthen implementation of the Strategic Plan for Biodiversity 2011–2020 and progress towards the Aichi Biodiversity Targets at the national, subregional and regional levels, and encourages other donors and Parties to complement the funds provided by the Government of Japan, as well as Canada, China, Denmark, European Union, France, Germany, Republic of Korea, Netherlands, Norway, Spain, United Kingdom and Uruguay in this context.
