#### THE FINANCIAL MECHANISM

#### Review of implementation of decision XI/5

Note by the Executive Secretary

- 1. In accordance with the provisional agenda, the fifth meeting of the Ad Hoc Open-ended Group on Review of Implementation of the Convention will consider the implementation of decision XI/5 (on the financial mechanism). The present note has been prepared in close cooperation with the Secretariat of the Global Environment Facility, providing pertinent updates on the implementation of the various elements of decision XI/5, for consideration by the Working Group.
- 2. The present note has three sections. Section I provides the brief updates provided by the Global Environment Facility (GEF) in response to decision XI/5, bearing in mind that a full report from the Global Environment Facility will soon be available for the twelfth meeting of the Conference of the Parties (COP 12). Section II describes additional sources of relevant information and updates by the Executive Secretary, in line with the elements of the Memorandum of Understanding: provision of guidance, reporting from the GEF Council, monitoring and evaluation, determination of funding needs, inter-secretariat collaboration, as well as the two protocols under the Convention. Section III provides possible elements for inclusion in a decision on the financial mechanism that the Ad Hoc Open-ended Group on Review of Implementation of the Convention may wish to consider at its fifth meeting.
- 3. The fifth meeting of the Ad Hoc Open-ended Working Group on Review of Implementation of the Convention is invited to take note of the updates and develop relevant recommendations for consideration by the twelfth meeting of the Conference of the Parties.

Council will prepare and submit a report for each ordinary meeting of the Conference of the Parties. Based on past practice, the official report from the Council of the Global Environment Facility to the twelfth meeting of the Conference of the Parties will become available in July/August 2014. However, the Global Environment Facility has provided the following update for the benefit of the fifth meeting of the Ad Hoc Open-ended Working Group on Review of Implementation of the Convention.

### Nagova Protocol on Access and Benefit-sharing

Recommends that the Global Environment Facility make available the necessary funds for activities to support access and benefit-sharing and the early entry into force and implementation of the Nagoya Protocol in order to implement the third objective of the Convention on Biological Diversity, and further recommends that GEF operational focal points carefully consider the urgent need to finance activities related to access and benefit-sharing and the Nagoya Protocol when consulting national stakeholders on the distribution of the System for Transparent Allocation of Resources (STAR) allocation;

Further recommends that the Global Environment Facility continue to finance, as a priority, technical support to Parties aimed at the speedy ratification and early entry into force of the Nagova Protocol, and its implementation at national level;

Requests GEF, in considering financing for Nagova Protocol Implementation Fund projects, to ensure that the Fund will specifically support activities related to early ratification and capacity-building, and be used for access to and utilization of genetic resources only when such activities have been approved by appropriate government authorities and endorsed through the GEF operational focal point;

Requests the GEF to continue to administer the NPIF until the time the resources committed up to the end of GEF-5 are disbursed, and to report on the status of the fund to the twelfth meeting of the Conference of the Parties to the Convention, which shall decide on its biodiversity strategy provides opportunity for country-driven projects to exploit synergies amongst the relevant multilateral environment agreements and advance shared objectives.

GEF will provide a full report for COP 12 on support to the implementation of the Nagoya Protocol. In brief, during GEF-5, the GEF Trust Fund supported the ratification and implementation of the Nagoya Protocol thorough 7 country-based projects and two global projects (50 countries for the early entry into force of the protocol and 25 countries for ratification). The GEF invested \$29 million and leveraged \$64 million in co-financing.

The GEF-6 biodiversity strategy responds to the guidance provided by the Conference of the Parties to GEF on the programme priorities to support the implementation of the Nagoya Protocol on Access and Benefit Sharing.

The Nagoya Protocol Implementation Fund (NPIF) has supported 11 projects totalling \$12.6 million and leveraging \$29.9 million in co-financing. These include 8 country-based projects, one global project and two regional projects (Pacific, Central Africa) in support of ratification of the Nagoya Protocol. Although all projects will support ratification in some measure, the global project and two regional projects were solely focused on accelerating early ratification. GEF will provide a full report to COP 12.

5. The Global Environment Facility also provided further updates on the Nagoya Protocol Implementation Fund (NPIF). The creation of the Nagoya Protocol Implementation Fund (NPIF) was

approved by the GEF Council on 18 February 2011. Following this decision, the GEF Council approved the operational arrangements of this new multi-donor trust fund at its May 2011 meeting. The NPIF was established to promote the early entry into force and effective implementation of the Nagoya Protocol on Access to Genetic Resources and the Fair and Equitable Sharing of Benefits Arising from their Utilization. To date, the NPIF has received contributions totaling \$16 million generously made available by the governments of Japan, France, Norway, Switzerland and the United Kingdom. The NPIF started its operation in the summer of 2011, with the first grant being awarded on 13 December 2011. Over the last three years, the GEF Secretariat has approved 11 proposals totalling \$12.6 million,<sup>3</sup> leveraging \$29.9 million in co-financing. These projects have benefited a total of 51 countries. These projects include eight country-based projects (Bhutan, Colombia, Cook Islands, Costa Rica, Fiji, Gabon, Kenya and Panama), one global project in support of ratification of the Nagova Protocol (21 supported so far) and two regional projects in support of the ratification of the Nagoya Protocol: one in central Africa for the ten member states of the Central African Forests Commission (COMIFAC), and one in the Pacific for the twelve member countries of the Secretariat of the Pacific Regional Environment Programme (SPREP). The country-based projects are achieving a dual role: the development of access and benefit-sharing (ABS) agreements between users and providers or genetic resources, and the advance of the ABS agenda at the national level. ABS agreements are being developed using marine resources (Fiji and Panama), vascular plants (Colombia and Costa Rica) and extremophiles (Kenya). The global and regional projects are assisting countries in the ratification and/or implementation of basic provisions of the Nagoya Protocol, and some of them have already ratified the Nagoya Protocol (Bhutan, Burkina Faso, Côte d'Ivoire, Egypt, Fiji, Guinea-Bissau, Micronesia, and Panama) effectively contributing to the entry into force of this legally binding protocol.

#### II. ADDITIONAL INFORMATION ON DECISION XI/5

#### Guidance to the financial mechanism

- 6. The Executive Secretary transmitted decision XI/5 to the Chief Executive Officer and Chairperson of the Global Environment Facility on 29 October 2012, and reiterated the messages from the eleventh meeting of the Conference of the Parties through his statements to the forty-third and forty-fourth meetings of the Council of the Global Environment Facility. A joint CBD-GEF Webinar on the Financial Mechanism and 2020 Aichi Biodiversity Targets was also held on 5 June 2013 during World Environment Day.
- 7. The responses of the Global Environment Facility have been largely captured through the following documents: GEF-6 Programming Directions (GEF/R.6/20/Rev.01) and Strategic Positioning for the GEF (GEF/R.6/19), GEF-6 Policy Recommendations (GEF/R.6/21) and Management Response to the Fifth Overall Performance Study of the GEF (GEF/R.6/18). In accordance with paragraph 7 of the Memorandum of Understanding, these official documents of GEF have been made available by the GEF Secretariat to the Secretariat of the Convention on Biological Diversity, and are hereby issued as information documents for the present meeting.

#### Reporting

8. The Secretariat has been in close liaison with the Global Environment Facility with regard to the regular reporting obligations under the Memorandum of Understanding between the Conference of the Parties to the Convention and the Council of the Global Environment Facility, as well as the request contained in paragraph 2 of decision XI/5 to report back to the Conference of the Parties at its twelfth meeting on the GEF-6 strategy and its thirteenth meeting on its implementation and how it responds to the individual elements and their components, and the additional strategic considerations of the framework.

#### Monitoring and evaluation

9. In paragraph 7 of decision XI/5, the Conference of the Parties requested the Executive Secretary to make available to Parties the report of the fourth review of the effectiveness of the financial mechanism for consideration by the Ad Hoc Open-ended Working Group on Review of Implementation of the Convention at its fifth meeting. The report of the fourth review of the effectiveness of the financial mechanism is available in information document UNEP/CBD/WGRI/5/INF/10, and the comments and draft decision are provided in document UNEP/CBD/WGRI/5/5/Add.1.

#### Determination of funding needs

- 10. In paragraphs 6 and 8 to 14 of decision XI/5, the Conference of the Parties invited developed country Parties and others to increase their financial contributions through the financial mechanism during the sixth GEF replenishment period (GEF-6), and noted the report of the assessment of needs for GEF-6. In paragraph 15 of the same decision, the Conference of the Parties transmitted to the Global Environment Facility the report on the assessment of needs for GEF-6, for consideration by the Global Environment Facility, so that the Facility will in its regular report to the Conference of Parties indicate how it has responded during the replenishment cycle to the previous assessment by the Conference of the Parties.
- 11. The Executive Secretary transmitted decision XI/5 to the Chief Executive Officer and Chairperson of the Global Environment Facility on 29 October 2012, and reiterated the messages from the eleventh meeting of the Conference of the Parties through his statements to the forty-third and forty-fourth meetings of the Council of the Global Environment Facility.
- 12. The fourth meeting of the GEF-6 replenishment is scheduled to take place in Geneva, Switzerland from 16-17 April 2014, and the results of the GEF-6 replenishment will be contained in the document entitled "Summary of Negotiations Sixth Replenishment of the GEF Trust Fund". In accordance with paragraph 7 of the Memorandum of Understanding, the official document of GEF will be made available by the GEF Secretariat to the Secretariat of the Convention on Biological Diversity, and will be issued as an information document for the present meeting.

#### Inter-secretariat collaboration

- 13. Since the eleventh meeting of the Conference of the Parties, the CBD and GEF secretariats have continued their efforts to enhance inter-secretariat collaboration in response to various decisions. The CBD Secretariat has revamped its website on the financial mechanism under the new headings of GEF strategies, programmes and projects, GEF accountability, GEF effectiveness and GEF replenishment, and also hosted the joint CBD-GEF retreat on the financial mechanism and 2020 Aichi Biodiversity Targets from 4-5 June 2013. The CBD Secretariat has continued to review relevant project proposals from the GEF agencies, and has provided comments as appropriate, including through participation in the teleconference of the Executive GEF Operations Committee (GEFOP) meetings. The CBD Secretariat has continued to provide information input to the GEF Council document entitled "Relations with conventions and institutions", and to monitor the responses of the GEF Council to the requests from the Conference of the Parties, including the internal analysis of the ongoing GEF project portfolio and participation in meetings of the GEF Council and other meetings. The CBD Secretariat was involved through technical interactions in the elaboration of the GEF-6 Biodiversity Strategy, and the comments of the Executive Secretary are available on the CBD website (https://www.cbd.int/financial/gef/guidance/).
- 14. At a meeting on 2 and 3 September 2013, the liaison group of biodiversity-related conventions (BLG) considered the relationship between its members and the Global Environment Facility (GEF),

including on how to help countries access GEF funding to implement projects that harness synergies amongst the biodiversity-related conventions while being consistent with the GEF mandate.<sup>4</sup> At an earlier meeting, the BLG had noted that additional funding for activities of biodiversity-related conventions other than the Convention on Biological Diversity (CBD) may be obtained from the GEF if the activities contribute to the achievement of the Strategic Plan for Biodiversity 2011-2020 and its Aichi targets, and had therefore agreed that a joint approach by the conventions may facilitate country access to funding and that such an approach should be further discussed.

- 15. The BLG meeting, organized in close collaboration with the GEF secretariat,<sup>5</sup> underscored that a significant amount of GEF-funding, and associated projects, already contribute to implementation of biodiversity-related conventions other than the CBD, and emphasized the importance of using better programmatic synergies among the biodiversity-related conventions as a means for obtaining better access to GEF funds for those conventions for which the GEF is not the financial mechanism. In this context, the meeting reiterated the importance of the Strategic Plan for Biodiversity 2011-2020 and its Aichi targets as the global framework and entry point for harnessing synergy with the respective conventions. It was recalled that the Strategic Plan was adopted by the tenth meeting of the Conference of the Parties to the CBD as an inclusive framework which is relevant for all biodiversity-related conventions. The Strategic Plan has been recognized as such in various decisions of the Conference of the Parties or resolutions of the governing bodies of other biodiversity-related conventions.
- 16. As an important element<sup>6</sup> in establishing a closer relationship with the GEF, the BLG noted that it could be useful to put arrangements in place which would enable the communication of pertinent recommendations of other biodiversity-related conventions to the GEF in a well-coordinated and effective manner. The meeting agreed to propose an arrangement consisting of the following elements, for consideration by the Working Group on Review of Implementation of the Convention at its fifth meeting and the Conference of the Parties at its twelfth meeting:
- (a) The Conference of the Parties to the Convention on Biological Diversity invites the governing bodies of the other biodiversity-related conventions (i) to provide, as appropriate, any GEF-related advice that is pertinent to their respective mandate and the mandate of the GEF; and (ii) to request their respective secretariats to transmit such advice to the Executive Secretary of the Convention on Biological Diversity;
- (b) The Conference of the Parties to the Convention on Biological Diversity requests the Executive Secretary of the Convention on Biological Diversity, upon receipt of such advice, to include it in the pre-session documentation for the appropriate agenda item, for consideration by the Conference of the Parties to the Convention on Biological Diversity;

Nagoya Protocol on Access and Benefit-sharing

17. The Global Environment Facility provided an update on its activities related to the Nagoya Protocol Implementation Fund (see section I above). The GEF Secretariat has provided regular updates

on the Nagoya Protocol Implementation Fund through its information document to the Council of the GEF. In accordance with paragraph 7 of the Memorandum of Understanding, the official documents of GEF will be made available by the GEF Secretariat to the Secretariat of the Convention on Biological Diversity, and the latest information document on the Nagoya Protocol Implementation Fund will be issued as an information document for the present meeting.

#### Cartagena Protocol on Biosafety

18. In paragraph 28 of decision XI/5, the Conference of the Parties transmitted the guidance received from the Conference of the Parties serving as the meeting of the Parties to the Cartagena Protocol on Biosafety to the financial mechanism; the decision also requested the Executive Secretary to further communicate with the GEF Secretariat before the meeting of the GEF Council in November 2012 in order to discuss the possibility of opening a special financial support window for implementation of the Protocol, and to report on the outcome to the Parties to the Protocol. The Executive Secretary transmitted this decision to the Chief Executive Officer and Chairperson of the Global Environment Facility on 29 October 2012. Due to the narrow proximity between the October meeting of the Conference of the Parties and the November meeting of the GEF Council, there was no discussion on this matter within the November meeting of the GEF Council. The CBD and GEF Secretariats further discussed the issue at the joint CBD-GEF retreat on the financial mechanism and 2020 Aichi Biodiversity Targets held 4-5 June 2013.

#### III. RECOMMENDATIONS

- 19. The fifth meeting of the Ad Hoc Open-ended Working Group on Review of Implementation of the Convention is thus invited to review the updates provided in the present note and the associated information documents provided by the Global Environment Facility, but no comprehensive recommendations were prepared due to a number of factors. In accordance with the Memorandum of Understanding, the financial mechanism has been a standing item on the agenda of the ordinary meetings of the Conference of the Parties, and the official report of the Global Environment Facility will be made available to the twelfth meeting of the Conference of the Parties. It should also be noted that most of the information documents from the Global Environment Facility had not been finalized at the time when the present note was prepared; their final versions will be available to the fifth meeting of the Ad Hoc Openended Working Group on Review of Implementation of the Convention.
- 20. Based on the outcomes of the aforementioned meeting of the liaison group of biodiversity-related conventions (BLG) from 2-3 September 2013, however, the fifth meeting of the Ad Hoc Open-ended Working Group on Review of Implementation of the Convention may wish to consider the following elements for inclusion in a decision on the financial mechanism:

#### *The Conference of the Parties,*

*Recalling* that the Strategic Plan for Biodiversity 2011-2020 represents a useful flexible framework that is relevant to all biodiversity-related conventions, and *welcoming* the recognition given to the Strategic Plan in the decisions or resolutions of the governing bodies of other biodiversity-related conventions,

*Recognizing* that funding provided by the financial mechanism of the Convention on Biological Diversity already contributes to the implementation of biodiversity-related conventions other than the Convention on Biological Diversity,

*Mindful of* the importance of enhancing programmatic synergies among the biodiversity-related conventions, in the context of revised national biodiversity strategies and action plans, the Strategic Plan for Biodiversity 2011-2020 and the GEF-6 programming directions including the biodiversity focal area strategy, for the effective use of financial resources and the effective implementation of the Aichi biodiversity Targets,

- 1. *Invites* the governing bodies of the other biodiversity-related conventions to:
- (a) Provide elements of advice, as appropriate, concerning the funding of activities within their respective mandate and the respective mandate of the GEF, that may be referred to the GEF through the Conference of the Parties to the Convention;
- (b) Request their respective secretariats to transmit, in a timely manner, such advice to the Executive Secretary of the Convention on Biological Diversity;
- 2. Requests the Executive Secretary of the Convention on Biological Diversity to include any advice received in accordance with the previous paragraph into the documentation of the appropriate agenda item, for consideration by the Conference of the Parties to the Convention on Biological Diversity at its next meeting.
