222- 223	Worth considering what it means to be an expert. IP&LC groups / women / farmers can provide expert knowledge, regardless of having or not having formal degrees or other titles that would typical signify "expert" status.
354	I recommend adding under resources the " <u>Integrated Spatial Planning</u> <u>Workbook</u> ", published in 2022 by UNDP. This document relates directly to landscape approaches, providing a guide to UNDP's methodology for integrated spatial planning, which has been piloted in 11 countries. You can add the following text:

158	Great to mention all the sectors that might contribute/benefit from landscape approaches. I would be good to mention the nexus on biodiversity/climate change here (maybe where "forestry" is noted), because landscape approaches can also support in achieving the climate- related goals for a given entity.
173 (whole following para)	Would be good to mention experts in Systematic Conservation Planning, who are the experts that most of the time run prioritization analysis and are able to produce maps to guide decision making.

189	On the considerations to mobilize the right stakeholders, mention the language, as well as the appropriate facilitation for the consultations. Some groups (and/or genders) might want to meet separately.
	Under "convene and establish objective", second bullet seems to display an error?
	Under "map" it might be good to refer to both national and global data that can support the mapping exercise
218	Recommend having Indigenous Peoples and Local Communities on a separate bullet than civil society
220	Experts *and facilitators (they play an important role especially when it comes to the trade-offs)
228	Same, IPLCs could be considered as experts?
279	I would recommend adding to the list "Essential Life Support Areas (ELSAs)", and could use the sentence "Essential Life Support Areas (ELSAs) that indicate where actions to protect, sustainably manage and restore nature could occur in a country, based on a thorough stakeholder engagement process". There may be some value in clarifying what is meant by the term 'indicator'. Most of my comments below get at specific (duplicate) instances of this, where things like 'progress' towards something is not very clearly defined. For an indicator to be of actual use it must be something more concrete - how can and is progress defined in light of a target? If the BGF text is actually ambiguous on this, then we should press that an indicator is something measurable and that local/national efforts must address what this means in light of both policy and available data.

Please provide general comments on the draft manual below.

The report is meaningful in supporting national governments to apply landscape approaches in the planning and achieving of GBF.

Chapter 1 is important for the key definitions. However, both the definition of landscape and landscape approach under the context of GBF are not very clearly explained in the text. Suggest more clarification on landscape, especially the ecological meaning - this may not be accurate to define ' landscapes are local features' (line 138), also not accurate to restrict landscape approaches to local scale only, other than larger spatial scale or national level.

'Conservation' was used as a broad term in the report, but line 153 is not an accurate explanation (see below comments).

General comment on the writing: The Summary and main text need further proofread. There are many verbalized expressions in the text that would be better to switch to written language - such as 'remain useful for some time', 'more of a concept', 'some form of', 'as much as possible', "more or less", and there is an overuse of 'but'.

139	"Landscape approaches are, therefore, applied at the local level" this may not be accurate, landscape could be multiple spatial scales.	
153-155	This sentence is a bit confusing, conservation is not responsible for managing PAs. Generally, PAs established for protecting or maintaining biodiversity serve as important approach / tools for conservation.	
Page 7 the 'Map' box	"These maps are at a coarse scale, so they may be of limited use", this is not very accurate. There are high (10m) and mid (30-100m) resolution free land cover maps available that can be applied at local scale.	

	Accuracy assessment and/or growth truthing is suggested when using these remote sensing products to support action plans on the ground.
Page 7 the 'Map' box	I don't think 'ArcGIS' is more advanced than 'QGIS'
