## Regional Workshop on Sustainable Use, Salinas, Ecuador, 18 to 21 February 2002

The consulate of Ecuador in Montreal advises that citizens of the following countries require a visa to enter Ecuador: Afghanistan, Algeria, Bangladesh, Costa Rica, Cuba, Democratic People's Republic of Korea, Guatemala, Honduras, India, Iran, Iraq, Jordan, Lebanon, Lybia, Nigeria, Pakistan, Palestine Authority, People's Republic of China, Republic of Korea, Sri Lanka, Sudan, Syria, Tunisia, Vietnam and Yemen. **It is important for participants to obtain visas from the Ecuador embassies/consulates before travelling.** To enter the country, visitors must fill in an international embarkation - disembarkation form. It is important to keep it with your passport. Travellers should have their passports with them during their stay in Ecuador. A copy is not acceptable. Those who wish to stay longer in the country have to do the corresponding paperwork in an Ecuadorian Consulate.
