Re: Meeting of Technical Experts on the Requirements of Paragraph 2(a) of Article 18 of the Cartagena Protocol on Biosafety, Montreal, 18 to 20 March 2002

I am pleased to convey herewith the composition of the experts for the meeting on the requirements of paragraph 2(a) of Article 18 of the Cartagena Protocol on Biosafety to be convened pursuant to the recommendation of the second meeting of the Intergovernmental Committee for the Cartagena Protocol (ICCP). The meeting will take place in Montreal, from 18 to 20 March 2002 following the generous financial contribution made by the Governments of Canada, France, Switzerland and the United States of America.


The composition of the experts and the provisional agenda for the meeting are attached.
