I have the honour to inform you that, at the kind invitation of the Government of Malaysia, the seventh meeting of the Conference of the Parties to the Convention on Biological Diversity (COP-7) will be held in Kuala Lumpur, Malaysia, from 9 to 20 February 2004. The meeting will be followed by the first meeting of the Conference of the Parties serving as the meeting of the Parties to the Biosafety Protocol (COP-MOP-1), from 23 to 27 February 2004 to be held at the same venue.

It should be noted that, following adoption of its report and decisions on 20 February 2004, the seventh meeting of the Conference of the Parties (COP-7) will be adjourned until 27 February 2004 to allow the Conference of the Parties to serve as the meeting of the Parties to the Cartagena Protocol on Biosafety (COP-MOP-1). The seventh meeting of the Conference of the Parties (COP-7) will formally conclude its work on 27 February 2004 after the closing of the COP-MOP-1 meeting.

In this regard, I have the honour to invite your Government to designate its representative(s) to the above-mentioned meetings. Please inform the Secretariat of the name(s) and coordinates of your government's officially designated representative(s) to these two meetings at your earliest convenience but no later than **31 December 2003** so that travel arrangements are made in a timely manner in favour of eligible participants. To facilitate registration and for security and logistical purposes, participants are kindly requested to pre-register with the Secretariat using the attached forms. Please note that the forms are also included in the "Information for Participants Note" which is accessible at the Secretariat's web site at [www.biodiv.org](http://www.biodiv.org).

In accordance with rule 18 of the rules of procedure for meetings of the Conference of the Parties, I would be grateful if your Government would submit to the Secretariat, as soon as possible, the credentials of your representative(s) and the names of the alternate representative(s) and advisor(s), as appropriate, for both COP-7 and COP-MOP-1 meetings. Please note that separate credentials for the two meetings are required, even in cases where the same delegate(s) would represent the Government in both meetings. Please find attached herewith, for your convenience, a sample format of appropriate credentials for each meeting, which should be signed by the Head of State or Government or by the Minister for Foreign Affairs, except in the case of a regional economic integration organization, where it should be signed by the competent authority of that organization.

Subject to the availability of contributions to the Special Voluntary Trust Fund for Facilitating Participation of Parties in the Convention process for the biennium established by decision VI/29, the Secretariat hopes to be in a position to finance the participation of **one representative to each of the meetings** from each developing country Party to the Convention, in particular the least developed and small island States, and countries with economies in transition Party to the Convention. Countries Party to the Convention that wish to solicit such assistance are kindly requested to inform the Secretariat of the name and contact information of the designated delegate eligible for such financial support as soon as possible but no later than **31 December 2003**.

In view of the increased security procedures for travellers and budget constraints, and, in order to allow the maximum number of countries to participate in the meetings, the Secretariat will be using special air-fare tickets for sponsored delegates which impose restrictions with respect to changing the passenger's name, travel dates and itinerary. In this respect, it will not be possible for the Secretariat to accommodate name changes if they are received after the deadline of **31 December 2003** and/or the issuance of the air ticket, whichever is first.
