## NOTIFICATION

### **Urgent request for submissions on concrete activities and initiatives including measurable targets and/or indicators to achieve the strategic goals contained in the strategy for resource mobilization and on indicators to monitor the implementation of the strategy**

Dear Madam/Sir,

I would like to draw your kind attention to decision IX/11 (Review of implementation of Articles 20 and 21), B, wherein the Conference of the Parties:

“6. *Invites* Parties to submit views on concrete activities and initiatives including measurable targets and/or indicators to achieve the strategic goals contained in the strategy for resource mobilization and on indicators to monitor the implementation of the strategy;

“7. *Requests* the Executive Secretary to prepare a compilation of the information provided in accordance with paragraph 6 of the present decision, including options on monitoring progress towards the goals and objectives of the resource mobilization strategy, and make it available three months prior to the third meeting of the Ad Hoc Open-ended Working Group on Review of Implementation of the Convention;

“8. *Requests* the Ad Hoc Open Ended Group on Review of Implementation of the Convention to prepare at its third meeting a list of concrete activities and initiatives to achieve the strategic goals of the strategy for resource mobilization and on indicators to monitor the implementation of the Strategy, and submit it for consideration of the Conference of the Parties, at its tenth meeting.”

In response and to facilitate your submission, I circulated notification 2008-122 (Ref: SCBD/ITS/YX/64504) dated 22 September 2008, with a deadline of 12 December 2008, and upon request from some Parties the deadline was extended to 31 July 2009. Nevertheless, the Secretariat has received, so far, very limited number of submissions. A critical mass of submissions is essential for any meaningful deliberation on this important matter during the third meeting of the Ad Hoc Open Ended Group on Review of Implementation of the Convention (WGRI-3) to be held next May.

As WGRI-3 is fast approaching, I would like to invite Parties to expedite submissions which should reach the Secretariat **no later than 16 November 2009**. I also attach hereto the structure of the resultant document to be prepared for WGRI-3.

#### **I. INTRODUCTION**

1. In its decision IX/11 (Review of implementation of Articles 20 and 21), B, the Conference of the Parties invited, in paragraph 6, Parties to submit views on concrete activities and initiatives including measurable targets and/or indicators to achieve the strategic goals contained in the strategy for resource mobilization and on indicators to monitor the implementation of the strategy, and requested, in paragraph 7, the Executive Secretary to prepare a compilation of the information provided in accordance with paragraph 6 of the decision, including options on monitoring progress towards the goals and objectives of the resource mobilization strategy, and make it available three months prior to the third meeting of the Ad Hoc Open-ended Working Group on Review of Implementation of the Convention. In paragraph 8 of the same decision, the Conference of the Parties requested the Ad Hoc Open Ended Group on Review of Implementation of the Convention to prepare at its third meeting a list of concrete activities and initiatives to achieve the strategic goals of the strategy for resource mobilization and on indicators to monitor the implementation of the Strategy, and submit it for consideration of the Conference of the Parties, at its tenth meeting.

2. In response, the Executive Secretary transmitted to Parties and Governments the request from the Conference of the Parties through the notification SCBD/ITS/YX/64504 (2008-122) on 24 September 2008, and requested their submissions with the initial deadline of 12 December 2008. Subsequently, the Secretariat received submissions from Egypt, Peru, and Qatar. Upon the request from Parties, the Executive Secretary circulated a notification on 17 December 2008 to extend the deadline to 31 July 2009. As a result, the Secretariat received additional submissions from the European Union, including the

European Commission, Czech Republic, and France. The submissions received have been reproduced in the information document UNEP/CBD/WGRI/3/INF/4.
