Fair on National Experiences with the Implementation of the Cartagena Protocol on Biosafety

I have the honour to inform you that another fair on national experiences with the implementation of the Cartagena Protocol on Biosafety will be held at the margins of the sixth meeting of the Conference of the Parties serving as the meeting of the Parties to the Cartagena Protocol on Biosafety (COP-MOP 6) from 1 to 5 October 2012 in Hyderabad, India.

The fair, which is jointly organized by the Government of India, as the host of COP-MOP 6, and the CBD Secretariat, will provide Parties, other Governments and relevant organizations with the opportunity to showcase their national experiences, good practices and lessons learned on various topics, including:

- a) National implementation of the Strategic Plan for the Cartagena Protocol on Biosafety (2011-2020);

- e) Implementation of the programme of work on public awareness, education and participation concerning the safe transfer, handling and use of living modified organisms (2011-2015).

The participating governments and organizations will be able to present their activities and outputs in a variety of formats, including: posters, printed materials and CD-ROMs, videos and/or PowerPoint presentations.
