NOTIFICATION

Nomination of Experts to the Workshop of the Network of Laboratories for the Detection and Identification of Living Modified Organisms

Ispra, Italy, 25 – 27 November 2013

Dear Madam/Sir,

In decision BS-V/9, the Conference of Parties serving as the meeting of the Parties to the Cartagena Protocol (COP-MOP) established, through the Biosafety Clearing-House (BCH), an electronic network of laboratories to facilitate the identification of living modified organisms (LMOs) as well as the sharing of information and experiences. Furthermore, in that same decision, the COP-MOP requested the organization of workshops for representatives of laboratories involved in the detection of LMOs to exchange information and experience on the implementation of relevant standards and methods.

In implementing these requests, the Secretariat organized a series of online discussions under the Network of Laboratories for LMO Detection and Identification on topics that are relevant to LMO detection laboratories.¹ Further to the online discussions and following the generous offer by the Government of Japan, the Secretariat is organizing a workshop with the objective of:

- (i) Developing an implementation strategy with a view to guiding and assisting Parties in reaching the outcomes of the Strategic Plan for the Protocol that are relevant to the detection and identification of LMOs (under operational objectives 1.6, 1.8 and 2.3);² and
- (ii) Drafting a set of recommendations on the subject of detection and identification of LMOs for consideration by the COP-MOP at its seventh meeting.

Accordingly, I am pleased to invite Parties, other Governments and relevant organizations to nominate representatives from their national LMO detection laboratories to take part in the upcoming workshop, which is scheduled to take place from 25 to 27 November 2013, at the European Commission Joint Research Centre (JRC) in Ispra, Italy. Each nomination is to be accompanied by a brief statement indicating the activities in which the nominee has been involved that are relevant to LMO detection and identification and the anticipated benefit of the workshop to the participant.
