Contributions of biological and cultural diversity, community conservation, customary sustainable use and the power of local action to the implementation of the Strategic Plan for Biodiversity 2011-2020 and the Aichi Biodiversity Targets 11-12 October 2014- Pyeongchang, Republic of Korea

Dear Madam/Sir,

As the global community considers the mid-term review of the revised Strategic Plan for Biodiversity 2011-2020, the post-2015 development agenda and sustainable development goals, there has been a growing interest in the biological and cultural dimensions of diversity; the interactions between them; their connection to social and economic development; as well as their role in building resilience against natural and human induced change and more broadly the power of local action.

Issues of cultural and biological diversity, community conservation and the power of local action are indeed at the heart of the three goals of the Convention on Biological Diversity. They have inspired the Secretariat of the Convention on Biological Diversity and UNESCO, together with a number of partners, including FAO GIAHS, the World Indigenous and Local Community Land and Sea Managers Network (WIN/EI/UNDP), the ICCA Consortium, the International Indigenous Forum on Biodiversity, and CBD Korean Civil Network and local communities, to organize a weekend of activities that celebrate, draw attention to and consider the possible contributions of biological and cultural diversity, community conservation, customary sustainable use and the power of local action to the implementation of the Strategic Plan for Biodiversity 2011-2020 and the Aichi Biodiversity Targets.

The weekend of activities will include local temple and forest visits, a cultural event and reception and a series of roundtable discussions. These activities will be held on 11-12 October 2014, primarily in room G4, as well as in the Rio Conventions Pavilion and with off-site excursions.

The objectives include:

- To better understand the links between biological and cultural diversity and their implications for policy and actions at various levels, including different regional perspectives;
- To understand the contribution of ICCAs towards reaching multiple Aichi Biodiversity Targets and implementing the Strategic Plan for Biodiversity 2011-2020 and the Aichi Biodiversity Targets; and
- To foster discussions, and to share experiences, best practices and lessons learned from governments and ILCs on the links between cultural and biological diversity, traditional
