#### Update on the regional joint preparatory meetings of CITES and CBD representatives prior to the upcoming meetings of the respective Conferences of the Parties (CoP/COP)

In follow-up to the joint notification issued on 10 June 2016 (CITES Notification 2016/044 and CBD Notification 2016-077), and as per guidance provided in the joint notification, Parties are reminded to nominate one participant to take part in the preparatory meeting for CITES and one participant to take part in the preparatory meeting for CBD, and to inform the secretariats of particular issues or items of the agenda of the CoP/COP and COP/MOPs that they would like the preparatory meeting to address. To provide sufficient time for Parties to respond to this notification, the deadline for nomination has been extended to **4 July 2016**.

The CITES and CBD Secretariats are also pleased to inform you that the dates and venues of the meetings for Africa and the Pacific/Oceania have now been finalized. These details and other relevant information are provided in annex to this notification.

The CITES and CBD Secretariats take the opportunity to thank Parties that have nominated their representatives and transmitted their views and comments on the agenda of the CoP/COP and/or COP/MOPs. Nominated representatives will soon be contacted by the institutions responsible for making travel arrangements, and will receive further information in preparation for the meetings, including a provisional agenda and background documents, from the secretariats and their partner organizations.
