Follow-up to decisions of the eighth meeting of the Conference of the Parties serving as the meeting of the Parties to the Cartagena Protocol on Biosafety: Overview of requests for action and planned activities for the next biennium

Dear Madam/Sir,

The purpose of this notification is to bring to your attention the decisions adopted at the eighth meeting of the Conference of the Parties serving as the meeting of the Parties to the Cartagena Protocol (COP-MOP 8) that request action by Parties, other Governments and relevant organizations in relation to the Cartagena Protocol, as well as to provide information on planned activities for the biennium 2017-2018 in light of the decisions adopted at COP-MOP 8.

Actions to be undertaken by Parties, other Governments and relevant organizations

A number of decisions adopted at COP-MOP 8 call for action by Parties, other Governments and relevant organizations. A list of these requests and decisions is included in the annex for your consideration.

The Secretariat will follow up in due course to invite submissions, as appropriate, in preparation for intersessional activities.

Intersessional activities for the biennium 2017-2018

The following intersessional activities in support of the implementation of the Cartagena Protocol will take place in line with the decisions by COP-MOP 8:

- The fourteenth meeting of the Compliance Committee under the Cartagena Protocol on Biosafety (16 to 18 May 2017);
- The eleventh meeting of the Informal Advisory Committee (IAC) on the Biosafety Clearing-House (BCH) (tentatively scheduled for the fourth quarter 2017);
- A meeting of the Ad Hoc Technical Expert Group (AHTEG) on Socio-economic Considerations (tentatively scheduled for the fourth quarter 2017);
- The fifteenth meeting of the Compliance Committee under the Cartagena Protocol on Biosafety (tentatively scheduled for the second quarter 2018);

To: CPB National Focal Points and CBD National Focal Points (where CPB focal points have not yet been designated), relevant organizations







- The 22nd meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA), which will consider issues related to risk assessment and risk management as per decision CP-VIII/12 (tentatively scheduled for mid-2018);
- The second meeting of the Subsidiary Body on Implementation (SBI), which will review the revised format for the fourth national reports (tentatively scheduled for mid-2018).

Further details on these activities will be provided in due course.
