1. ABS Clearing-House Workshop: “How to effectively use the ABS Clearing-House and facilitate the implementation of the Nagoya Protocol”

This workshop will take place on Friday, 23 November 2018, from 10 a.m. to 1 p.m. This half-day workshop is organized by the Secretariat and made possible thanks to the generous support of the Government of Japan. The aim of the workshop is to inform participants of the recent changes to the ABS Clearing-House, including introducing two new common formats as well as other important improvements, and to provide training on the Protocol’s system to monitor the utilization of genetic resources through the ABS Clearing-House.
