30 September and 7 October 2026**

As you know, the seventeenth meeting of the Conference of the Parties (COP 17) to the Convention on Biological Diversity will take place concurrently with the twelfth meeting of the Conference of the Parties serving as the meeting of the Parties to the Cartagena Protocol (CP-MOP 12) and the sixth meeting of the Conference of the Parties serving as the meeting of the Parties to the Nagoya Protocol (NP-MOP 6), from 19 to 30 October 2026 in Yerevan, Armenia. The first webinar on organizational preparations will aim to brief participants on a number of organizational matters, including an overview of the scenario note and organization of work for COP 17, the modalities for early submission of statements, updates on parallel events and logistics. In addition, the incoming Armenian Presidency will be providing an overview of the preparations for the Leaders' Summit and High-Level Segment. This webinar on organizational matters will be held on Microsoft Teams on **30 September 2026** from 8:00 a.m. to 10:00 a.m. EDT (GMT-4) and will be conducted in English only.
