INTRODUCTION

- 1. This report has been prepared pursuant to decision III/24 of the Conference of the Parties, which requested the Executive Secretary to prepare a quarterly report on the administration of the Convention including such matters as the staff list, status of contributions, progress on the implementation of the medium term work programme and financial expenditure report. The requirements to report on a regular basis to the Parties were further elaborated under the Administrative Arrangements between the Secretariat and UNEP, which were endorsed by the Conference of the Parties in decision IV/17.
- 2. The Executive Secretary has therefore, prepared the 46th edition of the Quarterly Report which contains a summary of key activities in implementing the decisions of the Conference of the Parties and other relevant matters during the period 1 July to 30 September 2009.

I. OFFICE OF THE EXECUTIVE SECRETARY

MEETINGS

- 3. The Secretariat organized the following meetings:
- 4. A South-South exchange meeting on the conservation and sustainable use of forest biodiversity on 8-10 July 2009 at the CBD Secretariat, to enhance capacity within and foster exchange between regional organizations for a more effective and efficient implementation of tools and approaches linked to instruments of international forest-related agreements, consequently providing supporting sustainable forest management and poverty alleviation efforts at national level.
- 5. Consultations with the Canadian authorities on the International Year of Biodiversity on 18 August 2009 at the CBD Secretariat. The meeting identified ways and means on how the Canadian authorities can maximize their efforts to help raise awareness and galvanize political will for 2010 and beyond.
- 6. The fifth meeting of the COP Bureau on 9-10 July 2009 in Strömstad, Sweden. The Bureau members discussed: the availability of financial resources for the implementation of COP 9 decisions, revision of the Strategic Plan of the Convention on Biological Diversity, update on The Economics of Ecosystems and Biodiversity study, contribution to the UNFCCC COP 15, preparations for GBO-3, the 2010 International Year of Biodiversity and the high level event on biodiversity during the 65th session of the U.N. General Assembly, among other issues.
- 7. Informal brainstorming session on business and biodiversity held on14-15 September 2009 at the CBD Secretariat. The meeting was held with the participation of the representatives of the triple COP Presidency (Germany, Japan and Brazil) as well as the representative of Canada and Netherlands. The meeting was followed by an inter-agency meeting held by teleconference. Participants shared experiences and ideas, including initiatives undertaken, on promoting biodiversity and business globally, as well as proposed a roadmap for COP 10 on engaging business in the implementation of the Convention.
- 8. The Secretariat also organized the following meetings: expert workshop on the 2010 biodiversity indicators and post-2010 indicator development, organized with UNEP World Conservation Monitoring Centre (6-8 July 2009, Reading, U.K.); drafting committee meeting for the report of the second *ad hoc* technical expert group on biodiversity and climate change (20-24 July 2009, Cape Town, South Africa); sub-regional capacity-building workshop on forest biodiversity and climate change for South-and South East Asia (2-5 September 2009, Singapore City, Singapore); Africa regional training of trainers' workshop on the identification and documentation of living modified organisms under the Cartagena

Protocol on Biosafety (14-18 September 2009, Bamako, Mali); Regional Workshop on Ways and Means to Promote the Sustainable Production and Use of Biofuels (28-30 September 2009, Louveira, São Paulo, Brazil); Expert Workshop on Scientific and Technical Guidance on the use of Biogeographic Classification Systems and Identification of Marine Areas beyond national jurisdiction in need of protection (29 September-2 October 2009, Ottawa, Canada); and Cities and biodiversity meetings via teleconference (14 July and 9 September 2009).

MUSEUM OF NATURE AND CULTURE

- 9. The Secretariat received a gift the Director General of Environmental Protection Agency in Ethiopia, as a contribution to the CBD Museum of Nature and Culture. The beautiful artwork is a drawing on parchment of an endemic animal species, the Gelada Baboon, and an endemic plant species, *Lobelia rhynchopetallum*, from the Semien Mountains National Park, a world heritage site in Northern Ethiopia.
- 10. The Kuna People of Panama also contributed two beautiful patchworks, one depicting a man with animals and the other depicting ocean life, to the CBD museum.

REPRESENTATION

11. During the period of July and September 2009, the Secretariat took part and contributed to a number of important meetings that are of relevance to the objectives of the Convention on Biological Diversity and its Cartagena Protocol on Biosafety. Details can be seen in Annex I to this report.

MEMORANDA OF COOPERATION/UNDERSTANDING

Tourisme Montréal

12. A Memorandum of Understanding was signed with *Tourisme Montréal* with the purpose of establishing and maintaining a sound and lasting collaboration through information exchange in relation to planning and organizing meetings and conferences held in Montreal, with a view to achieving mutual goals and objectives.

UNEP-WCMC

13. On 3 September, an agreement to further strengthen cooperation was signed with UNEP World Conservation Monitoring Centre, in the margins of "The Biodiversity Debate" event at the Royal Geographical Society in London., U.K. The agreement identifies how UNEP-WCMC, through its technical and capacity building expertise, will support the Secretariat and Parties in the implementation of the objectives of the Convention on Biological Diversity, in particular, but not limited to, the decisions of COP 9.

United Nations World Tourism Organization

14. In the margins of the World Climate Change-3, a Memorandum of Cooperation was signed between the Secretariat and the United Nations World Tourism Organization (UNWTO). The agreement aims to enhance cooperation on issues related to biodiversity and tourism, in particular the sustainable planning and management of tourism activities in vulnerable terrestrial, marine and coastal ecosystems and habitats of major importance for biological diversity, as well as the socioeconomic and cultural impacts of tourism.

MEETINGS OF THE EXECUTIVE SECRETARY

- 15. During the third quarter of 2009, the Executive Secretary met with a number of senior staff and representatives from Parties, other Governments, organizations and institutions, with a view to further enhance cooperation as well as increase public awareness of the Convention on Biological Diversity and its Cartagena Protocol on Biosafety, its work and objectives.
- 16. The Secretariat welcomed the visit of the following Government representatives: the Director of Global Environment Division, International Cooperation Bureau at the Japanese Ministry of Foreign Affairs, and senior officials from the Consulate General of Japan in Montreal. The Chair and staff of UNEP-STAP also paid a visit to the Secretariat. Senior staff members from the *Tourisme Montréal* and Montreal International were at the Secretariat office, on the occasion of the signing of the agreement with *Tourisme Montréal*. The Airbus Senior Vice President for Public Affairs and Communications and Vice President for Communication Strategy and Strategic Programmes visited the Secretariat and delivered a presentation on Airbus and the environment. The Founding Chairman and staff of the International Economic Forum of the Americas also paid a visit to the Secretariat to discuss among other issues, preparations for IYB. The CBD Executive Secretary had an opportunity to meet the new Secretary General of ICAO in August 2009.
- 17. Representatives from organizations visited the Secretariat, including: the Deputy Director of IDDRI; FICSA President and General Secretary; the Canadian Environmental Network; ICIMOD Programme Manager for Ecosystem Services; the Business Events Sydney; the Alliance fro Zero Extinction; and American Bird Conservancy. The former Secretary General of ICAO also visited the Secretariat. Biologist and filmmaker Jean Lemire visited the Secretariat to discuss collaboration for IYB, and the Canada Research Chair in Ethnoecology and Biodiversity Conservation visited the Secretariat.
- 18. In July, the CBD Executive Secretary was invited to a reception hosted by the Ambassador of Japan in Ottawa, on the occasion of the State visit to Canada of Their Majesties the Emperor and the Empress of Japan. The special occasion provided a great privilege for the CBD Executive Secretary to be introduced to Their Majesties, and in which he seized the unique opportunity to express his deep appreciation to the Government of Japan for the support to the work of the Convention on Biological Diversity, in particular to hosting the biodiversity meetings in Nagoya in 2010. During the reception, the CBD Executive Secretary also had opportunity to meet: Mr. Yasuo Fukuda, former Japanese Prime Minister, Mr. Jean Chrétien, former Prime Minister of Canada, the Right Honourable Michaëlle Jean, Governor General of Canada, as well as with the Minister of Natural Resources and a number of Ambassadors accredited to Ottawa.
- 19. At the kind invitation from the Executive Director of the Second International Youth Symposium, the Secretariat took part in the Second International Youth Symposium for Biodiversity in Ottawa. The CBD Executive Secretary delivered remarks at the opening dinner event held on 4 July. Staff from CBD also delivered presentations on the Cartagena Protocol on Biosafety and on drafting and delivering an effective youth message. The youth symposium Board members will participate and present the outcome of the youth event, including the revised Youth Accord on Biodiversity, at the COP 10 meeting in October 2010.
- 20. In July, the CBD Executive Secretary attended Bioversity International's two-day planning meeting for the Diversity for Life Campaign, held at the Rockefeller Foundation's Bellagio Center. A presentation on "The International Year of Biodiversity: Opportunities and Plans" was made, and discussion was held with the Director General of Bioversity International on ways and means to ensure complementarity between the Diversity for Life Campaign and the IYB.

- 21. In August, at the kind invitation from the Government of Mexico, the CBD Executive Secretary attended the launch of the Fourth National Report of Mexico, with the participation of the Minister and Vice Minister of Environment and Natural Resources, senior Mexican authorities and other relevant partners. During their meeting, Mr. Djoghlaf had an opportunity to discuss with the Minister about preparations for the International Year of Biodiversity, in conjunction with the Latin American and the Caribbean Forum on Sustainable Development as well as UNFCCC 16 which will take place in Mexico. While in Mexico, meetings were held with the Minister of Environment of Mexico City and the General Director of Zoos and Wildlife in Mexico, the Executive Secretary, National Coordinator and staff of CONABIO, and President of CONANP.
- 22. The CBD Executive Secretary attended a special launch of Saint-Laurent's Urban Forestry Plan on 31 August, at the Saint-Laurent Borough Council room, with the participation of more than 50 guests. During the event, Alan DeSouza, Mayor of Saint-Laurent, announced the creation of the program «*Une naissance, un arbre*» (One Birth, One Tree), a tree-planting program that would see a tree being planted to mark the birth of a new baby to a Saint-Laurent family. This initiative makes Saint-Laurent the first Montreal borough to put biodiversity at the heart of its greening strategy.
- 23. The CBD Executive Secretary then travelled to Nairobi, Kenya to take part in the meeting of the International Commission on Land Use Change and Ecosystems, established by the Global Legislators Organisation for a Balanced Environment (GLOBE) International. The meeting, hosted by UNEP, discussed policies to conserve two critical ecosystems, tropical forests and marine fisheries, and redressed GLOBE's position on biofuels. The CBD Executive Secretary made a presentation on IYB, as well as on CBD work on forest biodiversity, including south-south cooperation; marine and coastal biodiversity; and biofuels. Discussions were held with the Chair of the UNEP Scientific and Technical Advisory Panel, as well as with the former Director of the Millennium Ecosystem Assessment.
- 24. During his mission in Nairobi, the CBD Executive Secretary had an opportunity to meet with the UNEP Executive Director and the Deputy Executive Director to discuss the International Year of Biodiversity and the UNEP Global Ministerial Environmental Forum to take place in Bali in 2010, and other relevant IYB events during 2010. Meetings were also held heads/representatives of UNEP Divisions, including the Director and staff of UNEP Division of the Global Environment Facility on the role of DGEF for the preparation of the Nagoya biodiversity meetings and the international regime on ABS. A meeting was also held with the UNEP Director for Africa to discuss ABS and support of Africa for the IYB 2010 during the 2010 FIFA World Cup. During his visit to UNEP headquarters, the CBD Executive showed his support by adding his stamp to UNEP's Seal the Deal campaign.
- 25. In September, the CBD Executive Secretary took part and delivered a lecture at an event entitled "The Biodiversity Debate: Engaging and educating children on biodiversity as the future guardians of our planet", an event on The Green Wave initiative, organized by Airbus and National Geographic. A lecture was also given by Joel Sartore, one of National Geographic's top photographers and Ambassador of Airbus for The Green Wave. The event, which gathered more than 200 participants, was held at the Royal Geographical Society in London, U.K. In the margins of the event, meetings were held with: Director of Communication for Airbus, Head of the environmental strategy of Rolls Royce, a representative of Airbus Corporation Foundation, to name a few.
- 26. At the kind invitation of the Swedish Environment Minister, the CBD Executive Secretary participated and delivered a statement at the opening of the High level Conference under the theme: Visions for biodiversity beyond 2010 People, Ecosystem Services and the Climate Crisis, convened by the Government of Sweden, in its capacity as the EU President, on 7-9 September. Held at the city of Strömstad, the meeting discussed the economic valuation of biological diversity and ecosystem services, and future visions and goals for the Convention on Biological Diversity. Attended by more than 10 European ministers, the high level meeting provided an opportunity for the unveiling of the official logo for the International Year of Biodiversity. In the margins of the high-level meeting, the CBD Executive

Secretary had an opportunity to meet with the Ministers of Environment of Spain and Italy, senior officials of the Governments of Belgium, Norway and United Kingdom, and with staff from SIDA. While in Sweden, the CBD Executive Secretary attended the inauguration of the first transboundary marine protected areas, *Kosterhavet* (Sweden) and *Ytre Hvaler* (Norway), by His Majesty King Carl XVI Gustaf and His Royal Highness Crown Prince Haakon, and also delivered a statement at the Europarc Federation General Assembly, with the participation of about 200 participants at the occasion of the 100 anniversary of the establishment of the first protected area in Europe.

- 27. Also in September, at the kind invitation of the Chair of the Pan European Biological and Landscape Diversity Strategy (PEBLDS), the CBD Executive Secretary participated and delivered a statement at the opening of the fifth Biodiversity in Europe Conference in Liege, Belgium on 22 September. A meeting was held with PEBLDS Chair and UNEP's Regional Director on the revised PEBLDS and the Nagoya compact. A working dinner was held with the Norwegian delegation to discuss a number of relevant issues, including COP-10, as well meetings were also held with a number of partners attending the conference.
- 28. The CBD Executive Secretary attended and delivered a statement at the ministerial segment of the UNCCD COP 9 held in Buenos Aires, highlighting the joint CBD-CCD work programme, as well as the need to further enhance collaboration among the three Rio Conventions. The high level event provided an opportunity for the Secretariat to present to the participants the official logo of the 2010 International Year of Biodiversity. While in Buenos Aires, meetings were held with Ministers from Argentina and South Africa, with the head of delegation from Madagascar, Cote d'Ivoire, Algeria, and with the U.S. delegation on the U.S. ratification. The CBD Executive Secretary also met with the CEO/Chairperson of GEF, Director of the United Nations Forum on Forests and with the Director of UNEP-DELC, among other persons.
- 29. A number of media-related events took place during the third quarter of 2009. In April, the CBD Executive Secretary was interviewed by Radio des Nations Unies. In July, in the margins of the Bioversity International meeting at the Bellagio Center, the CBD Executive Secretary was interviewed by IPS news. While in Algeria, interviews were held with Algerian TV and the local newspaper Liberté, on the work of the Convention and IYB. In August, an interview was conducted by Features Editor of Nature on the successes and challenges of the 2010 biodiversity target. The CBD Executive Secretary was also interviewed by Argentina TV's "Recurso Natural", which focused on endangered species. In the margins of the biodiversity lecture at the Royal Geographical Society in London, several media events and interviews took place, including: radio interviews with Joel Sartore and Diana Mortimer, Head of Sustainability of the UK Joint Nature Conservation Committee, Minster FM, Juice 107.2, Seven FM, Six FM, Sunrise Radio, BBC Humberside, ManxRadio, Swansea Sound 1170MW, 106.1 Rock Radio, Heart Somerset, Heart North Devon Star 107.5 FM, and Sky News radio.
- 30. A press conference was held at the Secretariat of the Convention on Biological Diversity about a multi-media performance on the theme of biodiversity, to premiere 26 January 2010 at Place des Arts in Montreal as a contribution to the International Year of Biodiversity. Created by Jean Lemire (Mission Antarctica), Dominic Champagne (Cirque du Soleil's Beatles show, LOVE), and Daniel Bélanger (musician/singer/songwriter), the show will be one of the first major arts events contributing to the International Year of Biodiversity in 2010. The Secretariat is a partner and technical advisor to the performance. The press conference gathered the presence of major local TV and radio news stations, and relevant partners in Montreal.

IMPLEMENTATION OF THE ADMINISTRATIVE ARRANGEMENTS

a. Personnel Arrangements

- 31. During the period July September 2009, there were 29 Professional staff members regularized on posts approved under the Convention. There was one vacant post. Additionally, 5 professional staff members are regularized on posts funded from other sources.
- 32. Under the Convention there were 21 General Service staff members regularized on posts funded by the core budget. There were two (2) vacant posts. Additionally, 11 staff members are regularized on posts funded from other sources, 3 of which were formerly funded from the core budget.
- 33. During the period under review for the Biosafety Protocol there were 7 Professional staff members regularized on posts approved by the COP/MOP. There were 4 General Service staff members regularized on posts funded by the core budget.
- 34. For more information, please refer to the attached staff list and organigram (Annex II Appendix 1, and Annex III respectively).

b. Financial Arrangements

- 35. With regard to budgetary matters, as at 30 September 2009, of the total pledged contributions of US\$10,506,128 for 2009 to the General Trust Fund for the Convention on Biological Diversity (BY Trust Fund), the total contributions received amounted to US\$9,862,612 of which \$2,045,707 were 2009 pledges paid in 2008, and \$7,816,905 were pledges paid in 2009 for 2009 and future years. Details of the BY Trust Fund are contained in Annex VI.
- 36. Several Parties have contributed additional voluntary funds in support of approved activities under the Convention (BE Trust Fund). As of 30 September 2009, the total pledged for 2009 amounts to US\$2,643,878 of which \$1,761,637 has been received. Total unpaid pledges for 2009 and prior years to the BE Trust Fund is US\$1,139,267. Details of the BE Trust Fund are contained in Annex IV.
- 37. As at 30 September 2009, US\$337,528 has been pledged in 2009 as additional voluntary contributions to facilitate the participation of Parties to the Convention Process (BZ Trust Fund). To date, US\$273,589 has been received. Total unpaid pledges for 2009 and prior years, to the BZ Trust Fund, amount to US\$186,285. Details of the BZ Trust Fund are contained in Annex V.
- 38. As at 30 September 2009, of the total pledged contributions of US\$1,959,191 for 2009 to the General Trust Fund for the Core Programme Budget for the Biosafety Protocol (BG Trust Fund), total contributions received is US\$1,777,164, of which US\$831,158 was received in advance of 2009 and US\$946,006 has been received in 2009 for 2009 and future years. Details of the BG Trust Fund are contained in Annex VII.
- 39. As at 30 September 2009, six Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Additional Voluntary Contributions in support of Approved Activities of the Cartagena Protocol on Biosafety, (BH Trust Fund). To date US\$305,833 has been received in 2009 for 2009 and future years. Details of the BH Trust Fund are contained in Annex VIII.
- 40. As at 30 September 2009, no Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Facilitating Participation of Developing Country Parties in the Cartagena Protocol on

Biosafety, (BI Trust Fund). Total unpaid pledges for prior years, to the BI Trust Fund, amounts to US\$11,813. Details of the BI Trust Fund are contained in Annex IX.

41. As at 30 September 2009, two pledges have been received for the General Trust Fund for Voluntary Contributions to Facilitate the Participation of Indigenous and Local Communities in the Work of the Convention on Biological Diversity (VB Trust Fund) in 2009. Norway pledged contribution of NOK 250,000 and Denmark pledged contribution of DKK 600,000 have been received. Details of the VB Trust Fund are contained in Annex X.

II. IMPLEMENTATION OF THE DECISIONS OF THE CONFERENCE OF THE PARTIES

SCIENTIFIC, TECHNICAL AND TECHNOLOGICAL MATTERS

Decisions VIII/23, IX/1 and IX/2: Agricultural Biological Diversity and Biofuels and Biodiversity

- 42. In response to decisions VIII/23, IX/1 and IX/2 the Secretariat carried out the following activities:
 - a. Drafted a section on the Soil Biodiversity Initiative for the forthcoming Soil Biodiversity Atlas of Europe in collaboration with the European Commission;
 - b. A member of the Secretariat attended the2nd Joint International Workshop on Bioenergy, Biodiversity Mapping and Degraded Lands, 7-8 July, Paris.
- 43. In response to decision IX/2, the Secretariat:
 - a. Completed preparations for regional workshop on ways and means to promoted the sustainable production and use of biofuels for Latin America and the Caribbean to be held from 28 to 30 September 2009 in Louveira, São Paulo, Brazil.
 - b. Briefed the Permanent Delegation of Brazil to the International Civil Aviation Organization about the workshop.
 - c. Prepared notifications 2009-116 and 2009-117, inviting Parties from Africa and Asia and the Pacific to nominate experts for the regional workshops tentatively scheduled for 15-17 November 2009 in Accra, Ghana, and 25-27 November 2009 in Bangkok, Thailand.
 - d. Posted additional information on biofuels and biodiversity, including references to the submissions received, on the CBD website.

Decisions IX/3, VII/9 and VII/31: Global Strategy for Plant Conservation

- 44. In response to decisions IX/3, VII/9 and VII/31 the Secretariat:
 - a. Completed translation, editing and layout of the Arabic, Chinese, French, Russian and Spanish versions of the Plant Conservation Report and made it available from http://www.cbd.int/programmes/outreach/awareness/publications.shtml?grp=xc.
 - b. Arranged for printed versions of the Plant Conservation Report in Arabic, Chinese, French, Russian and Spanish and began dissemination.

Decision IX/4: Invasive Alien Species

- 45. In response to decisions XI/4 the Secretariat:
 - a. Submit an article to address the issue of invasive alien species and the roles of international organisations to OIE Scientific and Technical Review.
 - b. Submit an article to "Aliens", a newsletter of IUCN Species Survival Commission to address the issue of invasive alien species.

Decision VII/27: Mountain Biological Diversity

- 46. In response to decision VII/27, the Secretariat carried out the following activities:
 - a. Interacted extensively with the Global Mountain Biodiversity Assessment, Coordinator, Mountain Partnership and the Mountain Forum secretariats, the International Centre for Integrated Mountain Development (ICIMOD), Mountain Research Initiative, other relevant organizations, experts and other related Conventions for preparing the in-depth review of the implementation of the programme of work on mountain biological diversity by SBSTTA-14 and COP-10.
 - b. After analyzing 96 third national reports, 15 voluntary reports received on implementation of mountain biological diversity programme of work, identified the key obstacles and challenges in implementing the programme of work. In collaboration with the Mountain Forum Secretariat an online survey was conducted seeking inputs on ways and means to address the identified obstacles including case studies and best practices.
 - c. Held meetings with officials of the ICIMOD on future collaboration in implementing mountain biological diversity programme of work.
 - d. The first draft of the background document on the in-depth review of the implementation of the programme of work on mountain biological diversity by SBSTTA-14 is completed.

Decisions VI/22 and IX/5: Forest Biodiversity

- 47. In response to requests in decisions VI/22 and IX/5, the Secretariat carried out the following activities:
 - a. The Secretariat participated in a Strategic Dialogue meeting of the Collaborative Partnership on Forests (CPF) in Rome, 2-3 July 2009. Discussion points were, amongst others, the development of an outline for joint CPF activities over the coming 2-3 years, as well as the identification of joint activities (including communication activities) at the fifteenth meeting of the Conference of the Parties (COP-15) to the UNFCCC. It was suggested the ABS in relation to the forest sector could be a theme for joint activities, such as capacity building, pending the outcome of COP-10. The Secretariat will be involved in joint CPF activities at UNFCCC COP-15, notably the preparation of Forest Day 3, where the Secretariat will co-host a learning event on "Forest Biodiversity and Climate Change" on 13 December 2009.
 - b. The Secretariat convened a meeting on South-South Cooperation in the field of forest biodiversity from 8-10 July 2009 in Montreal, Canada. The objective of the meeting was twofold: to foster South-South Cooperation amongst the major tropical forest regions, and to build capacity on pertinent issues, notably reducing emissions from deforestation and forest

degradation (REDD), Payments for Ecosystem Services (PES), and Access and Benefit Sharing (ABS). Participants included delegates from the Secretariats of the Central Africa Forest Commission (COMIFAC), the Association of Southeast Asian Nations (ASEAN) and the Amazon Cooperation Treaty Organization (ACTO), as well as observers from the UN REDD Programme, ITTO, La Francophonie, and the UNFF. Representatives from the regional organizations decided at the meeting to engage in further collaboration and agreed on a set of specific ways and means.

- c. The Secretariat, in collaboration with the UNFF and the National Parks Board of Singapore, and with generous financial support from the government of Germany and the ASEAN Center for Biodiversity (ACB), organized a sub-regional capacity building workshop for Southern and South-Eastern Asia in Singapore City, Singapore, 2-5 September 2009. The workshop aimed at building capacity for improved national and regional collaboration between relevant government actors in the field of forest biodiversity and climate change, including REDD, and climate change adaptation. 50 participants from 13 countries attended the workshop, which was also supported through in-kind contributions in the form of expertise and staff time from members of the Collaborative Partnership on Forests, notably the UN REDD Programme (FAO, UNEP, UNDP), IUCN, ITTO, CIFOR, IUFRO, as well as the Swiss Development Cooperation (Intercooperation).
- d. The Secretariat published a 'Good Practice Guide' entitled Sustainable Forest Management (SFM), Biodiversity and Livelihoods. This is part of a series of similar documents for a range of CBD thematic areas and the relevant economic sectors (tourism, fisheries, forestry, water) initiated by the CBD Biodiversity and Development Unit in collaboration with relevant programme officers. The document is available in English, electronically and in hard copy.
- e. The Secretariat published the Spanish language version of Technical Series 33 'Conservation and Sustainable Use of Wildlife-based Resources: The Bushmeat Crisis'. The document is available electronically and in hard copy.
- f. The Secretariat published, jointly with the German Technical Cooperation (GTZ), a guide on biodiversity and livelihood benefits of efforts to reduce emissions from deforestation and forest degradation (REDD). The document is available in English, electronically and in hard copy.

Decision IX/7: Ecosystem Approach

48. In response to decision IX/7 paragraph 5(a), the Secretariat prepared and disseminated the September 2009 issue of the Ecosystem Approach e-Newsletter, which is being issued on quarterly basis, to CBD national focal points, SBSTTA focal points, and other relevant organizations and experts. In particular, for the publication of September issue, the Secretariat collaborated with experts of GEF/LME projects.

Decision IX/10: Preparation of the Third Edition of the Global Biodiversity Outlook

- 49. In response to decision IX/10 the Secretariat:
 - a. Completed the first draft of the third edition of the Global Biodiversity Outlook (GBO-3) and invited Parties and other stakeholders to peer review the report (www.cbd.int/gbo3review).
 - b. Began compiling/analyzing comments received as part of the peer review process of GBO-3.

- c. Began revising the second draft of GBO-3 in light of the comments received.
- d. Sent reminders about the deadline for the peer review and encouraged Parties and stakeholders to participate in the process (689 downloads as of 24 September 2009).
- e. Continued to analyse fourth national reports with regard to information and data relevant to GBO-3.
- f. Continued to gather published scientific information for possible use in GBO-3.
- g. Participated in the Expert Workshop on the 2010 Biodiversity Indicators and Post-2010 Indicator Development (Reading, UK, 6-8 July 2009).
- h. Participated in the partners' meeting of the 2010 Biodiversity Indicators Partnership (Cambridge, UK, 10 July 2009).
- i. Selected suppliers for preparation of the design and layout of GBO-3 as well as for the adaptation into the other five official languages of the United Nations and selected a science writer for the revision and preparation of summaries and targeted products.
- j. Prepared a substantive progress report about the first year of the European Commission project to support GBO-3.
- k. Prepared and discussed a proposal to the Government of Japan to contribute to the preparation of GBO-3 in line with the pledge reflected in decision IX/24.
- 1. Briefed representatives from Japan, GEF-STAP, Alliance for Zero Extinction and others about progress in the preparation of GBO-3.
- m. Liaised with UNEP-WCMC to ensure that the latest scientific information is being made available for GBO-3
- n. Initiated preparations for a meeting to review the scientific content of GBO-3 (4-5 November 2009) which would make recommendations to the meetings of the SBSTTA and joint COP/SBSTTA Bureaux meetings on 6-7 November 2009;
- o. Continued to update the web pages on GBO-3.

Decision IX/15: Follow-up to the Millennium Ecosystem Assessment

- 50. In response to decision IX/15 the Secretariat:
 - a. Participated in a meeting of the Consultative Group for the second Ad hoc Intergovernmental and Multi-Stakeholder Meeting on an Intergovernmental Science-Policy Platform on Biodiversity and Ecosystems Services (IPBES), held in London on 9 July 2009.
 - b. Reviewed a manuscript on the Group on Earth Observations-Biodiversity Observation Network (GEO-BON), as a contribution to a special issue of Ecological Research on CBD 2010.
 - c. Contributed to the study on biodiversity futures prepared by DIVERSITAS-International and UNEP-WCMC, which reviews models, scenarios and assessments, including those carried out in follow-up to the MA, for GBO-3.

Decision IX/16: Biodiversity and Climate Change

- 51. In response to decision IX/16, the Secretariat:
 - a. Held a drafting committee meeting for the second Ad hoc Technical Expert Group on Biodiversity and Climate Change from 20 to 24 July 2009 in Cape Town, South Africa.
 - b. Submitted the draft report of the second Ad hoc Technical Expert Group on Biodiversity and Climate Change to the Bureau of the Conference of the Parties which approved it for publication as a Technical Series.
 - c. Conducted a peer review of the literature review on the links between biodiversity and climate change mitigation and adaptation.

Decision IX/17: Biological Diversity of Dry and Sub-Humid Lands

- 52. In response to decision IX/17, the Secretariat:
 - a. Completed a toolkit on Pastoralism, Nature Conservation and Development.
 - b. Carried out a study on biodiversity, soil conservation, pastoralism and climate change mitigation.
 - c. Provided input into the EMG issue management group on land degradation.
 - d. Participated in the high level panel of the ninth session of the Conference of the Parties to the United Nations Convention to Combat Desertification.

Decisions VII/28, VIII/24 and IX/18: Protected Areas

- 53. In response to requests in decisions VII/28, VIII/24 and IX/18, the Secretariat carried out the following activities:
 - a. Examined and provided comments on the GEF 5 biodiversity strategy.
 - b. Developed a demo of a user-friendly and comprehensive website on protected areas and a framework for streamlined reporting process of on the implementation of the PoWPA.
 - c. Interacted extensively with Governments of India, Colombia, Cote d'Ivoire, as well as the German Federal Agency for Nature Conservation, regarding organizing the regional capacity-building and review workshops on the implementation of PoWPA in Asia & Pacific, Africa, and GRULAC and CEE regions in October-November 2009.
 - d. Processed the funding letters and visa and other logistical assistance for the Africa, Asia and Pacific other GRULAC workshops. Issued notification seeking nominations of country representatives for the CEE workshop.
 - e. Interacted with IUCN-WCPA on the preparations and next steps for the in -depth review of the Programme of work on protected areas by SBSTTA 14 including the PoWPA futures workshop in Jeju and prepared a background paper on the implementation of the programme of work.
 - f. The first draft of the background document on the in-depth review of the implementation of the programme of work on protected areas by SBSTTA-14 is completed.

/...

g. The LifeWeb coordinator participated in the Jeju workshop on PoWPA Future and held discussions with Japan and South Korea Governments on their possible participation in LifeWeb. The website of the LifeWeb initiative was revised with information and applications for expression of interest, donor and country information. Discussions were held with the Government of Finland on the possible matches under the LifeWeb.

Decisions VII/4, VIII/20 and IX/19: Biological Diversity of Inland Waters

- 54. In response to decisions VII/4, VIII/20 and IX/19, the Secretariat carried out the following activities:
 - a. Completed further key sections of background information for the in-depth review to be undertaken at SBSTTA-14, including a comprehensive summary of indirect drivers of change related to water use and trends, climate change and inland waters, responses and an executive summary.
 - b. Drafted a toolkit on drinking water, biodiversity and poverty alleviation (as part of the CBD toolkit series on Biodiversity and Development).
 - c. Contributed to the UN-Water drafting group preparing a statement and briefing note on Water and Climate Change for UNFCCC COP-15.
 - d. A member of the Secretariat attended the Stockholm International Water Week, Sweden (16-22 August) where the following meetings were also held: the UN-Water senior programme managers meeting (15-16 August); the UN-Water task forces on monitoring, reporting and indicators (20 August), climate change (17 August) and liaison meetings for the development of the fourth World Water Assessment Report (14 and 20 August); with the Ramsar Secretariat (17 August) to discuss implementation of the Joint Work Programme and inputs into the indepth review.

Decision IX/20: Marine and Coastal Biological Diversity

- 55. In response to decision IX/20, the Secretariat:
 - a. The Secretariat reviewed the first draft report submitted by the consultant who was commissioned, with a fund provided by the Government of Spain and UNEP, for compiling and synthesizing relevant scientific information on the impacts of destructive fishing practices, unsustainable fishing, and illegal, unreported and unregulated (IUU) fishing on marine biodiversity and habitats. The Secretariat also reviewed the first draft report provided by a consultant hired by FAO for compiling and synthesizing relevant scientific information on impacts of destructive fishing practices (para 2 of decision IX/20).
 - b. The Secretariat attended "FAO/UNEP Expert Meeting on Impacts on Destructive Fishing Practices, Unsustainable Fishing and IUU Fishing on Marine Biodiversity", which was organized by FAO and UNEP in collaboration with the Secretariat from 23 to 25 September 2009 in FAO Headquarter, Rome, Italy, to provide inputs in response to the request made by COP 9 in decision IX/20, paragraph 2.
 - c. The Secretariat circulated for peer-review a revised draft report, submitted by UNEP-WCMC, on compiling and synthesizing relevant scientific information on potential impacts of direct human-induced ocean fertilization on marine biodiversity (para 3 of decision IX/20) to Parties, other Governments and relevant organization (Notification Ref. 2009-082).

- d. The Secretariat circulated for peer-review a revised draft report, submitted by UNEP-WCMC, on compiling and synthesizing relevant scientific information on potential impacts of ocean acidification on marine biodiversity (para 4 of decision IX/20) to Parties, other Governments and relevant organization (Notification Ref. 2009-092). The Secretariat attended the UN Expert Panel on Ocean Acidification, which was organized by UN Division of Sustainable Development, held in UN Headquarter on 3 September.
- e. The Secretariat, in consultation with the COP Bureau, finalized the selection of experts to attend the expert workshop on scientific and technical aspects relevant to environmental impact assessment in marine areas beyond national jurisdiction, to be held in Manila, Philippines, from 18 to 20 November 2009 (para 10 of decision IX/20). The Secretariat issued invitation letters to selected experts and initiated communication with the Government of Philippines and PEMSEA regarding the logistics arrangements for the said workshop.
- f. The Secretariat compiled and uploaded on the CBD website relevant meeting documents and information submitted by Parties and relevant organizations for the expert workshop on scientific and technical guidance on the use of biogeographic classification systems and identification of marine areas beyond national jurisdiction in need of protection (Ottawa, Canada, 29 September 2 October, 2009). The Secretariat finalized logistic and travel arrangements for the expert workshop, in coordination with the hosting government.
- g. The Secretariat circulated for peer-review the revised draft report, submitted by a consultant, on the implementation of programme of work on marine and coastal biodiversity, to Parties, other Governments and relevant organization (Notification Ref. 2009-099).
- h. The Secretariat compiled necessary information for the project on Biodiversity for Development: good practice toolkit on sustainable fisheries, in collaboration with experts of FAO, UNEP, IUCN, International Collective in Support of Fishworkers (ICSF), and other relevant experts.

Decision VIII/3 and IX/22: Global Taxonomy Initiative

- 56. In response to decisions VIII/3 and IX/22 the Secretariat:
 - a. Interacted with BioNET INTERNATIONAL and Global Invasive Species Programme to organise a project development seminar for African region with particular interests in invasive alien species management in protected areas, which will take place in Nairobi, Kenya in November 2009.
 - b. Interacted with Consortium for Barcode of Life to prepare for a project writing seminar in the margins of the 3rd International Conference for Barcode of Life in Mexico City, Mexico.

Decision IX/27: Cooperation among Multilateral Environmental Agreements and other Organizations

- 57. In accordance with the provisions of decision IX/27 the Secretariat:
 - Organized and prepared the third meeting of the Chairs of Scientific Advisory Bodies of Biodiversity-related Conventions (Nairobi, 4 October 2009).

Decision IX/29: Operations of the Convention

- 58. In accordance with the provisions on the process for identifying new and emerging issues relating to the conservation and sustainable use of biological diversity the Secretariat:
 - Updated the web page on emerging issues by adding the new proposals received in response to the notification 2008/159 at http://www.cbd.int/convention/emerging.shtml.

SOCIAL ECONOMIC AND LEGAL MATTERS

Decision IX/6: Incentive measures

- 59. In the period under review, the Secretariat finalized preparations for the international expert workshop on the removal and mitigation of perverse, and the promotion of positive, incentive measures, as requested in paragraph 6 of decision IX/6, including the preparation of documentation, travel and funding arrangements for eligible participants, and organizational arrangements with the host. The meeting will take place on 6-8 October 2009 in Paris, France, and will be hosted by the Division for Technology, Industry and Economics (DTIE) of the United Nations Environment Programme
- 60. The Secretariat participated in the OECD workshop on innovative international financing for biodiversity conservation and sustainable use on 2 July 2009. The Secretariat informed participants on the work under the CBD on innovative financial mechanisms, and drew their attention to the upcoming CBD workshop on the topic early next year as entry point for feeding work results into the CBD process, also in the context of the work on the revision of the strategic plan.
- 61. The Secretariat participated in the 24th regular meeting of the OECD Working Group on Economic Aspects of Biodiversity (WGEAB) on 3 July 2009, with a view to contribute to the review of work currently under way and encourage alignment of current OECD work with relevant work programmes under the Convention.

Decision IX/12: Access to genetic resources and benefit-sharing

- 62. In the period under review, the Secretariat:
 - a. Carried out preparations for the eighth meeting of the Working Group on ABS, to be held in Montreal, from 9 to 15 November 2009, including logistical arrangements and preparation of documentation.
 - b. Participated in the South-South-Exchange Meeting on the Conservation and Sustainable Use of Forest Biodiversity, held from 8 to 10 July 2009, in Montreal, Canada, which included a technical session on access and benefit-sharing.
 - c. Participated in the ASEAN Regional Workshop on ABS (26-28 August, Siem Reap, Cambodia) organised by the ASEAN Centre for Biodiversity and hosted by Cambodia.
 - d. Participated in a preparatory meeting, held on 23 September 2009, in Eschborn, Germany, for the African Minister's Conference on ABS to be held in March 2010.

Decision IX/13: Article 8(j) and Related Provisions

63. In the period under review, the Secretariat continued the logistical preparations for the sixth meeting of the Working Group on Article 8(j) and related provisions and finalized the documentation for the meeting. The preparations included amongst other tasks, completing the notification process and

selecting twenty-seven indigenous and local community representatives to receive travel grants from the voluntary fund for indigenous and local community participation to participate in the 6th meeting of the Working Group on Article 8(j) and/or the 8th meeting of the Working Group on ABS. As well as this, the Secretariat has planned for and completed the selection process for indigenous and local community representatives to the LAC regional Capacity Building Workshop to be held on the eve of the sixth meeting of the Working Group on Article 8(j). Twenty indigenous and local community representatives will be funded to participate.

64. Also during this period the Secretariat prepared for and participated in the annual meeting of the Inter-Agency Support Group on indigenous peoples' issues annual meeting in Nairobi 28-30 September, as well as planning in partnership with relevant agencies and the Tebtebba Foundation, a technical workshop on indicators on indigenous peoples' well-being and sustainable development, focusing on traditional knowledge and status and trends in changing land use (1-3 October 2009, Nairobi). The report of which will be made available for the 6th meeting of the Working Group on Article 8(j).

Decision VIII/14: Biological Diversity and Tourism

- 65. The Secretariat has invited Parties to nominate participants to the third workshop of the series on indigenous tourism, biodiversity and new web-based technologies, organized in partnership with the Government of Ecuador and funding from the Government of Spain, which is planned to take place in Ecuador in December 2009, and will focus on Latin American and the Caribbean (LAC) forest ecosystems. As for the first and second workshops, the LAC workshop aims to support the management of biodiversity-friendly tourism activities, the web-based capacity of indigenous tourism operators, and the marketing of the culturally and biologically sustainable aspects of indigenous tourism products.
- 66. The Secretariat received a grant from the Heidehof Foundation to support the development and delivery of the Indigenous Tourism and Biodiversity Website Award- Second Version 2010. The award is aimed at private tourism services, owned and operated by indigenous people and/or traditional communities, and its main objectives are: to motivate candidates to improve their online communication on biological and cultural diversity; to highlight their best practices in managing tourism in a biodiversity-friendly way and raise tourism operators and public's awareness on biodiversity. The award will be launched in the fall of 2009 and the winners will be announced in April 2010 at a major trade fair on sustainable tourism in Germany.
- 67. From September 20 to 24, 2009, the Secretariat participated in the 6th Brazilian Congress on Protected Areas in Curitiba, Brazil, with the support of the Brazilian Ministry of Environment and Fundação Boticario, where 1,200 professionals from government, the private sector and NGOs, from 27 countries, discussed the status and trends of the implementation of the programme of work on protected areas in South America and Brazil. The Secretariat contributed a paper on carbon emission offsets from tourism to benefit parks (a copy is available here: http://www.cbd.int/tourism/wstour-01.shtml), and participated in a technical session on tourism concessions in protected areas with the objective of preparing a reference publication on the subject. Colorado State University specialists will collaborate with several leading NGOs and the Secretariat to request resources from USAID for research support and dissemination, and the resulting publication will be distributed through UNESCO, IUCN's World Commission on Protected Areas and the CBD.

Decision IX/14: Technology Transfer and Cooperation

68. The Secretariat finalized the first version of a document on the proposed Biodiversity Technology Initiative for consultation with relevant organizations, as requested by the decision. The document will be reviewed by the third meeting of the Working Group on Review of Implementation of the Convention and considered further by the Conference of the Parties at its tenth meeting.

OUTREACH AND MAJOR GROUPS

Children and Youth / Non-governmental organizations

- 69. The Secretariat participated in the UNEP Tunza International Conference on the Environment for Children and Youth held in Daejeon, Republic of Korea from 17 23 August 2009, delivering a keynote speech on climate change and biodiversity and side-events to participants on the International Year of Biodiversity and *The Green Wave* initiative.
- 70. A meeting was held with members of the Canadian Environmental Network (RCEN) on 3 July 2009 to present, discuss and explore collaboration and active involvement of the RCEN on the International Year of Biodiversity and The Green Wave initiative.
- 71. Further effort was taken during the reporting period to establish *The Green Wave* initiative as a strong network and communication mechanism on biodiversity for children and youth, including the following initiatives undertaken in the framework of partnership established with Airbus and National Geographic: The Biodiversity Debate held at the Royal Geographical Society, London, UK on 3 September 2009 with keynote presentation by the Executive Secretary on engaging and educating children on biodiversity as the future guardians of our planet, and with associated media interviews gaining strong coverage in the UK; international children's photo competition on biodiversity run through National Geographic global publishing networks (closing 8 September 2009 and with winners to be announced in the fourth quarter 2009); and identification of potential partnerships in India for biodiversity project support from the Airbus Corporate Foundation.

Biodiversity for Development Initiative

A. UNDP-SCBD MOU on mainstreaming biodiversity in development

72. In the context of the UNDP and CBD MOU on mainstreaming biodiversity into development, the main quarterly results for the period July-September 2009 are the following:

Environment Mainstreaming in Development Initiative

73. The Senior Program Officer is leading discussions on scoping and planning of the IIED-UNDP-UNEP-CBD-OECD- partnership. Current focus is on moving the idea and group work from an environmental mainstreaming sourcebook to a focus on sorting out and pooling of different guidance, establishing in-country learning systems and adopting global policy and guidance for donors. This involves effective integration with the work of the OECD task team on Governance and Capacity Development for Natural Resource and Environmental Management. Key milestones were the London June 19 planning meeting, revised concept and proposal of June 30 and the OECD task team meeting of September 24-25.

Biodiversity for Development and Poverty Alleviation IDB and IYB booklet

74. The annotated outline was revised following comments received. A first draft was prepared for this awareness and advocacy booklet for the IYD/IYB Advancement needs to be accelerated with research and editing assistance, planned but so far not materialized.

Biodiversity and Local Development Initiative

75. Initial product of photo stories of community level experiences with biodiversity dependent development processes was scoped and initiated with GEF-SGP and Equator Initiative. Exchanges were continued with the Japanese government on collaboration on Satoyama International Initiative.

Biodiversity in Development Cooperation

76. Plans were refined and exchanges were held with SIDA and SwedBio to coordinate and share implementation responsibilities for follow up activities agreed to by the network expert meeting on mainstreaming biodiversity in Development Cooperation. Discussions were held with OECD secretariat on options for a follow up meeting and donor forum in COP 10 Nagoya.

Proposal for collaborative UNDP SCBD activities and resource mobilization

77. A proposal was prepared on biodiversity and climate change, as part of SCBD proposal for secondment SCBD.

Collaboration on UNDP Human Development Report 2010

78. The UNDP HDR 2010 Anniversary Issues will be tackling the issue of how to integrate environmental sustainability and biodiversity in the concept, policy discussions and implementation Exchanges and initial inputs to research team for purpose of outline and planning research inputs.

UNDP plan of activities for IYB

79. UNDP IYB plans were finalized in collaboration with UNDP colleagues and communications to SCBD prepared.

Communication to UNDP Country offices on SCBD activities

80. A call for peer review of the GBO 3, Biodiversity and Development newsletter and the report on the expert meeting on mainstreaming biodiversity in development cooperation were circulated on the UNDP networks for environment and energy and poverty reduction involving Country offices, regional and global groups. Article was prepared on the key messages of the AHTEG report on connecting climate change and biodiversity. The article is to be published on the networks early October as soon as full report is available online. A feature article is in preparation on the CBD Programme of Work on Protected Areas to be circulated to UNDP networks in October.

Connecting UNDP and SCBD teams

81. Arrangements were made for SCBD REDD team to join UN REDD internal workspaces to improve communications and exchange and facilitate joint activities; connecting DDC technical team to dry land work of CBD to collaborate on SBSTTA documents and potential side events. In the context of the UNDP LAC Initiative on the economics of biodiversity and ecosystem services, facilitated the collection of case studies on the economics of biodiversity, from CBD focal points and other key actors.

GBO-3

82. Comments and substantive inputs provided on the first draft messaging analysis and case examples circulated to networks for peer review.

83. Representation and substantive input to WCPA–IUCN organized workshop on the future of the CBD programme of work on Protected Areas hosted by the Korea National Parks.

Contributing to SCBD preparations for COP 10 and related initiatives

84. Comments and suggestions provided to different preparatory work and activities in particular those of the Biodiversity for Development and Poverty Alleviation Initiative activities as well as the Business and Development, WGRI and SBSTTA preparation work. Prepared the tourism input and led program preparation for IAIA 2010 conference on Transitioning to a Green Economy.

B. German Financial Resources Management

- 85. During the third quarter 2009, the following activities were undertaken:
 - a. Elaboration of a tool kit on biodiversity mainstreaming for stakeholders involved in multi and cross-sectoral planning and finance processes (including Poverty Reduction Strategies) at the national level. The tool kit targets essentially mid level officers from Planning and Finance Ministries and provides a conceptual frame as well as a technical overview on how to incorporate through an ecosystems goods and services approach biodiversity considerations into responsible and informed decision making. The tool will show the importance of ecosystem services as indispensable assets for sustainable development and poverty reduction. Shifting from a traditional re-active and do-no harm approach to a pro-active investment vision, the tool aims to overcome remaining doubts and skill gaps to definitely incorporate biodiversity into development planning processes.
 - b. As a first step to elaborate an umbrella framework linking the planning cycle and the implementation of the CBD better to development and poverty reduction processes, an agreement in form of a consultancy was established with UNEP/WCMC. The work starts with an analysis on to which extent socio-economic and poverty considerations are already integrated in each of the seven thematic Programmes of Work. Based on this analysis and detected gaps a proposal for a better and coherent integration of poverty and socio- economical issues within each thematic Programme of Work will be formulated. The results will be presented in form of individual desired matrices for each Programme of Work. A synthesis of common tasks and challenges for all the Programmes of Work will provide substantial contributions for the umbrella framework and the new Strategic Plan beyond 2010.
 - c. Outlines of a technical series entitled "Interdependence between biodiversity and development under global change" were defined. The technical series will include several disciplinary and trans-disciplinary scientific manuscripts showing the actual best available knowledge on the main global challenges related to human survival and options to prevent dangerous tipping points resulting from biodiversity loss, ecosystem degradation and climate change. After calling for contributions through the CBD-web a significant amount of submissions and letter of interest were received for each of the chapters. The recruiting process will be finalized in October 2009.
 - d. In the context of concrete initiatives with regional organizations, collaboration starts with the Southern African Development Community (SADC FANR). The purpose of this additional initiative with SADC is to catalyze actions aiming to reinforce the implementation of its Regional Biodiversity Strategies. Additional to the NBSAPs more and more countries work at the regional level on biodiversity issues as part of common

trans-boundary challenges and regional integration processes. The collaboration with SADC consist in gathering good practices and lessons learned from member states in order to identify replicable experiences and establish a common trans-boundary portfolio for priority interventions in the region. Based on this work and an additional contribution from IUCN-Pretoria, SADC will be able to operationalize its biodiversity strategy through the formulation of an regional action plan and elaborate projects proposals for fund rising. A consultant was hired and will start his work in October.

- e. During a mission to Peru and Ecuador in July a common work plan with the Peruvian Ministry of Environment and the General Secretary of the Andean Community of Nations (SGCAN) were defined. The Peruvian Ministry is interested to be involved in the whole SCBD Biodiversity for Development Initiative in order to contribute Peru's experiences into the planned guidance and mainstreaming activities, including the review of the strategic plan. For this purpose the Ministry seconded an experienced Officer to the SCBD, who will work on the agreed issues during the next weeks. The Andean Community expressed interest to collaborate with the SCBD to better link its regional biodiversity program with poverty reduction in the region.
- f. During a second mission to Germany in September the Programme Officer attended an international workshop at the Isle of Vilm hosted by the German Agency for Nature Conservation (BfN). The workshop was dedicated to analyze the actual CBD Strategic Plan and 2010 Target in order to identify gaps regarding its linkages to poverty reduction and development. The Programme Officer presented the working approach to better integrate poverty and development issues into the CBD planning cycle. The workshop came up with concrete recommendations on how to better link the new strategic plan and the post 2010 framework to poverty reduction and development. Specific goals and indicators incorporating an equitable access to vital ecosystem services for all the segments of the society, transparency and good environmental governance as well as a clear international commitment for cooperation and capacity building on the interfaces between biodiversity conservation climate change poverty reduction development are the central recommendations.

Decision IX/26: Promoting Business Engagement

- 86. A two-day informal brainstorming meeting was held at the CBD Secretariat on 14-15 September 2009 with a view to advancing the decisions VIII/17 and IX/26 of the Conference of the Parties to the CBD on engagement with the private sector. The meeting was convened under the four year Letter of Intent between the Netherlands and the Secretariat with a view of coordinating the ongoing initiative on business and biodiversity undertaken in the context of the implementation of the Convention.
- 87. The meeting was held with the participation of the current, previous and future COP Presidencies (respectively Germany, Brazil and Japan) and with the participation of Canada and the Netherlands.
- 88. Following governmental consultations, the group was joined by representatives of the business community (the World Business Council for Sustainable Development (WBCSD), the Nippon Keidanren Committee on Nature Conservation, the Canadian Business and Biodiversity Initiative, the Lasting Initiative for Earth (LIFE)), non-governmental organizations (International Union for Conservation of Nature (IUCN), Finance Alliance for Sustainable Trade (FAST), and international organizations (the Global Environment Facility (GEF) and the Division of Technology, Industry and Economics of the United Nations Environment Programme (UNEP-DTIE)).

- 89. Participants agreed on a timetable defining the next steps, which included elements of a strategy to advance the business and biodiversity agenda post-2010 and reaffirmed their commitment to take to the tenth meeting of the Conference of the Parties a meaningful and effective business and biodiversity initiative.
- 90. Recognizing the economic values of biodiversity and ecosystems services, the brainstorming session was held as an informal preparatory meeting for the "Third Business and 2010 Biodiversity Challenge Conference" being convened by the CBD Secretariat in collaboration with UNEP in Jakarta from 30 November to 3 December 2009.
- 91. Further steps were taken during the reporting period in preparation for the Jakarta meeting, documentation for which is available at the following location on the CBD website: http://www.cbd.int/doc/?meeting=B2010-03.

Decisions IX/32 and IX/33: Programme of Work for Communication, Education and Public Awareness and Preparations for the International Year of Biodiversity

- 92. A number of initiatives are being taken for the preparations for the celebrations of the International Year of Biodiversity (IYB). The latest version of the implementation plan for the year was posted on the CBD website at: http://www.cbd.int/iyb/iyb-2010-strategy-final-en.pdf.
- 93. Thanks to the financial assistance of the government of Canada, the Secretariat completed the work on the logotype and messaging for the International Year. The logotype in all United Nations Languages was made available to Parties and Partner Organizations via notification: (http://www.cbd.int/doc/notifications/2009/ntf-2009-110-iyb-en.pdf). The logotype was unveiled at a number of international meetings including in Strömstad, Sweden; Liege, Belgium; and at the COP of the UNCCD in Buenos Aires, Argentina. The communications guide for the IYB in all languages is in finalization and will be made available to Parties in early October when the IYB website is launched.
- 94. On 24 September 2009, a press conference was held at the Secretariat of the Convention on Biological Diversity about a multi-media performance on the theme of biodiversity, to premiere 26 January 2010 at Place des Arts in Montreal as a contribution to the International Year of Biodiversity. Entitled "Paradis Perdu" (Paradise Lost), the show is a post-apocalyptic musical odyssey of a soldier, the last human being on earth, who dreams of recreating a world destroyed by mankind. Created by Jean Lemire (Mission Antarctica), Dominic Champagne (Cirque du Soleil's Beatles show, LOVE), and Daniel Belanger (musician/singer/songwriter), the show will be one of the first major arts events contributing to the International Year of Biodiversity in 2010. The Secretariat is a partner and technical advisor to the performance. The press conference gathered the presence of major local TV and radio news stations, and relevant partners in Montreal.
- 95. Other partners announced their support for the IYB. A meeting of Canadian authorities was convened on August 18 to discuss and coordinate the activities of all levels of government and stakeholders in Canada. Implementation plans were shared and put into place. The Council of the Global Environment Facility (GEF) approved a special initiative to support the objectives of the 2010 International Year of Biodiversity (IYB). Budgeted at US\$ 895,000, this is the most significant initiative for the IYB agreed to date. The GEF activities on IYB will be undertaken in consultation with the Convention Secretariat taking in to account relevant decisions of the Conference of the Parties to the Convention. UNEP also agreed to contribute 500,000 United States dollars to the IYB celebrations and plans for the use of these funds are in development.

- 96. UNESCO in close partnership with the Secretariat is finalizing its exhibition and will be the lead UN agency launching the International Year of Biodiversity in January 2010. UNESCO will prepare a Biodiversity Education Kit in honor of the International Year.
- 97. SCBD participated in a workshop on communications coordination at UNEP headquarters in Nairobi from 31 August to 1 September 2009. The workshop brought together information officers from regional offices and multilateral environmental agreements for discussions on harmonization of communication strategies and better sharing of resources. A training on approaches to branding and messaging was also conducted by Futerra Sustainability Communications firm. As part of this meeting, the implementation plans for the International Year were shared with communications officers and the logotype was distributed.
- 98. SCBD in close collaboration with the triple presidency (Brazil, Germany and Japan) has submitted to the United Nations its recommendations for the designation of a UN ambassador for the International Year.
- 99. United Nations Postal Administration has confirmed that a series of stamps will be issued to commemorate the International Year of Biodiversity.
- 100. The Secretariat continues its ongoing work on the preparations for the series of sub-regional training workshops on Communication, Education and Public Awareness and Media Relations. The next workshop for ASEAN countries will be held in Jakarta, Indonesia from 30 November to 3 December, in collaboration with the ASEAN Centre for Biodiversity and the government of Indonesia, with the financial assistance of the government of the Netherlands. It will be held at the same time as the Business and Biodiversity meeting.

IMPLEMENTATION AND TECHNICAL SUPPORT

VIII/14: National reporting and the next Global Biodiversity Outlook

- 101. As of end of September 2009, a total of 80 fourth national reports including a few draft reports have been received. All the final reports have been posted on the Convention website at https://www.cbd.int/reports/search/?type=nr-04.
- 102. The Executive Secretary sent a letter to the Ministers of the Environment of those countries that had not submitted their fourth national reports, urging them to submit the report before the end of November 2009 while highlighting the importance of submissions by all Parties.
- 103. The Secretariat continued communicating with relevant Parties through various means to facilitate the preparation and submission of the fourth national report, including providing comments or suggestions to the draft reports some countries sent to the Secretariat.
- 104. A preliminary synthesis of information contained in around 60 fourth national reports received before the end of July had been prepared as a contribution to the first draft of the third edition of the Global Biodiversity Outlook.
- 105. Consultation is under way with Countdown 2010 and IUCN regional offices on a possible sub-regional workshop for the Caribbean and Central American countries on the fourth national report and the post-2010 biodiversity target. The workshop is intended to facilitate the submission of the fourth national reports of this sub-region, among others.

- 106. Phase III of a medium-sized project to support the preparation of the fourth national report had been formally approved by the Global Environment Facility. So far about 22 country requests had been approved or are being processed. The Secretariat sent a few reminders to relevant countries urging them to move fast to get the funds and to initiate the preparation of the fourth national report.
- 107. A teleconference was held with the South Pacific Regional Environment Programme, UNDP country or regional offices in the Pacific countries and other partners to discuss how to facilitate the preparation of the fourth national report by the Pacific Island Countries. With the facilitation of SPREP, most PICs have initiated the preparation of the report or applied for funds for report preparation.
- 108. A proposal has been developed to obtain support from Japan to facilitate the preparation and submission of the fourth national report. Options proposed include organizing regional workshops, provision of technical support through individual country visits upon request and hiring consultants to help countries upon request. Such a proposal is being considered by Japan.
- 109. Inputs were provided to educational or communication materials prepared for the International Year of Biodiversity based on information from national reports.
- 110. Inputs were provided to a few in-depth reviews being prepared for the sixth meeting of the Working Group on Article 8(j) and the fourteenth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice. Further inputs are also being prepared for the third edition of the Global Biodiversity Outlook.

Decisions VIII/8 and IX/8: National Biodiversity Strategies and Action Plans

- 111. The Secretariat is continuing work to compile case studies, tools and guidance arising from the regional capacity development workshops. The Secretariat is cooperating with the United Nations University-Institute of Advanced Studies project on NBSAPs and with various scientific programmes to improve the evidence-base for implementation of the Convention.
- 112. A senior official from the office of the focal point of Botswana, responsible for implementation of the NBSAP, worked at the Secretariat during a three week period.
- 113. The report of the second European workshop on national biodiversity strategies and action plans and mainstreaming of biodiversity (12-16 June 2009, Vilm, Germany) has been prepared.

Decision IX/9: Revision and updating and of the Strategic Plan of the Convention

- 114. A number of further views on the Updating and revision of the Strategic Plan of the Convention have been submitted by Parties and observers.
- 115. The Secretariat made presentations on the updated Strategic Plan, including processes, at the meeting on Biodiversity, Ecosystem Services and Poverty Eradication in Vilm Germany, the meeting of Pan-European Biodiversity Conference in Liege, Belgium and at the margins of the second meeting on IPBES in Nairobi, Kenya. Each of these meetings also provided important inputs to the updating of the Strategic Plan.
- 116. The synthesis/analysis of views which was made available in June (UNEP/CBD/SP/PREP1 at www.cbd.int/sp) is now being updated to reflect the additional submissions and consultations. In addition, a paper setting out some possible elements of the updated Strategic Plan are being prepared. The papers will be available in November.

117. Preparation is underway for a regional workshop for South, East and Southeast Asia on the updating of the Strategic Plan of the Convention for the period beyond 2010, which will be held from 15 to 18 December 2009 in Tokyo, Japan. The workshop will be supported by the Japanese Ministry of the Environment and Japan Wildlife Research Centre. Consultation is underway to organize meetings for other regions.

Decisions IX/11 and IX/31: Financial Resources and the Financial Mechanism, and the Guide to the Financial Mechanism

- 118. The notification informing Parties of the International Workshop on Innovative Financial Mechanisms, to be held in Bonn, Germany, from 27-29 January 2010, was circulated on 14 July 2009. Nominations for regional centers of excellence were received from Canada (IISD, CEC, USDA, Forest Trends), Central African Republic, France (Ministry of Ecology, Energy, Sustainable Development and Sea-France, IUCN, WWF, OECD, GEF, FFEM, The Katoomba Group, BBOP), EC (EC Directorate General Environment), Peru, Tajikistan, and Tuvalu. Invitation to organizations and regional centers of excellence has been prepared.
- 119. Annotations to the agenda item on financial resources and the mechanism have been prepared for inclusion in the WGRI-3 document.
- 120. Submissions have been received from the European Union, with the European Commission, Czech Republic, France, in response to the notification on decisions IX/11 and IX/31 concerning financial resources and mechanism, which were posted at: http://www.cbd.int/financial/.
- 121. There are a total of 47 resource mobilization focal points so far. Additional 15 Parties have so far appointed such focal points, including: Azerbaijan, Cambodia, Cuba, Ecuador, Fiji, Grenada, Hungary, Nepal, Sao Tome and Principe, Serbia, Suriname, Swaziland, Tanzania, and Timor-Leste.
- 122. All GEF-financed biodiversity projects have been marked in terms of COP guidance to facilitate the preparation of documentation on review of the guidance to the financial mechanism for WGRI-3.
- 123. Input to the GEF report to its Council meeting of November 2009 was transmitted to the GEF Secretariat. The draft proposal on the fourth review of the effectiveness of the financial mechanism was included for consultation with the GEF Council.
- 124. The Secretariat reviewed documents provided by the GEF Secretariat for the meeting of the GEFOP to be held on 6 October 2009 to which it shall participate.

Decision IX/30: Scientific and Technical Cooperation and the Clearing-House Mechanism

- 125. During the third quarter of 2009, activities related to the Clearing-House Mechanism (CHM) can be summarized as follows:
 - A. Website Maintenance and Development:
 - a. Implementation of several important web portals proceeded with a special focus on the International Year on Biodiversity (IYB) portal, the Biodiversity for Development portal, and LifeWeb portal. The latter greatly benefited from the arrival of the two LifeWeb staff members (Coordinator and Website Officer) at the beginning of the summer.
 - b. Some visual enhancements were made to the data-driven dynamic web components that display related websites and reference documents across the CBD website.

- c. Development of a web page and translation management system proceeded, but more work is needed to get an operational version.
- d. A junior programmer worked as a CHM intern during the summer and investigated how to benefit from a Web 2.0 service provider (Google) to share calendar and other relevant information. A basic proof of concept was implemented.

B. Knowledge and Information Management:

- a. The report of the consultancy on knowledge and information management was submitted to the Secretariat with recommendations on how to improve knowledge and information management.
- b. A CHM intern reviewed and enhanced the content of several key database tables (related websites, reference documents). He also structured facts and figures extracted from the available Fourth National Reports for future export into a database.
- c. The CBD Secretariat actively participated in the UNEP Knowledge Management Meeting for MEAs held in Chexbres, Switzerland on 22-24 September 2009. The purpose of the meeting was to take stock of existing initiatives and identify useful information services that could be implemented as a first step towards broader knowledge sharing among MEAs.

C. Cooperation and the Clearing-House Mechanism Network:

- a. The ASEAN Centre for Biodiversity (ACB) organized a Regional Technical Workshop on CHM Enhancement: Networking and Collaboration Tools in Bogor, Indonesia, on 30 June-3 July 2009. The workshop, attended by 18 CHM experts from 8 ASEAN countries, provided concrete hands-on training on the Joomla content management system (CMS). The CBD Secretariat contributed by presenting the CHM strategic vision and lessons learned, and by compiling information on national CHM from the various participating countries.
- b. The Third Global Invasive Species Information Network (GISIN3) meeting was held in Elmira, NY, United States on 26-29 July 2009, and organized by USGS National Biodiversity information Infrastructure (USGS/NBII). The objective of the meeting was to make progress in the establishment of the GISIN protocol, an interoperability mechanism to exchange IAS information between providers and potential users. The meeting was attended by 12 IAS/IT experts from several IAS data providers and other relevant institutions (IABIN I3N, FishBase, Smithsonian Institute, GBIF, and CBD/CHM).

BIOSAFETY

THE CARTAGENA PROTOCOL ON BIOSAFETY

III. IMPLEMENTATION OF THE DECISIONS OF THE CONFERENCE OF THE PARTIES SERVING AS THE MEETING OF THE PARTIES TO THE PROTOCOL

Decisions BS-II/2 and BS-IV/2: Operation and Activities of the Biosafety Clearing House (BCH)

- 126. With the aim of improving Management Centre as recommended at the last BCH-IAC meeting and in accordance with Programme Element 1 of the annex to BS-II/2, a new version of the BCH Management Centre and 6 new common formats for information registration have been released and are available at http://bch.cbd.int/managementcentre. The following changes have been effected:
 - the structure of the common formats has been improved by adding new fields (metadata);

- a number of mandatory fields have been introduced to minimize registration of incomplete and/or inaccurate records,
- a new procedure for the validation of information which establishes a timeframe for the confirmation or updating of certain categories of information.
- 127. Common formats for the submission of information at the Biosafety Information Resource Centre (BIRC), LMO registry, Gene registry and the Organism registry have also been modified. These modifications are aimed at offering a more user-friendly interface as well as a wider and more precise range of options for the classification of records. In addition, a new set of Frequently Asked Questions (FAQs) has been made available at: http://bch.cbd.int/help/faq.shtml.
- 128. During the reporting period, the Secretariat launched through the BCH a website on the Online Survey on the Application of and Experience in the Use of Socio-Economic Considerations in Decision-Making on Living Modified Organisms. The online survey will commence on 1 October and end on 31 October 2009.
- 129. With regards to the upcoming BCH IAC meeting in October 2009, the Secretariat has finalized an agenda that available at: http://bch.cbd.int/about/iac/. The meeting is expected to be attended by 20 participants who include BCH experts and observers.
- 130. The BCH databases continues to expand and improve with the increase in information registered in the capacity-building databases, the Biosafety Information Resource Centre (BIRC) and the addition of guidance materials on risk assessment.

Decision BS-IV/11: Risk Assessment and Risk Management

- 131. The Ad Hoc Technical Expert Group on Risk Assessment and Risk Management under the Cartagena Protocol on Biosafety (AHTEG) continues its work on the development of guidance materials in its four Sub-working Groups. (Roadmap for Risk Assessment, Living Modified Crops with Resistance or Tolerance to Abiotic Stress, Living Modified Mosquitoes and Living Modified Organisms with Stacked Genes or Traits). It is hoped that the outputs of the Sub-working Groups, among others, will be ready for the second round of the discussion groups in November 2009 under the Open-ended Online Forum.
- 132. Pursuant to decision BS-IV/11, the Secretariat issued a notification reminder on 25 August 2009 calling for the submission of scientifically sound information regarding the identification of living modified organisms or specific traits that may have adverse effects on the conservation and sustainable use of biological diversity, taking also into account risks to human health. The submissions received by the deadline will serve as a basis for deliberations by experts in i) ad hoc discussion groups and ii) real-time conferences under the Open-ended Online Forum; as well as by the experts of the Ad Hoc Technical Expert Group during its second meeting.

Decision BS-IV/17: Public Awareness, Education and Participation

- 133. The Secretariat released the sixth issue of the Biosafety Protocol News in July and produced an updated version of the brochure on the Cartagena Protocol on Biosafety in the six UN languages. It also embarked on preparation of outreach materials on the Protocol for the International Year on Biodiversity (IYB).
- 134. The Secretariat made a presentation at the 2nd International Youth Symposium for Biodiversity, 6 July, Ottawa, Canada.

Decisions BS-III/10 and BS-IV/9: Handling, transport, packaging and identification of living modified organisms – paragraph 2 (a) of Article 18

- 135. The Secretariat organised the first in the series of Regional Training of Trainers' Workshops on the Identification and Documentation of Living Modified Organisms (LMOs) under the Cartagena Protocol on Biosafety for the Africa region. The workshop was held from 14 to 18 September 2009 in Bamako, Mali. It was hosted by the Government of Mali with the financial contribution from the European Commission and with support for some participants being provided by the Union Economique et Monétaire Ouest Africaine. The workshop was attended by more than 36 participants including 22 countries and 6 representatives from organizations involved in the identification and documentation of living modified organisms.
- 136. The workshop was aimed at introducing customs officers to (i) the requirements of the Cartagena Protocol on Biosafety regarding the identification and documentation of LMOs; and (ii) techniques and methodologies that may be used for the implementation of these requirements. To this end, participants discussed the role of customs officials in implementing the Cartagena Protocol on Biosafety, documentation accompanying shipments of living modified organisms, sampling and detection of living modified organisms and experiences of the Green Customs Initiative partners. One of the major outputs of the workshop was the development of action plans for the implementation of the identification and documentation requirements for LMOs by country participants. The workshop also had an experimental session on LMO identification at the Laboratoire de Biologie Moléculaire Appliquée (LBMA) of the Université de Bamako.
- 137. The Secretariat is preparing for the next workshop for the GRULAC region to be held from the 23 to 27 November 2009 in Mexico City, Mexico.

Decisions BS-II/6 and BS-IV/6: Cooperation with other organizations, conventions and initiatives

- 138. During the reporting period, the Regional Specialist on Communication of the *Union Economique et Monétaire Ouest Africaine Réussir Ensemble l'Intégration* (l'UEMOA) paid a working visit to the Secretariat with the aim of enhancing cooperation in capacity building activities and information sharing (BCH) between the SCBD and UEMOA.
- 139. Four fellows of the African Biosafety Network of Experts who are currently setting up the West African Node for the NEPAD biosafety project also paid a day working visit to the Secretariat.

Decisions BS-II/12 and BS-IV/16: Socio-Economic Considerations

140. The Secretariat, in collaboration with the GEF Coordination Division of the United Nations Environment Programme (UNEP), is preparing to launch a survey through the BCH on the application of and experience in the use of socio-economic considerations in decision making on living modified organisms. The survey will be available in English, French and Spanish. More information about the survey can be found at: http://bch.cbd.int/onlineconferences/socioeconomics.shtml.

Status of Ratification or Accession to the Protocol

141. As of 30 September 2009, 156 countries have ratified or acceded to the Protocol. The list of these Parties is available on the website: http://www.cbd.int/biosafety/signinglist.shtml.

ANNEX II

Status of Implementation of the Agreed Administrative Arrangements

I Personnel Arrangements

1. During the reporting period, the Secretariat had 36 regularized Professional staff members and 25 regularized General Service staff members funded from the core budget. There was 1 Professional and 2 General Services vacant posts for which recruitment/selection is in progress. Additionally, 5 professional posts and 11 General Service posts were funded from other sources. For more information, please refer to the attached staff list and organigram (Appendix 1 and Annex II respectively).

II <u>Contributions and Funds</u>

- 2. During the third quarter of 2009, eight new pledges of additional voluntary funds in support of approved activities under the Convention (BE Trust Fund) were recorded. Finland pledged: EUR 5,000 for the Drafting Committee Meeting for the AHTEG on Biodiversity and Climate Change and EUR 15,000 towards the IUCN World Commission on Protected Areas; France pledged EUR 2,036 towards the Marine Expert Workshop; Germany pledged: US\$30,000 towards the Marine Expert Workshop on bio-geographic classification systems, EUR 5,254 for the COP-9 Bureau Meeting and EUR 100,429 for the Workshop on Innovative Financial Mechanisms; Heidehof Foundation pledged EUR 29,500 towards the 2nd CBD Indigenous Tourism and Biodiversity Award and Japan pledged US\$100,000 towards the production of GBO-3.
- 3. For 2009 a total of US\$2,643,878 has been pledged to the BE Trust Fund, of which US\$1,761,637 or 67% has been collected as at 30 September 2009. Full details of the pledges and contributions to the BE Trust Fund are reflected in Annex IV.
- 4. The total amount pledged for the BY Trust Fund in 2009 is US\$10,506,128. Of this amount, US\$8,302,192 or 79% has been received as at 30 September 2009. A total of US\$1,560,420 has also been collected in 2009 as advance payments for 2010 and future years. Additionally, US\$886,106 has been pledged as additional contributions to the BY Trust Fund for 2009. US\$48,618 has also been collected in 2009 for prior years. Full details of the pledges and contributions to the BY Trust Fund are reflected in Annex VI.
- 5. As at 30 September 2009, US\$337,528 has been pledged for 2009 as additional voluntary contributions to facilitate the Participation of Parties in the Convention process (BZ Trust Fund). Full details of the pledges and contributions to the BZ Trust Fund are reflected in Annex V.
- 6. As at 30 September 2009, contributions to the BZ Trust Fund in 2009 amounted to US\$273,589 or 81% of the total pledged for 2009. A total of US\$186,285 remains outstanding for the BZ Trust Fund for 2009 and prior years. Full details of the pledges and contributions to the BZ Trust Fund are reflected in Annex V.
- 7. As at 30 September 2009, a total of ninety (90) countries have paid US\$1,749,368 to the BG Trust Fund, representing 89% of pledges for 2009. A total of US\$27,796 has also been collected in 2009 as advance payments for 2010 and future years. US\$127,713 has also been collected in 2009 for prior years. Full details of the pledges and contributions to the BG Trust Fund are reflected in Annex VII.
- 8. As at 30 September 2009, six Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Additional voluntary Contributions in Support of Approved Activities of the Cartagena

Protocol on Biosafety, (BH Trust Fund) in 2009. To date, US\$305,833 has been received in 2009 for 2009 and future years. Full details of the pledges and contributions to the BH Trust Fund are reflected in Annex VIII.

9. As at 30 September 2009, no Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Facilitating Participation of Developing Country Parties in the Cartagena Protocol on Biosafety, (BI Trust Fund). Full details of the pledges and contributions to the BI Trust Fund are reflected in Annex IX.

III Accounting and Reporting

Status of Expenditure

- 10. COP-9 approved a budget of US\$11,391,900 for the BY Trust Fund for 2009. As at 30 September 2009, a total of US\$6,591,079 was spent or committed. This represents 57.9% of the approved amount.
- 11. COP/MOP-4 approved a budget of US\$2,611,800 for the BG Trust Fund for 2009. As at 30 September 2009, a total of US\$1,470,671 has so far been spent or committed. This represents 56.3% of the approved amount.

Reimbursement for Services provided to the Secretariat

12. 





Organizational Chart of the CBD Secretariat


