INTRODUCTION

1. This report has been prepared pursuant to decision III/24 of the Conference of the Parties, which requested the Executive Secretary to prepare a quarterly report on the administration of the Convention including such matters as the staff list, status of contributions, progress on the implementation of the medium term work programme and financial expenditure report. The requirements to report on a regular basis to the Parties were further elaborated under the Administrative Arrangements between the Secretariat and UNEP, which were endorsed by the Conference of the Parties in decision IV/17.

2. Therefore, the Executive Secretary has prepared the 49th edition of the Quarterly Report which contains a summary of key activities in implementing the decisions of the Conference of the Parties and other relevant matters during the period 1 April to 30 June 2010.

I. OFFICE OF THE EXECUTIVE SECRETARY

MEETINGS

3. The Secretariat organized the following meetings:

4. A workshop on Regional Action to Combat Invasive Species on Islands to Preserve Biodiversity and Adapt to Climate Change on 12-16 April in Auckland, New Zealand.

5. The Second meeting of the *Ad hoc* Technical Expert Group on Risk Assessment and Risk Management on 29-23 April in Ljubljana, Slovenia.

6. The International Symposium for the CBD: The role of forest biodiversity in the sustainable use of ecosystem goods and services in agro-forestry, fisheries and forestry on 26-28 April in Waseda University, Tokyo, Japan.

7. Launch events around the world of the third edition of Global Biodiversity Outlook.

8. The Fourteenth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice on 10-21 May in Nairobi, which was preceded by a meeting of the SBSTTA Bureau.

9. The Ninth meeting of the Coordination Mechanism for the Global Taxonomy Initiative on 16 May in Nairobi. The meeting was preceded by a GTI Symposium on "Taking Stock of the Renaissance in Taxonomy: Post-2010 Capacity-building in Taxonomy for the Convention on Biological Diversity".

10. The Third meeting of the *Ad hoc* Open-ended Working Group on Review of Implementation of the Convention on 24-28 May in Nairobi.

11. A number of events and activities to mark the International Day for Biological Diversity, International Year of Biodiversity and *The Green Wave* in Nairobi, Kenya.

12. The Second Expert Meeting for South-South Cooperation on Biodiversity for Development on 29-30 May in Nairobi, Kenya.

13. During the reporting period, the Bureau of SBSTTA convened a meeting on 9 May, prior to the SBSTTA 14 meeting. On 23 May, the COP Bureau held a meeting, prior to the WGRI-3 meeting. Taking

advantage of the presence of the members of both the COP and SBSTTA Bureaux in Nairobi, a joint meeting of the two Bureaux was held on 23 May. Also on the same day, a meeting of the COP-MOP Bureau was held.

14. The Latin American and Caribbean Indigenous and Local Community Capacity-building Workshop on the CBD including issues relevant to Article 8(j) and ABS.

15. The International Conference on Biological and Cultural Diversity: Diversity for Development-Development for Diversity on 8-10 June in Montreal, Canada.

16. The Third meeting of the Group of the Friends of the Co-Chairs on Liability and Redress in the context of the Cartagena Protocol on Biosafety on 15-19 June in Kuala Lumpur, Malaysia.

17. Five regional workshops on the fourth national report: Regional Workshop for Asia and Horn of Africa on the Fourth National Report (12-15 April, Manama, Bahrain); Regional Workshop got Asia-Pacific Countries on the Fourth National Report (19-22 April, Apia, Samoa); Regional Workshop for African Countries on the Fourth National Report (31 May-2 June, Nairobi, Kenya); Regional Workshop for Latin American and Caribbean Countries on the Fourth National Report (15-17 June, Panama City, Panama); and Regional Workshop for Europe on the Fourth National Report (30 June-2 July, Budapest, Hungary).

MUSEUM OF NATURE AND CULTURE

18. The President of the Second International School Congress: Natural Resources, Sustainability and Humanity in Portugal, on behalf of the children, the craftsmen, the scientists and researchers, the teachers and students and all the institutions involved in the International School Congress, donated a silver heart necklace to the Secretariat as a contribution to the CBD Museum. The Secretariat also received a Buddha head jade statue from the Minister of Environment of The Royal Government of Cambodia.

REPRESENTATION

19. During the second quarter of 2010, the Secretariat participated and contributed to a number of important meetings and activities that are of relevance to the objectives of the Convention on Biological Diversity and its Cartagena Protocol on Biosafety. Details can be seen in Annex I to this report.

MEMORANDA OF COOPERATION/UNDERSTANDING

Alliance for Zero Extinction (AZE)

20. A Memorandum of Understanding (MoU) was signed between the Secretariat and the Alliance for Zero Extinction, in the margins of the SBSTTA 14 meeting in Nairobi. The MoU aims to establish a collaborative framework with a view to promote greater implementation of the Convention, specifically with regard to preventing species extinctions and maintaining ecosystems and habitats at keys sites for endangered species.

MEETINGS OF THE EXECUTIVE SECRETARY

21. During the reporting period, the Executive Secretary held meetings with a number of senior staff and representatives from Parties, other Governments, organizations and institutions, with a view to further enhancing and strengthening collaboration, and raise public awareness of the Convention on Biological Diversity and its Cartagena Protocol on Biosafety, its work and objectives.

22. In April, the CBD Executive Secretary welcomed the visit of: the President and CEO and staff from RARE Conservation; as well as Ms. Carole Robert and Mr. Bernard Colas. A delegation from the City of Brest in France, and students from the *Université du Québec à Montréal* (UQAM) also visited the Secretariat. On 18 May, the Secretariat welcomed the visit of Mr. Pavan Sukhdev, TEEB Study Leader & Special Advisor & Head of UNEP's Green Economy Initiative. Mr. Sukhdev had an opportunity to address the staff and deliver a presentation on the TEEB report. The final TEEB synthesis report is expected to be released at the CBD COP10 meeting in Nagoya, Japan.

23. A coordination meeting was held at the CBD office on 13 May with CBD staff and representatives of Sedna Foundation, Quebec Ministry of Sustainable Development, Environment and Parks, Canadian Environmental Network (RCEN), and the National Coalition of regional councils of the environment (RNCREQ). Staff from CABI also visited the Secretariat and met with relevant CBD staff.

24. For the month of June, visitors to the Secretariat included: the Consul General of Switzerland and the Consul General of Tunisia (in Montreal); Vice Minister Takemoto for Global Environmental Affairs, Ministry of the Environment of Japan; the Director of the Center for Integrative Conservation Research at University of Georgia, staff from the Colorado State University, and the new Coordinator of the GTZ Biodiversity Programme.

25. The Canadian Environmental Network (RCEN) organized a multi-stakeholder dialogue on the new Strategic Plan of the Convention on Biological Diversity at the Secretariat on 11 June 2010. The meeting was attended by Canadian representatives of the public sector (federal, provincial and municipal), NGOs, industry, academia, municipalities' network, community members and UN agencies.

26. In April, at the kind invitation of the International Conservation Foundation, the CBD Executive Secretary took part in the U.S. Congressional launch of the International Year of Biodiversity in Washington, organized with the support of the Global Environment Facility (GEF). The event coincided with the award ceremony of the Teddy Roosevelt International Conservation Award to the President of the Republic of the Philippines and the Prime Minister of Norway. The CBD Executive Secretary attended the dinner hosted by the CEO of GEF, in honour of the President of the Republic of the Philippines. While in Washington, the CBD Executive Secretary met and discussed with key congressmen and senior staff of the National Oceanic and Atmospheric Administration (NOAA) and the U.S. State Department the accession of the U.S. to the Convention on Biological Diversity.

27. The CBD Executive Secretary travelled to New York in April to attend and address the Second meeting of the Commission for Biodiversity, Ecosystems, Finance and Development, following an invitation from the UNDP Regional Bureau for Latin America and the Caribbean. In the margins of the meeting, meetings were held with the new UNDP Deputy Administrator, as well as the UNDP Director of Environment and Energy Group of the Bureau for Development Policy. A meeting was also held with the Director of the United Nations Forum on Forests. The CBD Executive Secretary also attended the 82nd plenary of the United Nations General Assembly, which adopted a draft resolution on the high-level meeting on biodiversity in September 2010, as a contribution to the International Year of Biodiversity. While in New York, meetings were held with: the United Nations Chief of Staff, the Deputy Representative

of Switzerland, the heads of the African Union Secretariat, the Commonwealth Secretariat; *Francophonie* and the Secretariat of the Chief Executive Board. A meeting was also held with the Ambassador of Andorra to the United Nations to discuss Andorra's accession to the Convention on Biological Diversity. The CBD Executive Secretary also attended and delivered a statement at the ninth meeting of the United Nations Permanent Forum on Indigenous Issues. The meeting was opened by the United Nations Secretary General, the President of the U.N. General Assembly and the President of ECOSOC, and was convened under the theme "Indigenous peoples, development with culture and identity".

28. The CBD Executive Secretary addressed the Canadian diplomatic corps in Ottawa during an information session on the International Year of Biodiversity on 20 April. In the margins of the briefing session, meetings were held with senior officials from the Government of Canada as well as the Government of Quebec.

29. In May, the CBD Executive Secretary was invited to deliver a keynote address at the Fifth Global Conference on Oceans, Coasts and Islands: Ensuring Survival, Preserving Life, Improving Governance. The meeting was hosted by UNESCO and the Government of France. A panel on "Preserving Life: Marine Biodiversity, Networks of MPAs, and Celebrating the 2010 International Year of Biodiversity" was organized. The Secretariat also served in the International Program Committee for the Oceans conference to provide guidance in all aspects of the meeting.

30. At the kind invitation of the Minister of Environment and Lands of Rwanda, the CBD Executive Secretary attended and delivered a keynote speech at the World Environment Day celebrations in Rwanda, celebrated this year under the theme "Many Species. One Planet. One Future", and as part of the International Year of Biodiversity. The special event gathered over 30,000 people, and with the special participation of the Rwandan President Paul Kagame. Also in attendance was actor Don Cheadle, who was named UNEP Goodwill Ambassador during the event. The three-day event involved a number of activities including: tree planting events, TUNZA Regional Youth Conference on Biodiversity, launch of UNEP publication "Dead Planet, Living Planet: Biodiversity and Ecosystem Restoration for Sustainable Development", an art exhibit, cycling tour, among others, which culminated in the Kwita Izina gorillanaming ceremony in the world's famous Volcanoes National Park, home to the Critically Endangered Mountain Gorillas.

31. In June, the CBD Executive Secretary was invited to deliver a keynote address at the Fourth Global Botanic Gardens Congress, under the theme "Addressing Global Change: A new agenda for botanic gardens". This was followed by his participation as one of the keynote speakers at the International Conference on Sustainable Business and Consumption, which took place in Nuremberg on 15-16 June. The two other keynote speakers at the event were the Parliamentary State Secretary of the German Federal Ministry for the Environment, Nature Conservation and Nuclear safety, and a Senior Councillor from the Ministry of the Environment of Japan. The conference facilitated the exchange of information on biological diversity and how it can play a greater role in business and society in the future.

32. The CBD Executive also attended the World Cities Summit 2010 in Singapore in June, and took part as one of the speakers at the panel discussion on "Urban Biodiversity & Ecology for Sustainable Cities". The four-day meeting, under the theme "Liveable and Sustainable Cities for the Future", focused on leadership and governance and building liveable and sustainable communities. Prior to his trip to Singapore, the CBD Executive was in Bangkok to brief the Permanent Representatives to ESCAP on the work of the Convention on Biological Diversity and the International Year of Biodiversity. He also held meetings with the Executive Secretary of ESCAP as well as the UNEP Regional Director for Asia and the Pacific. Also in June, the CBD Executive Secretary took part in the national celebration of the International Year of Biodiversity in Cambodia and in Malaysia.

33. A number of media-related events took place during the second quarter of 2010. In April, the CBD Executive Secretary was interviewed by the *Irish Eye* magazine and by *Le Devoir*. The month of May started with wide global launch events and media coverage of the release of the GBO 3. Interviews were also made with: *U.N. Radio, BBC, National Public Radio* (Los Angeles), *Al Jazeera, La Presse*, The Katoomba Group's *Ecosystem Marketplace, International Herald Tribune*, GoodPlanet Foundation, *Métro* (Montreal) journal, *Voice of America, Radio Canada*, and *Sunday Express*. The CBD Executive Secretary took part in a podcast interview at the BIO International Convention held in May, for distribution to participants at the meeting and for posting on the BIO website. In June, the CBD Executive Secretary participated in a number of media events in the margins of the World Cities Summit 2010 and the IYB event in Malaysia. He also took part in a press roundtable at the SusCon 2010 meeting in Nuremberg, and was also interviewed by Michael Baley in June.

34. In April, the CBD Executive Secretary and the Director of the United Nations Forum on Forest contributed a joint article in the *MEA Bulletin*, Issue No. 91, on "Forests and Biodiversity for our Future". An article was also submitted to the Arab Forum for Environment and Development (AFED) on IYB for inclusion to their publication.

IMPLEMENTATION OF THE ADMINISTRATIVE ARRANGEMENTS

A. Personnel Arrangements

35. During the period April – June 2010, there were 26 Professional staff members regularized on posts approved under the Convention. There were 4 vacant posts. Additionally, 6 professional staff members are regularized on posts funded from other sources.

36. Under the Convention, there were 22 General Service staff members regularized on posts funded by the core budget. There was one (1) vacant post. Additionally, 10 staff members are regularized on posts funded from other sources, 3 of which were formerly funded from the core budget. One post is vacant.

37. During the period under review for the Biosafety Protocol, there were 7 Professional staff members regularized on posts approved by the COP/MOP. There were 4 General Service staff members regularized on posts funded by the core budget.

38. For more information, please refer to the attached staff list and organigram (Annex II Appendix 1, and Annex III respectively).

B. Financial Arrangements

39. With regard to budgetary matters, as at 30 June 2010, of the total pledged contributions of US\$11,453,478 for 2010 to the General Trust Fund for the Convention on Biological Diversity (BY Trust Fund), the total contributions received amounted to US\$8,602,908 of which US\$2,258,387 were 2010 and future years pledges paid in 2009, and US\$6,344,521 were pledges paid in 2010 for 2010 and future years. Details of the BY Trust Fund are contained in Annex VI.

40. Several Parties have contributed additional voluntary funds in support of approved activities under the Convention (BE Trust Fund). As of 30 June 2010, the total pledged for 2010 amounts to US\$2,224,100 of which US\$1,626,090 has been received. Total unpaid pledges for 2010 and prior years to the BE Trust Fund is US\$1,143,725. Details of the BE Trust Fund are contained in Annex IV.

41. As at 30 June 2010, US\$1,082,782 has been pledged in 2010 as additional voluntary contributions to facilitate the participation of Parties to the Convention Process (BZ Trust Fund). To date, US\$500,292 has been received. Total unpaid pledges for 2010 and prior years, to the BZ Trust Fund, amount to US\$839,898. Details of the BZ Trust Fund are contained in Annex V.

42. As at 30 June 2010, of the total pledged contributions of US\$2,388,847 for 2010 to the General Trust Fund for the Core Programme Budget for the Biosafety Protocol (BG Trust Fund), total contributions received is US\$1,998,095, of which US\$611,974 were 2010 and future years pledges paid in 2009 and US\$1,386,121 has been received in 2010 for 2010 and future years. Details of the BG Trust Fund are contained in Annex VII.

43. As at 30 June 2010, three Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Additional Voluntary Contributions in support of Approved Activities of the Cartagena Protocol on Biosafety, (BH Trust Fund). To date, US\$13,805 has been received in 2010 for 2010 and future years. Details of the BH Trust Fund are contained in Annex VIII.

44. As at 30 June 2010, three Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Facilitating Participation of Developing Country Parties in the Cartagena Protocol on Biosafety, (BI Trust Fund). Pledges totalling US\$121,408 have been received in 2010, of which US\$41,414 has been collected. Total unpaid pledges for 2010 and prior years, to the BI Trust Fund, amounts to US\$111,614. Details of the BI Trust Fund are contained in Annex IX.

45. As at 30 June 2010 one pledge has been received for the General Trust Fund for Voluntary Contributions to Facilitate the Participation of Indigenous and Local Communities in the Work of the Convention on Biological Diversity (VB Trust Fund) in 2010. Norway pledged NOK200,000. Details of the VB Trust Fund are contained in Annex X.

II. IMPLEMENTATION OF THE DECISIONS OF THE CONFERENCE OF THE PARTIES

SCIENTIFIC, TECHNICAL AND TECHNOLOGICAL MATTERS

Decision VII/27: Mountain Biological Diversity

- 46. In response to this decision, the Secretariat:
 - (a) Prepared and serviced the Fourteenth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA 14), held in Nairobi, from 10 to 21 May 2010, on the agenda item 3.1 on "In-depth review of the mountain biological diversity programme of work", which resulted in SBSTTA recommendation XIV/1 on "In-depth review of the implementation of the programme of work on mountain biological diversity", for consideration by the COP at its tenth meeting; and
 - (b) Undertook consultations with ICIMOD, Alpine, Carpathian conventions, GMBA and other organizations, towards the possibility of organizing a side event in the margins of COP 10, showcasing the implementation of the mountain biological diversity program of work.

Decisions IX/1 and IX/2: Agricultural Biodiversity

47. In response to this decision, the Secretariat:

- (a) Prepared information documents for SBSTTA 14 on: (i) Progress on the International Initiative for the Conservation and Sustainable Use of Pollinators (UNEP/CBD/SBSTTA/14/INF/31); (ii) Preparation of the Second Report on the State of the World's Plant Genetic Resources for Food and Agriculture and Updating the Global Plan of Action for the Conservation and Sustainable Utilization of Plant Genetic Resources for Food and Agriculture (UNEP/CBD/SBSTTA/14/INF/ 32); and (iii) Sustainable Agriculture and the Sustainable Use of Agricultural Biodiversity: Concepts, Trends and Challenges (UNEP/CBD/SBSTTA/14/INF/34);
- (b) Attended a meeting of the Platform for Agro-biodiversity Research at the Food and Agriculture Organisation of the United Nations, Rome, Italy, from 13 to 19 April, to prepare a report on the role of biodiversity for food and agriculture in feeding the world and in light of global climate changes; and
- (c) Serviced SBSTTA 14 on the agenda item 4.1 on "Agricultural biodiversity" and 4.1.2 on "Biofuels and biodiversity", which resulted in SBSTTA recommendation XIV/10 on "Agricultural biodiversity".

Decisions IX/3: Global Strategy for Plant Conservation

- 48. In response to this decision, the Secretariat:
 - (a) Prepared for the SBSTTA 14 including the preparation of proposals for the update of the Strategy beyond 2010;
 - (b) Co-organised and participated in two side events at the SBSTTA 14 in collaboration with BGCI, IUCN, Plantlife International, Catalogue of Life to elaborate the progress in the implementation of the GSPC as well options for the further development of the Strategy beyond 2010;
 - (c) Serviced SBSTTA 14 on the agenda item 3.3 on "Proposals for a consolidated update of the Global Strategy for Plant Conservation", which resulted in SBSTTA recommendation XIV/8 on "Proposals for a consolidated update of the Global Strategy for Plant Conservation";
 - (d) Prepared a concept note for the development of the toolkit on the GSPC for the overall proposal submitted to the Government of Spain;
 - (e) Participated in the 4th Global Botanic Gardens Congress, held in Dublin, Ireland, from 14 to 18 June 2010;
 - (f) Participated in the Science and Policy workshop with a focus on the GSPC, held in Kew, UK, from 21 to 22 June 2010, organized by the Royal Society and Royal Botanic Gardens Kew; and

- SBSTTA 14 finalization (b) Prepared for including the of documents UNEP/CBD/SBSTTA/14/16/Rev.1 on "Further Work on Gaps and Inconsistencies in the International Regulatory Framework on Invasive Alien Species, Particularly Species Introduced as Pets, Aquarium and Terrarium Species, as Live Bait and Live Food, and Best Practices for Addressing the Risks Associated with their Introduction" and UNEP/CBD/SBSTTA/14/INF/29 on "Report of the Workshop "Helping Islands Adapt – A workshop on Regional Action to Combat Invasive Alien Species on Islands to Preserve Biodiversity and Adapt to Climate Change" (11-16 April 2010, Auckland, New Zealand)";
- (c) Serviced SBSTTA 14 on the agenda item 4.4 on "Further work on gaps and inconsistencies in the international regulatory framework on invasive alien species introduced as pets, aquarium and terrarium species, as live bait and live food, and best practices for addressing the risks associated with their introduction", which resulted in SBSTTA 14 recommendation XIV/13 on "Further work on gaps and inconsistencies in the international regulatory framework on invasive alien species introduced as pets, aquarium and terrarium species, as live bait and live food, and best practices for addressing the risks associated with their introduced as pets, aquarium and terrarium species, as live bait and live food, and best practices for addressing the risks associated with their introduction";
- (d) Completed editing of CBD Technical Series No. 48, "Best practices for addressing the risks associated with the introduction of alien species as pets, aquarium and terrarium species, and as live bait and live food";
- (e) Organized and prepared a report on the inter-agency liaison group meeting on invasive alien species at the World Organisation for Animal Health, held in Paris, France, from 17 to 18 June 2010. The purpose of the meeting was to address gaps and inconsistencies in international regulatory framework; and
- (f) Prepared COP 10 document, including provision of input on invasive alien species.

Decisions VI/22 and IX/5: Forest Biodiversity

- 50. In response to decisions VI/22 and IX/5, the Secretariat:
 - (a) Participated in an international expert workshop at the University of Freiburg, Germany, on reducing emissions from deforestation and forest degradation, and forest biodiversity conservation, from 14 to 16 April 2010. The workshop's objective was to analyze the potential risks and opportunities for the conservation of forest biodiversity in developing countries under the CBD and UNFCCC with a major focus on the currently evolving design of REDD-plus;
 - (b) Co-organized an international symposium of the Forestry and Forest Products Research Institute (FFPRI) and Waseda University in Tokyo, Japan, on the role of forest biodiversity in the sustainable use of ecosystem goods and services, from 26 to 28 April 2010. The symposium discussed how forest biodiversity affects ecosystem services, which may benefit agriculture, fisheries and forestry;
 - (c) Co-facilitated, jointly with the International Tropical Timber Organization (ITTO), a meeting of the Collaborative Partnership on Forests (CPF) in New York City, United States, from 27 to 29 April 2010, with the aim to further improve collaboration on issues related to sustainable forest management;

- (d) Participated in a workshop of the UN REDD Programme on ecosystem co-benefits from reducing emissions from deforestation and forest degradation, Cambridge, United Kingdom, from 27 to 29 April 2010. The workshop focused on the social, institutional and economic aspects of ecosystem co-benefits and their integration into evolving national REDD-plus strategies;
- (e) Participated in a short-term staff exchange with UNEP and UNEP-based staff of the UN REDD Programme in Nairobi, Kenya, from 25 to 28 May. The staff exchange promoted collaboration with UNEP and UN REDD on forest-related issues, in particular regarding the multiple benefits of reducing emissions from deforestation and forest degradation and the sustainable use of bushmeat;
- (f) Participated in UNFCCC SBSTA 32 in Bonn, Germany, from 31 May to 11 June 2010. The Secretariat organized a side event on 1 June jointly with CIFOR, FAO and IUCN on forest degradation and forest landscape restoration; and
- (g) Participated in the 23rd session of the Asia Pacific Forestry Commission in Thimphu, Bhutan, 9-11 June. The Secretariat collaborated with FAO in the preparation of a background note on forest biodiversity for the session.

51. The Secretariat member serviced SBSTTA 14 on the agenda item 4.3 on "Forest biodiversity: joint work plan with the UNFF secretariat and report on cooperation on the monitoring of forest biodiversity and on clarifying the definitions of forest and forest types", which resulted in SBSTTA recommendation XIV/12 on "Forest biodiversity: Collaboration with the secretariat of the United Nations Forum on Forests and report on cooperation on the monitoring of forest biodiversity and on clarifying the definitions of forest and forest biodiversity and on clarifying the definitions of forest and report on cooperation on the monitoring of forest biodiversity and on clarifying the definitions of forest and forest types".

Decision IX/9: Process for the revision of the Strategic Plan

- 52. In response to decision IX/9, the Secretariat:

 - (b) Initiated revising the technical rationale for the proposed targets in the future Strategic Plan of the Convention on Biological Diversity in light of the comments received and interventions made during the SBSTTA-14 and WGRI-3.

53. The Secretariat member serviced SBSTTA-14 on agenda item 3.4. on "Examination of the outcome-oriented goals and targets, and associated indicators, and consideration of their possible adjustments for the period beyond 2010", which resulted in SBSTTA recommendation XIV/9 on "Examination of the outcome-oriented goals and targets (and associated indicators) and consideration of their possible adjustment for the period beyond 2010".

54. The Secretariat member serviced WGRI-3 on agenda item 5.1 on "Revising and updating of the Strategic Plan beyond 2010".

Decision IX/10: Preparation of the Third Edition of the Global Biodiversity Outlook

- 55. In response to this decision, the Secretariat:
 - (a) Completed the translation of the third edition of Global Biodiversity Outlook (GBO-3) into all United Nations languages and finalized the layout of the publication;
 - (b) Coordinated the printing and distribution of GBO-3;
 - (c) Launched GBO-3 in all United Nations languages on 10 May 2010 during the opening day of the fourteenth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA 14) in Nairobi, Kenya;
 - (d) Serviced SBSTTA 14 on the agenda item 3.2 on "Consideration of the third edition of the Global Biodiversity Outlook, its messages and implications", which resulted in SBSTTA 14 recommendation XIV/7 on "Third edition of the Global Biodiversity Outlook implications for the future implementation of the Convention";
 - (e) Supported regional launches of the Global Biodiversity Outlook 3 in cities around the world;
 - (f) Worked with a design company to develop and launch a new webpage for GBO-3;
 - (g) Completed the layout of CBD Technical Series 50 on "Biodiversity scenarios for the 21st century", and arranged printing and distribution;
 - (h) Developed and distributed various ancillary products related to GBO-3,e.g. executive summary, a slide presentation, an information CD, a press release and a GBO-3 guide for small island developing States (SIDS), and continued to develop additional products;
 - (i) Prepared a notification inviting Parties to prepare local language versions of GBO-3;
 - (j) Organized and participated in a workshop on communicating the main findings of GBO-3 in cooperation with the Consortium of Scientific Partners;
 - (k) Made available all the graphs used in GBO-3, as well as the in-design files, for the complete publication;
 - (1) Provided support to those countries preparing for the local language versions of GBO-3; and
 - (m) Presented the main findings of GBO-3 during a Multi-stakeholder Dialogue on the new Strategic Plan of the Convention on Biological Diversity organized by the Canadian Environmental Network (RCEN) Biodiversity Caucus with the support of Environment Canada (EC).

Decision IX/15: Follow-up to the Millennium Ecosystem Assessment

- 56. In response to this decision, the Secretariat:
 - (a) Participated in the third *ad hoc* intergovernmental and multi-stakeholder meeting on an intergovernmental science-policy platform on biodiversity and ecosystem services (IPBES-3), held in Busan, Republic of Korea, from 7 to 11 June 2010;
 - (b) Published CBD Technical Series 50 on "Biodiversity Scenarios: Projections of 21st century change in biodiversity and associated ecosystem services", in English and French; and
 - (c) Invited GEO-BON, to prepare an evaluation of existing observation capabilities relevant to the targets contained in the Strategic Plan for the period 2011-2020.

Decision IX/16 and SBSTTA Recommendation XIV/5: Biodiversity and Climate Change

- 57. In response to these decision and SBSTTA recommendation, the Secretariat:
 - (a) Serviced SBSTTA 14 on the agenda item 3.1.5 on " In-depth reviews of implementation of the programme of work on biodiversity and climate change", which resulted in SBSTTA 14 recommendation XIV/5 on "In-depth review of the work on biodiversity and climate change";
 - (b) Participated in the Nordic Symposium on Synergies in the Biodiversity Cluster with a particular focus on presenting lessons learned from the process of enhancing synergies among the three Rio Conventions;
 - (c) Launched an online survey to solicit views from Parties on possible joint activities among the three Rio Conventions with a view to presenting the results at COP10;
 - (d) Conducted a side event on the outcomes of the fourteenth meeting of SBSTTA at the margins of the UNFCCC Bonn meetings;
 - (e) Delivered a statement on the outcomes of the fourteenth meeting of SBSTTA on 1 June during the 32nd meeting of the Subsidiary Bodies to the UNFCCC, under the agenda item on cooperation with relevant international organizations; and
 - (f) Conducted meetings with relevant partners on the Rio Conventions' Ecosystems and Climate Change Pavilion.

Decision IX/17 and SBSTTA Recommendation XIV/11: Biodiversity of Dry and Sub-humid Lands

- 58. In response to this decision and SBSTTA recommendation, the Secretariat:
 - (a) Serviced SBSTTA 14 on the agenda item 4.2 on "Consideration of proposals related to the programme of work on the biodiversity of dry and sub-humid lands', which resulted in SBSTTA 14 recommendation XIV/11 on "Consideration of proposals related to the programme of work on dry and sub-humid lands";
 - (b) Launched an online survey to solicit views from Parties on possible joint activities among the three Rio Conventions with a view to presenting the results at COP10;
 - (c) Issued a statement by the Executive Secretary on the occasion of the World Day to Combat Desertification;
 - (d) Participated in the first meeting of the EMG Issue Management Group on land, held in Nairobi, Kenya on 14 May 2010;
 - (e) Provided input into the Global Situational Analysis report on the Rio Convention reporting requirements;
 - (f) Continued planning for Land Day 3 to be held at the margins of COP 10 in Nagoya, in collaboration with the Secretariat of the UNCCD; and
 - (g) Conducted a meeting with representatives of the UNCCD Secretariat to discuss collaboration on drought management planning and human-wildlife conflict management in drylands.

Decisions VII/28, VIII/24 and IX/18: Protected Areas

59. In response to these decisions, the Secretariat:

- (a) Launched a user-friendly, comprehensive central website, including e-learning curriculum, to improve the national implementation of the programme of work on protected areas (PoWPA) in a side event at the margins of SBSTTA 14;
- (b) Raised funding from the Governments of Spain, Canada, and UNEP-WCMC for undertaking the task of developing learning modules, and conducted discussions with the Government of Sweden, Belgium, Saudi Arabia, and Germany seeking funding for completing the task by COP 10;
- (c) Prepared and serviced SBSTTA 14 on the agenda item 3.1.4 on "In-depth review of the implementation of PoWPA", which resulted in SBSTTA 14 recommendation XIV/4 on " In-depth review of the implementation of the programme of work on protected areas";
- (d) Participated in the conference on "Nature Conservation beyond 2010" organised by the Government of Estonia to celebrate 100 years of establishing its first protected area, held in Tallinn, Estonia, from 26 to 27 May 2010, and presented a keynote address on "programme of work on protected areas of the CBD: actual situation and perspectives for the future";
- (e) Held discussions with IUCN-WCPA on further collaboration for facilitating implementation of PoWPA;
- (f) Received approval from the European Union for 1 million EURs for a focussed capacity building activities for implementing the PoWPA in developing countries;
- (g) Organized side events featuring the LifeWeb Initiative at the margins of SBSTTA 14 and UNFCCC SBSTA 32;
- (h) Facilitated approval of funding from the Government of Finland, to conserve the Atiquipa lomas forests in Peru under the LifeWeb Initiative;
- (i) Continued discussions with the development cooperation Ministries of donor countries, conservation foundations and other donors, for supporting the Expressions of Interest registered on the LifeWeb clearing house;
- (j) Organized, in collaboration with the *Unidad de Parques Nacionales Naturales de Colombia* and the *Agencia Presidencial para la Acción Social y la Cooperación Internacional*, a national financing roundtable to seek financial cooperation in support of protected area priorities, in Bogota, Colombia; and
- (k) Developed and made available, in collaboration with UNEP-WCMC, the first version of the "carbon estimation tool", to highlight the climate change benefits of projects profiled on the LifeWeb clearing-house.

- (c) Organised, with partners, side events at SBSTTA 14 on (i) biodiversity and water, and (ii) harmonised reporting between the three Rio Conventions.
- (d) Attended a workshop on "Climate Change and the Media Forum 2010", held in Bonn, Germany, from 21 to 23 June 2010; and
- (e) Attended a drafting group meeting to prepare a report on the efficient use of water for food production and ecosystems, held at the International Water Management Institute, Colombo, Sri Lanka, from 23 to 25 June 2010.

61. In response to SBSTTA recommendation XIV/2, paragraph 1, the Secretariat collaborated with the Scientific and Technical Review Panel of the Ramsar Convention, the Centre for Ecology and Hydrology (UK) and the International Water Management Institute and prepared relevant information in a draft document for COP-10.

Decision IX/20: Marine and Coastal Biological Diversity

- 62. In response to this decision, the Secretariat:
 - (a) Serviced SBSTTA 14 on the agenda item 3.1.3. on "In-depth reviews of implementation of the programme of work on marine and coastal biodiversity", which resulted in SBSTTA recommendation XIV/3 on "In-depth review of the implementation of the programme of work on marine and coastal biological diversity";
 - (b) Attended and provided technical inputs to "EAS Congress Follow-up Meeting (Tokyo, 12 April 2010)", "meeting at the Ministry of Environment, Japan (Tokyo, 13 April 2010)", and "2010 UN IYB Public Forum in Kanazawa & Biodiversity and Marine Sustainability Research Session (Kanazawa, Japan, from 14 to 16 April 2010)", and discussed the preparation of COP 10 with various Japanese experts and partners;
 - (c) Attended and delivered an opening speech at the "*Symposium sur les aires marines protégées au Québec*", held in Rimouski, Canada, from 10 to 11 June 2010;
 - (d) Attended and served as a panellist at "Sustainable Ocean Summit (SOS)" organized by World Ocean Council (WOC), held in Belfast, Ireland, from 15 to 17 June 2010;
 - (e) Issued a message of Executive Secretary on World Oceans Day on 8 June 2010;
 - (f) Provided the U.N. Department of Economic and Social Affairs with CBD report on the measures taken by the Convention on implementation of resolution 63/214 adopted on 19 December 2008 entitled "Towards the sustainable development of the Caribbean Sea for present and future generations" on 17 June 2010;
 - (g) Provided the U.N. Division for Ocean Affairs and Law of the Sea with CBD report on developments and issues relating to ocean affairs and the law of the sea, as an input for the Secretary General's report on oceans and the law of the sea, which will be submitted to the U.N. General Assembly for its consideration at its sixty-fifth session;
 - (h) Facilitated and provided necessary guidance for the organization of side events and Oceans Day event at COP 10 with various partners, including the Global Forum of Oceans, Coasts and Islands, FAO, UNEP, UNEP-WCMC, and other international organizations;
 - (i) Reviewed and uploaded case-studies on the experiences of integrated marine and coastal are management on the CBD case-study database;

- (j) Reviewed and circulated for peer-review by steering committee members, the first draft of "CBD Good Practice Guide for Sustainable Fisheries Management, Biodiversity and Livelihoods"; and
- (k) Facilitated the preparation of CBD Technical Series on the experiences of integrated coastal management in Japan in collaboration with UNU-Kanazawa.

Decision IX/22: Global Taxonomy Initiative

- 63. In response to this decision, the Secretariat:
 - (a) Prepared for SBSTTA 14 including documents UNEP/CBD/SBSTTA/14/15 (Global Taxonomy Initiative: Results and Lessons Learned From Regional Taxonomic Needs Assessments and Identification of Priorities) and UNEP/CBD/SBSTTA/14/INF/36 on "Regional Reports on Taxonomic Needs Assessment and Project Development";
 - (b) Serviced SBSTTA14 on the agenda item 4.5 on " Global Taxonomy Initiative: results and lessons learned from regional taxonomic needs assessments and identification of priorities", which resulted in SBSTTA 14 recommendation on " Global Taxonomy Initiative: results and lessons learned from regional taxonomic needs assessments and identification of priorities";
 - (c) Organized the Global Taxonomy Initiative (GTI) Symposium: "Taking Stock of the Renaissance in Taxonomy: Post-2010 Capacity Building in taxonomy for the Convention on Biological Diversity", held at the World Agroforestry Centre, Nairobi, Kenya, from 15 to 16 May 2010;
 - (d) Organized the ninth meeting of GTI Coordination mechanism in Nairobi, Kenya on 16 May 2010, and prepared the meeting report;
 - (e) Produced a report on "Global Taxonomy Initiative Coordination Mechanism Discussion on Access and Benefit Sharing", to be submitted to the resumed ninth meeting of the *Ad hoc* Open-ended Working Group on Access and Benefit Sharing, 10-16 July 2010 in Montreal, Canada;
 - (f) Submitted an article on "Barcoding Life to Conserve Biological Diversity: Beyond the Taxonomic Imperative" to a peer-reviewed open access scientific journal, PLoS Biology and accepted on 1 June 2010; and
 - (g) Prepared COP10 document, including provision of input on global taxonomy initiative.

Decision IX/28: Promoting engagement of cities and local authorities

- 64. In response to this decision, the Secretariat:
 - (a) Serviced the Third meeting of the *Ad hoc* Open-ended Working Group on Review of Implementation of the Convention (WGRI 3), held in Nairobi, Kenya, from 24 to 28 May 2010; and
 - (b) In collaboration with UN-HABITAT, organized a side-event on cities, local authorities and biodiversity to discuss the CBD initiative on Cities and Biodiversity, decision IX/28 and the Plan of Action on Cities, Local Authorities and Biodiversity to be submitted to COP 10.

SOCIAL ECONOMIC AND LEGAL MATTERS

Decision IX/12: Access to Genetic Resources and Benefit-Sharing

65. During this period, the Secretariat prepared the resumed ninth meeting of the *Ad hoc* Open-ended Working Group on Access and Benefit-sharing, including the following:

- Preparation of documents
- Carrying out logistical arrangements for the meeting
- Organizing two days of regional consultations and open-ended consultations

66. The Secretariat participated in the Sixteenth Session of the WIPO/IGC on Intellectual Property, Genetic Resources and Folklore held in Geneva, from 3 to 7 May 2010 and presented a side-event on the negotiations of the International Regime on ABS.

67. The Secretariat finalised the preparations of the ABS Information Kit, including a brochure on ABS and factsheets addressing respectively access and benefit-sharing, uses of genetic resources, traditional knowledge, national implementation and the Bonn Guidelines. The Information Kit is to be made available in the six U.N. languages in hard copies as well as on the ABS webpages.

68. The Secretariat has carried out research on developments at national and regional levels and updated the database on ABS measures.

Decision IX/13: Article 8(j) and Related Provisions

69. In April 2010, the Secretariat participated in the 9th session of the UNPFII at UN Headquarters in New York. The Executive Secretary addressed the UNPFII in the opening plenary, along with the Secretary General and the USG DESA. A photographic and text exhibition on indigenous and local communities as proponents of biological and cultural diversity was opened by the Secretariat, in partnership with UNPFII, UNESCO and UNDP Equator Initiative, to run for 2 months. Two side events were also held on CEPA materials and indicators relevant to indigenous and local communities. On 25 April, the Secretariat, along with UNPFII and UNDP Equator Initiative, sponsored a special screening of the film "Avatar" for indigenous leaders, which included an interview with producer James Cameron by indigenous journalists.

70. In May 2010, the Secretariat participated in the UNDP Equator Initiative Board meeting and Technical Advisory Committee to assess more than 200 projects submitted by indigenous and local communities with a focus on climate change adaptation and the use of traditional knowledge.

71. In June 2010, the Secretariat facilitated, in partnership with UNESCO, the Canadian National Commission of UNESCO, University of Montreal and the Economic Forum of the Americas, the International Conference on Biological and Cultural Diversity - for Development. The event included a high level day held in partnership with the Economic Forum on 8 June, followed by two days of deliberations by more than 230 experts, which produced a draft decision for the consideration of COP 10 regarding the establishment of a joint programme of work between SCBD and UNESCO to fully explore a intersectionality between diversities and to promote diversity for development.

Decision IX/6: Incentive measures

72. In the period under the review, the Secretariat convened and serviced the fourteenth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice, held from 10 to 21 May. The meeting considered incentive measures as item 4.6. of its agenda and adopted recommendation XIV/15 for consideration by the Conference of the Parties at its tenth meeting.

73. As requested by SBSTTA-14, the Secretariat initiated further work on the information, including case studies and lessons learnt, on the removal or mitigation of perverse, and the promotion of positive, incentive measures, and continued preparation of other relevant documentation, for finalization in time for consideration by COP-10.

74. The Secretariat participated in a teleconference on 21 June of the Issue Management Group (IMG) on a Green Economy of the United Nations Environmental Management Group. The IMG seeks to assess how the United Nations system could more coherently support countries in making the transition to a "green economy" and to work on joint and consistent messaging on measures needed to support the transition.

Decision IX/14: Technology Transfer and Cooperation

75. In the period under the review, the Secretariat convened and serviced the third meeting of the Openended Working Group on Review of Implementation of the Convention, held from 24 to 28 May 2010. The meeting considered technology transfer and cooperation as item 7 of its agenda and adopted recommendation 3/11 for consideration by the Conference of the Parties at its tenth meeting.

OUTREACH AND MAJOR GROUPS

Children and Youth / Non-governmental organizations

A. Young Hands Together for Diversity

76. In partnership with the FAO and the World Association of Girl Guides and Girls Scouts (WAGGGS), the CBD Secretariat launched "Young Hands Together for Diversity" - a worldwide youth education initiative to provide children and young people with useful biodiversity information, and to help them participate in protecting, preserving and improving biodiversity in their communities. The initiative comprises of an International Art Contest, a Biodiversity Challenge Badge and a Youth Quick Guide to Biodiversity. Over 1500 children and youth from over 60 countries submitted entries for the Art Contest. The contest winners will be announced in August 2010. The Biodiversity Challenge Badge and the Youth Quick Guide to Biodiversity will be made available later this year.

B. IDB theme

77. To encourage youth participation in this year's International Day for Biological Diversity celebrations, the CBD Secretariat launched a children's booklet "Goodbye poverty, hello biodiversity" to raise awareness on the 2010 IDB theme.

C. The Green Wave

78. On the International Day for Biodiversity, children and youth in countries all around the world took part in a global wave of action: The Green Wave. This year the International Day brought attention to the importance of biodiversity to development and poverty alleviation. Children and youth were joined by dignitaries, teachers, parents, experts and supporters from government, companies, non-governmental organizations and other organizations. Thousands of students from more than 1,000 schools and groups who took part in 64 countries have uploaded pictures and stories of their activities to The Green Wave website. information website and More is available on the in the report: http://www.cbd.int/doc/press/2010/pr-2010-06-05-greenwave-en.pdf

D. Green Wave ambassador

79. On 20 May, the Executive Secretary of the CBD announced the appointment of the Canadian biologist, filmmaker and explorer, Mr. Jean Lemire, as Honorary Ambassador for *The Green Wave*. To read the press release, including congratulatory words from Mr. Jim Prentice, Canada's Environment Minister, and Ms. Line Beauchamp, Minister of Sustainable Development, Environment and Parks of Quebec, and to see a video of Mr Lemire, commenting on his nomination, please visit: http://greenwave.cbd.int/en/JLemire. On 21 May, Mr. Lemire joined the Mayor of Montreal, the Director of Museums Nature, the representatives of the Quebec Network of alternative public schools (REPAQ) and over 4,000 children and parents to plant a Green Wave tree and throw "balls of life" to flourish and color the path between the Montreal Insectarium and Biodôme.

Decision IX/26: Promoting Business Engagement

80. In May, the *Business.2010* Volume 5, Issue 2 on BioTrade was posted online and distributed at WGRI 3. The previously posted newsletter on the Jakarta conference was also distributed at the meeting.

81. A presentation was made for Canadian Business and Biodiversity Programme.

82. In April, a presentation was made at the Business for Environment Conference, 21-23 April 2010, Seoul, Korea.

83. The WGRI 3 held in Nairobi on 24-28 May recommended decisions on business engagement for COP 10.

84. In May, Pavan Sukhdev, TEEB Study Leader, made a presentation at the CBD office on the TEEB report for business and a presentation was also made at the McGill faculty house.

85. In June, a presentation was made at the International Conference on Sustainable Business Consumption (SusCon) in Germany.

Decisions IX/32 and IX/33: Programme of Work for Communication, Education and Public Awareness and Preparations for the International Year of Biodiversity

86. The Secretariat participated in the meeting of the Steering Committee of the Commission for Education and Communication (CEC) of IUCN, held in Aviemore, Scotland from 14 to 16 April. Discussions were held on the CEC's contribution to the work of the programme of work on CEPA

87. The Secretariat attended the Second International School Congress: Natural Resources, Sustainability and Humanity, organized by Lamaçaes School Cluster in partnership with Gualtar School

Cluster held in Braga, Portugal from 4 to 8 May 2010. The Secretariat made presentations to the over 250 attendees on the International Year of Biodiversity and was part of a panel discussion.

A. Global Biodiversity Outlook 3

88. The Global Biodiversity Outlook 3 was launched on 10 May 2010 at the offices of UNEP in Nairobi. Launches were also held at the United Nations University in Japan; and in Bonn, Geneva, Chamonix, New York, Copenhagen, London, Panama, Cairo, Manama, and Montreal. The launch generated considerable press coverage. A survey of news coverage conducted by UNEP found 197 news articles were published in major newspapers, websites or blogs of note in the week immediately following the launch. Of these, 50 were in English. 22 were in French, 50 were in Spanish, 12 were published in German, 37 were in Chinese, 14 in Arabic, 9 in Portuguese and 1 Norwegian piece. A video news release was also produced for the launch and distributed through the European Broadcast Union. The following organizations reported broadcasting the piece: APTN - Associated Press Television (UK), BBC - British Broadcasting Corporation (UK), FIA GT (UK), GUS YAYIN GRUBU A.S. (Turkey), Antenna-3 TV (Spain), Agence E.F.E. (Spain), Hrvatska Radiotelevizija TV (Croatia), Magyar Televizio (Hungary), Antenas y Sistemas (Panama), Radiotelevisao Portuguesa Ep (Portugal), Televiziunea Romana (Romania). The VNR was also used by CNN International, and Al Jazeera in their coverage of GBO3. An internet television interview on GBO-3 with Thomas Lovejoy was broadcast on 11 May 2010 and attracted 13,000 live viewers worldwide.

B. International Day for Biological Diversity (IDB)

89. On the eve of the International Day for Biological Diversity (IDB) Montreal's Nature Museums took the first symbolic action to launch the Life District, at a ceremony attended by Montreal Mayor Gérald Tremblay, Jean Lemire, honorary ambassador for <u>The Green Wave</u>, Valérie Desbiens, a teacher representing the Quebec network of alternative public schools (RÉPAQ) and Charles-Mathieu Brunelle, Executive Director of Montréal's Nature Museums. Some 4,200 young people and staff from RÉPAQ schools tossed thousands of "seed bombs" onto the path linking the Insectarium and Biodôme, to fill it with colorful flowers.

90. The Secretariat of the Convention on Biological Diversity celebrated IDB with over 800 participants from both the SBSTTA 14 and WGRI 3 delegations at the UNEP headquarters on 22 May. The celebration began with messages from the UN Secretary-General, read by Angela Cropper, Deputy Executive Director of UNEP; a representative of the Government of Kenya; Daniel Chuburu, Ambassador/Permanent Representative of Argentina to UNEP; Jochen Flasbarth, representative of the COP 9 Presidency; Masayoshi Mizuno, representative of the COP 10 Presidency; Spencer Thomas, Chair of SBSTTA 14; and Ahmed Djoghlaf, CBD Executive Secretary. Students also attended the celebrations and participated in a debate focusing on sustainable development, followed by their participation at the tree planting ceremony in honor of both the International Day and International Year. There was also a Green Wave celebration comprising youth and children from Nairobi.

91. The afternoon session comprised of a visit to the Huruma Forest organized in close collaboration with the CBD and GTZ. Participants were treated to a presentation on ecosystem services and had the opportunity to ask questions to the villagers living in the community.

C. World Environment Day

92. The Secretariat participated in the celebrations of the World Environment Day. The Executive Secretary participated in the global celebrations for World Environment Day in Rwanda as part of the 2010

International Year of Biodiversity. Through different events, presentations, and overall celebrations, Rwanda, with its exceptional array of biodiversity, reminded the world of what is possible by showcasing their country's huge strides on environmental protection. The Secretariat was also invited to participate in the North American celebrations of the World Environment Day, held in Pittsburgh, USA, and delivered remarks at the opening and participated in the ceremony for the North American branch of the Children's Painting Competition.

IMPLEMENTATION AND TECHNICAL SUPPORT

Decisions VIII/8 and IX/8: National Biodiversity Strategies and Actions Plans

93. By the end of June 2010, 170 (88% of the total) have finalized their national biodiversity strategies and action plans or equivalent instruments. In addition, 14 Parties have informed the Secretariat that they are preparing their national biodiversity strategy and action plan. Two Parties that have acceded to the Convention in the last two years, and seven others, have not prepared a national biodiversity strategy and action plan or initiated the process to do so, or have not informed the Secretariat that they have done so. At least 48 Parties have revised national biodiversity strategies and action plans, or are in the process of doing so.

94. The Secretariat is continuing work to compile case studies, tools and guidance arising from the fourth national reports and the sub-regional capacity-development workshops held in 2008 and 2009 on NBSAP implementation and biodiversity mainstreaming (www.cbd.int/case-studies/). The Secretariat is drawing upon this material to enhance and update the capacity development modules on national biodiversity strategies and action plans (www.cbd.int/nbsap/training/) in line with decision IX/8.

Decision VIII/14: National reporting

95. By the end of June 2010, a total of 134 fourth national reports had been received (118 final, 16 advance draft).

96. With the support of the Government of Japan and some partners, five regional workshops were held in April, May and June 2010, on the preparation of the fourth national report, with the aim to facilitate the submission of the fourth national reports by all Parties before the tenth meeting of the Conference of the Parties in October 2010. More details about these workshops can be found on the Fourth National Reports Portal on the Convention's website at https://www.cbd.int/nr4/.

97. To celebrate the 2010 International Year of Biodiversity and raise public awareness of biodiversity, country biodiversity briefs continue to be prepared on the basis of the fourth national report, for publication in some newspapers in Canada, Japan and some European countries.

98. An analysis of information contained in 95 fourth national reports (statistical analysis based on 85 reports) was prepared for the third meeting of the Working Group on Review of Implementation (24-28 May 2010, Nairobi, Kenya), as was a summary of the experiences and lessons learned from the fourth round of national reporting under the Convention. Also, to facilitate discussion about the post-2010 targets for the revised Strategic Plan of the Convention, 2010 and post-2010 national targets were compiled from the fourth national reports received and presented in an information document to WGRI 3. This document will also be presented to COP-10.

99. Draft guidelines for the fifth national report were also developed and presented to the third meeting of the Working Group on Review of Implementation for its consideration. Pursuant to Recommendation III/7 of the third meeting, a notification from the Executive Secretary was sent to all Parties requesting submission of further views on the draft guidelines by 30 June 2010, at which time only 2 Parties had provided comments.

100. WGRI-3 documents, including the final report of the meeting, are available at http://www.cbd.int/doc/?meeting=WGRI-03.

Decision IX/9: Process for the revision of the Strategic Plan of the Convention

101. The third meeting of the Working Group on the Review of the Implementation (WGRI-3) was held from 24 to 28 May 2010 at UNEP headquarters in Nairobi, back-to-back with the fourteenth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice. As decided at the ninth meeting of the Conference of the Parties in May 2008, the Working Group would prepare, for the consideration and adoption by the Conference of the Parties at its tenth meeting, a revised and updated Strategic Plan, including a revised biodiversity target, as well as a multi-year programme of work for the period 2011-2020. Accordingly, the Executive Secretary conveyed the invitation of the Conference of the Parties on these issues prior to WGRI-3. Inputs received were compiled in discussion notes posted at http://www.cbd.int/sp/sp2010p/inputs.shtml, together with the reports of various consultation meetings organized by the Secretariat, Parties and partner organizations between February 2009 and February 2010 (see http://www.cbd.int/sp/sp2010p/workshop-consult-reports.shtml). Official documents prepared for WGRI-3, as well as the final report of the meeting, are available at http://www.cbd.int/doc/?meeting=WGRI-03.

Decision IX/30: Scientific and Technical Cooperation and the Clearing-House Mechanism

102. During the second quarter of 2010, activities related to the Clearing-House Mechanism (CHM) can be summarized as follows:

- (a) Work started on the CHM pre-session document for COP 10. This consisted of two parts. The first one was a review of responses to CHM questionnaires in order to prepare the progress report to COP 10. The second one was an elaboration of the CHM vision expressed in the draft updated Strategic Plan of the Convention that resulted from the WGRI 3 meeting.
- (b) The CBD website and the IYB portal were maintained with a particular emphasis on translation into various United Nations languages. There was also a plan to launch a new template for the CBD website, but unfortunately technical issues prevented a successful deployment, and further work will be needed.
- (c) A CHM European meeting on biodiversity information systems in support of policy development was organized by the European Environment Agency. It took place on 16-17 June in Copenhagen, Denmark and was attended by around 20 participants, a majority of them being CHM NFPs in charge of their national CHM. Several European initiatives related to biodiversity information exchange were presented, and discussion topics included new features of the European CHM Portal Toolkit, terms to use in a proposed European CHM glossary, and the development of national CHMs.
- (d) The CBD Secretariat was represented in the First Steering Committee Meeting of the MEA Information and Knowledge Management Initiative organized by UNEP/DELC, and held in Glion, Switzerland on 22-24 June 2010. The main purpose of the meeting was to review the

progress made so far and determine the way ahead. The steering committee was constituted by MEA representatives as well as representatives from UNEP, UNEP-WCMC, EMG, IUCN, and ECOLEX. The steering committee was shown a demonstration of the interoperability proof-of-concept which consisted of a search engine prototype that could simultaneously search decisions from several MEAs. The meeting included some brainstorming discussions on the organization of the InforMEA web portal and its information services.

- (e) The CBD Secretariat was represented in the Steering Committee Meeting of the Tematea project on issue-based modules, co-organized by UNEP and IUCN, and held in Glion, Switzerland, on 25 June 2010. The objective of the meeting was to review the current status of the project, the proposed next steps, and some pending issues.
- (f) The CBD Secretariat responded positively to a request from CITES Secretariat to provide advice on how to improve its information services, and gradually establish a dynamic website. This collaboration took the form of a one-day visit to CITES Secretariat on 21 June 2010. From a CHM perspective, this was a fruitful exchange of experience because MEA Secretariats have similar challenges to address in terms of web infrastructure, design, and content management.

Decision IX/24: Gender Plan of Action

103. The Secretariat, in collaboration with the IUCN Office of Senior Global Gender Advisor, has developed CBD Technical Series No: 49 Guidelines for mainstreaming Gender into the National Biodiversity Strategies and Action Plans (www.cbd.int/ts). The document, available in English, French and Spanish, was presented to Parties in May during WGRI 3 in Nairobi. The response to the guidelines was very positive and similar orientation on the guidelines will be presented at COP 10.

Decision IX/11 (Review of implementation of Articles 20 and 21) and Decision IX/31 (Financial resources and the financial mechanism and guidance to the financial mechanism)

104. The Secretariat prepared a press release on the outcomes of the fifth replenishment of the Global Environment Facility Trust Fund.

105. The Secretariat attended the thirty-eighth meeting of the GEF Council and circulated to Parties a notification on its results.

106. The Secretariat provided inputs to the GEF document on relations with Convention for its thirtyeighth Council meeting.

107. The Secretariat attended the Executive GEFOP meeting on 5 May 2010.

108. The Secretariat served the negotiations of the third meeting of the *Ad hoc* Open-ended Working Group on Review of Implementation of the Convention, which led to the adoption of three recommendations on concrete activities to implement the resource mobilization strategy, guidance to the financial mechanism, and innovative financial mechanisms.

109. The Secretariat assisted with the organization of the Rio Conventions Ecosystems and Climate Change Pavilion.

110. The Secretariat organized an electronic consultation on the draft consolidated decision for the financial mechanism in June 2010.

111. The Secretariat received a submission from USAID on US Government international biodiversity funding trends.

112. The Secretariat served as a UNEP expert on new architecture for biodiversity finance, and answered questions worldwide on 22nd June.

113. The Secretariat organized a series of four Training and Information Events on Innovative Financing for WGRI-3 Participants, Nairobi, 24-27 May 2010, which include: Biodiversity Offsets; A Green Development Mechanism and International Innovative Financing; Payment for Ecosystem Services and Climate Change Funding; Economic Valuation of Land - supporting evidence-based decision making.

114. The Secretariat finalized two documents for COP-10: review of implementation of resource mobilization strategy and the financial mechanism, which went through informal peer reviews.

115. The Secretariat undertook consultation with the Global Mechanism of UNCCD and the Global Environment Facility on the proposed indicative guidelines for country-specific resource mobilization strategies

116. In collaboration with the League of Arabic States, the Secretariat is planning to organize a subregional workshop on innovative financing and resource mobilization for national biodiversity strategies and action plans for Arabic-speaking countries in December 2010.

BIOSAFETY

THE CARTAGENA PROTOCOL ON BIOSAFETY

III. IMPLEMENTATION OF THE DECISIONS OF THE CONFERENCE OF THE PARTIES SERVING AS THE MEETING OF THE PARTIES TO THE PROTOCOL

Decisions BS-II/2 and BS-IV/2: Operation and Activities of the Biosafety Clearing House (BCH)

117. In response to the request of Parties (paragraph 13 of Decision BS-III/2), the pages of the new version of the BCH Management Centre have been translated into the six languages of the United Nations. The Management Centre is accessible only to representatives of Parties and other Governments who are BCH account-holders to provide and manage information. During the reporting period, an offline version of the BCH was also made available on DVD-ROM to those who needed it in the six UN languages. The BCH databases also continued to expand with the increase in information registered in the capacity-building databases and the Biosafety Information Resource Centre.

Decision BS-IV/11: Risk Assessment and Risk Management

118. The second meeting of the *Ad hoc* Technical Expert Group (AHTEG) on Risk Assessment and Risk Management took place in Ljubljana, Slovenia from 20 to 23 April 2010. During the meeting, the AHTEG

finalized the development of "Guidance on Risk assessment of Living Modified Organisms", which includes a Roadmap for risk assessment as well as guidance on risk assessment of specific types of living modified organisms (LMOs) and traits (i.e. LMOs with stacked genes, LM crops with tolerance to abiotic stress and LM mosquitoes). The AHTEG also deliberated on possible modalities for cooperation in identifying LMOs or specific traits that may have adverse effects on the conservation and sustainable use of biological diversity, taking into account human health. The report of the meeting is made available as document UNEP/CBD/BS/AHTEG-RA&RM/2/5.

Decision BS-IV/12: Liability and Redress

119. The third meeting of the Group of the Friends of the Co-Chairs on Liability and Redress in the Context of the Cartagena Protocol on Biosafety took place from 15 to 19 June 2010, in Kuala Lumpur, Malaysia. The Group further negotiated the draft supplementary protocol on liability and redress to the Biosafety Protocol from the second meeting. A consolidated text on civil liability guidelines was prepared incorporating comments and suggestions made by Friends and observers into the draft guidelines initially prepared by the Co-Chairs. The Group has decided to hold a fourth meeting in Nagoya from 6 to 8 October 2010, prior to MOP 5 in Nagoya, Japan, with a view to address outstanding issues and finalize its tasks before it submits, the following week, its final report and recommendations to the fifth meeting of the Parties to the Protocol.

Decision BS-IV/17: Public Awareness, Education and Participation

120. The Secretariat advanced the implementation of the outreach strategy (2008-2012) to promote public awareness, education and participation. The activities undertaken in that regard include: (i) the launching of a re-designed website of the Cartagena Protocol on Biosafety (http://bch.cbd.int/protocol) on 28 June 2010. The new website has an improved layout and includes more user-friendly features and additional information, including fact sheets and resources for media and outreach; and (ii) presentation of an exhibition highlighting the International Year of Biodiversity, in collaboration with the Redpath Museum, on 30 May at McGill University, as part of the Montréal Museums Day. The event, which was attended by more than 4,300 visitors, contributed to raising awareness about the promotion of safe transboundary movement, handling and use of LMOs using the Cartagena Protocol on Biosafety as one of the tools. During the reporting period, the Secretariat also participated in the International Symposium on Genetic Biocontrol of Invasive Fish which was held in Minneapolis on 21 June 2010, and made a presentation on the requirements of the Protocol and the recent developments on risk assessment in the context of the Protocol.

Decision BS-IV/15: Assessment and Review

121. As recommended by the COP-MOP Bureau, an expert group meeting and an informal open-ended consultations were held on 19 May and 20 May 2010, respectively, in Nairobi, Kenya at the margins of the fourteenth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA-14), with a view to provide more opportunities for Parties and other interested groups to make further inputs to the draft strategic plan of the Cartagena Protocol covering the period 2011 -2020 that the Secretariat has prepared initially on the basis of written submissions.

Status of Ratification or Accession to the Protocol

122. As of 17 June 2010, 159 countries have ratified or acceded to the Protocol. The list of these Parties is available on the website at: http://www.cbd.int/biosafety/signinglist.shtml.

ANNEX II

Status of Implementation of the Agreed Administrative Arrangements

I <u>Personnel Arrangements</u>

1. During the reporting period, the Secretariat had 33 regularized Professional staff members and 26 regularized General Service staff members funded from the core budget. There were 4 Professional posts and 1 General Services vacant post for which recruitment/selection is in progress. Additionally, 6 professional posts and 11 General Service posts were funded from other sources. For more information, please refer to the attached staff list and organigram (Appendix 1 and Annex II respectively).

II <u>Contributions and Funds</u>

2. During the second quarter of 2010, six pledges of additional voluntary funds in support of approved activities under the Convention (**BE Trust Fund**) were recorded. Japan: US\$131,888 towards the secondment of a Programme Officer, US\$42,545 for the secondment of an Associate Programme Officer, US\$500,000 in support of the 4th National Reports and US\$358,632 for the ABS-9 Resumed Session; IEPF: CAD25,000 towards the activities of the year of Biodiversity and Norway: NOK100,000 in support of the Expert and Regional Meetings.

3. For 2010 a total of US\$2,224,100 has been pledged to the **BE Trust Fund**, of which US\$1,626,090 or 73% has been collected as at 30 June 2010. Full details of the pledges and contributions to the BE Trust Fund are reflected in Annex IV.

4. The total amount pledged for the **BY Trust Fund** in 2010 is US\$11,453,478. Of this amount, US\$8,554,379 or 75% has been received as at 30 June 2010. A total of US\$48,529 has also been collected in 2010 as advance payments for 2011 and future years. Additionally, US\$903,800 has been pledged and has been collected, as additional contributions to the BY Trust Fund for 2010. US\$685,261 has also been collected in 2010 for prior years. Full details of the pledges and contributions to the BY Trust Fund are reflected in Annex VI.

5. As at 30 June 2010, US\$1,082,782 has been pledged for 2010 as additional voluntary contributions to facilitate the Participation of Parties in the Convention process (**BZ Trust Fund**). Full details of the pledges and contributions to the BZ Trust Fund are reflected in Annex V.

6. As at 30 June 2010, contributions to the BZ Trust Fund in 2010 amounted to US\$500,292 or 46% of the total pledged for 2010. A total of US\$839,898 remains outstanding for the BZ Trust Fund for 2010 and prior years. Full details of the pledges and contributions to the BZ Trust Fund are reflected in Annex V.

7. As at 30 June 2010, a total of seventy eight (78) countries have paid US\$1,793,347 to the **BG Trust Fund**, representing 75% of pledges for 2010. A total of US\$204,748 has also been collected in 2010 as advance payments for 2011 and future years. US\$75,520 has also been collected in 2010 for prior years. Full details of the pledges and contributions to the BG Trust Fund are reflected in Annex VII.

8. As at 30 June 2010, three Parties have pledged and/or contributed to the Special Voluntary Trust Fund for Additional voluntary Contributions in Support of Approved Activities of the Cartagena Protocol

on Biosafety, (**BH Trust Fund**). To date US\$13,805 has been received in 2010 for 2010 and future years. Full details of the pledges and contributions to the BH Trust Fund are reflected in Annex VIII.

9. As at 30 June 2010, the Governments of Finland, Norway and Sweden have pledged a total of US\$121,408 to the Special Voluntary Trust Fund for Facilitating Participation of Developing Country Parties in the Cartagena Protocol on Biosafety, (**BI Trust Fund**). A total of US\$41,414 or 34% has so far been collected. Full details of the pledges and contributions to the BI Trust Fund are reflected in Annex IX.

10. As at 30 June 2010, the Government of Norway pledged a total of US\$33,501 (NOK 200,000) to the General Trust Fund for Voluntary Contributions to Facilitate the Participation of Indigenous and Local Communities in the Work of the Convention on Biological Diversity (**VB Trust Fund**) for participation in CBD meetings. Full details of the pledges and contributions to the VB Trust Fund are reflected in Annex X.

III Accounting and Reporting

Status of Expenditure

11. COP-9 approved a budget of US\$12,355,100 for the BY Trust Fund for 2010. As at 30 June 2010, a total of US\$7,035,593 was spent or committed. This represents 57% of the approved amount.

12. COP/MOP-4 approved a budget of US\$2,880,900 for the BG Trust Fund for 2010. As at 30 June 2010, a total of US\$1,211,784 has so far been spent or committed. This represents 42.1% of the approved amount.

Reimbursement for Services provided to the Secretariat

13. 



Organizational Chart of the CBD Secretariat






Biosafety Protocol
