In particular, paragraph 1 of decision IX/13 D and paragraph 7 of decision IX/13 E are concentrated on providing capacity-building initiatives to ensure effective participation of indigenous and local communities in the work of the Convention. of Guatemala played a key role in the adoption of these decisions, pursuant to which, we are pleased to begin the fourth workshop as part of the series of capacity-building workshops for indigenous and local communities in the Mesoamerican subregion.

The workshop aims specifically at strengthening the knowledge of representatives of indigenous and local communities, particularly women, and providing expertise on the Convention on Biological Diversity and thus achieving their full and effective participation in the process leading to the tenth meeting of the Conference of the Parties (COP 10) to be held in Nagoya, Japan, in October 2010.

We are now at a crucial point in the life of the Convention as it addresses two very important issues for indigenous peoples: 1) the negotiation of an international regime on access and benefit-sharing, and 2) the work plan of the Working Group on Article 8(j) and related provisions of the Convention.

Indigenous and local communities in the countries of Mesoamerica, whose territories harbour great biological, cultural, and linguistic wealth, contain important reservoirs of biological diversity. With their traditional knowledge, their ancestral wisdom, biodiversity has been preserved, maintained and even restored. Therefore, their participation in the meetings under the Convention is very important to contribute their knowledge and suggestions on how to take care of our Mother Nature- the biodiversity.

As always, the Secretariat of the CBD is ready to facilitate the participation of indigenous and local communities in the work of the Convention and we hope that after these days of learning together we will soon be able to count on your participation in the meetings under the Convention and that the AJAW will guide us in doing so.
