Further comments

A 1990 publication presents a complete list of adventive species in Israel with basic information on every species including geographical origin, first record from Israel, habitat, distribution and expansion, status as a weed, presence in the Middle East and world distribution. Species are divided into four groups according to their population dynamics in Israel: accidental species, species with limited distribution, colonizing species in human-impacted habitats, colonizing species of natural habitats.

No systematic study has been undertaken recently, largely as a result of lack of adequate funds. There is some information concerning the most problematic alien plant species – *Acacia saligna*. Mechanical and chemical methods have been used for eradication of this alien plant species, but these efforts have largely proved unsuccessful.

Although Israel has not submitted detailed case studies on the prevention of introduction, control and eradiation of alien species that threaten ecosystems, habitats or species (due to lack of available case studies), it has submitted a general survey of alien invasive plant species in Israel to the Secretariat of the Convention on Biological Diversity. The information was included in the material submitted to the sixth meeting of SBSTTA in Montreal (March 2001).
