Target 21. Ensure equitable and effective participation in decision-making related to biodiversity by indigenous peoples and local communities, and respect their rights over lands, territories and resources, as well as by women and girls, and youth.

#### Objective:

Reaching the 2050 Vision for Biodiversity will require a whole-of-society approach. It is important that the views, perspectives and experiences of all groups are taken into account in decision-making processes related to biodiversity. This will require equitable participation in decision-making processes, with a view to ensure that indigenous peoples and local communities, women and girls, and youth can effectively shape these decisions and that their rights are respected. Indigenous peoples and local communities, women and youth should be recognized and empowered in their crucial role as leaders and key actors in action towards biodiversity conservation and sustainable use.

## Further explanation of target elements

**Equitable and effective participation in decision-making** – Under article 21.1 of the UN Universal Declaration of Human Rights, "[e]veryone has the right to take part in the government of his country, directly or through freely chosen representatives."83

**Rights over lands, territories and resources** – Under article 26 of the UN Declaration on the Rights of Indigenous Peoples, "[i]ndigenous peoples have the right to the lands, territories and resources which they have traditionally owned, occupied or otherwise used or acquired"<sup>84</sup>.

#### Linkages

Objectives of the CBD – conservation of biological diversity, sustainable use of the components of biological diversity, and fair and equitable sharing of the benefits arising out of the utilization of genetic resources
