Developing the Global Biodiversity Framework monitoring framework









The path to develop the monitoring framework: recap

- In paragraph 16 of decision 14/34 on the preparatory process, COP requested SBSTTA-23 and SBSTTA-24 to contribute to the development of the post-2020 framework and in support of the work of the Open-ended Working Group on the Post-2020 Global Biodiversity Framework
- SBSTTA recommendation 23/1, paragraph 13 the Subsidiary Body requested the Executive Secretary to prepare a document identifying, among other things, options for a monitoring framework for the post-2020 global biodiversity framework, taking into account the outcomes of the second meeting of the OEWG, and to submit the document to SBSTTA-24 for its consideration



The path to develop the monitoring framework: recap (cont'd)

- Recommendation WG2020-2/1 in paragraph 3, the second meeting of the OEWG invited SBSTTA-24 to carry out a scientific and technical review of the updated goals and targets, and related indicators and baselines, of the draft global biodiversity framework, as well as the revised appendices to the framework, and to provide advice to the OEWG at its third meeting
- **Peer review,** Notification 2020-045 On 25 June 2020, the CBD Secretariat requested Parties and Observers to participate in a peer review of an initial draft monitoring framework. The peer review was initially opened from 25 June to 15 August 2020.









Monitoring framework at SBSTTA-24 Part I

- CBD/SBSTTA/24/3 Post-2020 global biodiversity framework: scientific and technical information to support the review of the updated goals and targets, and related indicators and baselines
- This document was discussed under agenda item 3 through:
 - An initial reading of the document
 - A contact group Chaired by Anne Teller (European Union) and Jorge Murillo (Colombia)
 - An in session survey on the monitoring framework
- At the conclusion of SBSTTA-24/3 Part I, a draft L document was agreed (CBD/SBSTTA/24/L.3). Additionally, a co-chair's text on the discussion and the results of the survey are online.



Key elements of SBSTTA report and CBD/SBSTTA/24/L.3

- The draft SBSTTA recommendation mentions, in paragraph 1, that a monitoring framework for the post-2020 global biodiversity framework would be annexed to the recommendation. However, this draft Annex is missing from the draft L document.
 - [Adopts the monitoring framework for the post-2020 global biodiversity framework annexed to the present decision¹]
 - Footnote 1: The annex will be developed in the light of further discussions, including negotiations in the third meeting of the Working Group on the Post-2020 Global Biodiversity Framework, and finalized by the Conference of the Parties at its fifteenth meeting.
- This Annex is included in the list of intersessional work arising from part I of the twenty-fourth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice, annexed to the report of the first part of the meeting (CBD/SBSTTA/24/11).





Post SBSTTA-24 Part I

- An revised monitoring framework was developed prior to the WG2020-3 Part I.
 Primarily to align with the 1st draft of the GBF, but also to take into account the results of the survey to the extent possible.
- The monitoring framework was not discussed during WG2020-3 Part I. However, some Parties noted the need for additional clarity and simplification.
- As per CBD/SBSTTA/24/L.3 footnote 1, the Annex for L.3 has been posted as a non-paper for SBSTTA-24 Part II.
 - This document is a revision of the CBD/SBSTTA/24/3 document which takes into account the results of the survey and an attempt to improve the clarity and simplicity of the document.
 - The discussion on the monitoring framework, contained in the non-paper, will continue at SBSTTA-24 Part II.
