"Harmony with Nature and Sustainable Development in the Alps"

Esteemed Executive Secretary,

Harmony with Nature and Sustainable Development in the Alps is a theme that resonates deeply with us at the Alpine Convention.

The Alps are more than just a mountain range. They are a vital ecological, cultural, and economic region that stretches across eight countries, home to nearly 15 million people, and visited by many more each year. But with climate change, mass tourism, and habitat loss threatening this fragile region, it is more urgent than ever to rethink our relationship with nature and ensure a more harmonious coexistence.

For over 30 years the Alpine Convention has worked to protect the Alps while promoting their sustainable development. As an international treaty and pioneer of its kind, the Convention strives to ensure that nature and development can work together. With eight Protocols covering areas such as transport, tourism, agriculture, and spatial planning, the Alpine Convention offers a guiding framework for a more sustainable future.

The Convention also promotes the participation of local communities, recognising that sustainable development must involve those who live and work in the Alpine region. It encourages dialogue, research, and innovation — turning sustainability from theory into action.

However, serious challenges remain. The Alps are warming at twice the global average. Glaciers are retreating, biodiversity is under threat, and traditional Alpine
